**Call to Order:**

A meeting of the Blanche Ely High School Advisory Council was held in room 250 (substitute Media Center during renovations) on August 21<sup>st</sup>. Co-Chair Djuna Robinson called the meeting to order at \_\_\_\_\_ 6:44. Steven Woloszn will record minutes for this meeting.

**Minutes:**

- Ms. Robinson welcomed the attendees, and informed the group that the School Board deleted last year's membership, so the list of members for this year will be updated. She then had attendees introduce themselves.
- Mr. Spence reviewed the concept of meeting norms. The group will follow Robert's Rules of Order. We're here to improve things for the school, and the betterment of the students. There will be monthly presentations from different departments. SAC is the approving agent of the School Improvement Plan. He also reminded members that there are monies available to support students/instruction.
- Betty Walker motioned to approve the agenda. Ms. Fulton seconded. There was a sign of Aye to approve.
- Ms. Walker also motioned to approve the minutes of the May meeting as printed. Mr. Blue seconded. There was a sign of Aye to approve.
- SMART update: Ms. Robinson reviewed components of the SMART bond. Mr. Spence will have a bottom line for the next meeting. The \$15,000 that was designated for the weight room was not taken out of the SMART monies. Instead that came from the Athletics budget. The jump drives for students were not approved. Ms. Kal Sander asked whether items had been approved before. They had been, but were disallowed by the county. Mr. King asked how the SMART process works. Mr. Spence reviewed. Ms. McCoy asked if there is a list of what was approved on the SMART ballot. Mr. Spence will provide a list at the next meeting.
- Nominations for positions: Ms. Robinson asked the group to review the state statutes regarding the composition and governance of SAC (by-laws and positions). Refer to Florida statute 1001.452.

- Mr. Spence recognized Mr. Will, who is working with magnet students for scholarships.
- He mentioned the different funds. Accountability funds are there, but others (i.e. Recognition) are not. He will have an update next meeting.
- Mr. Will asked about departments requesting funds. Any department can request funds.
