

| Mr. Lee welcomed the committee and guests. He then gave an update on the SIP. Mr. Lee reviewed how BSA data is used to predict performance on the upcoming FSA. He opened the floor for questions. Mr. Camacho asked what we were offering to help students prepare in addition to regular classes. Mr. Lee explained the extended learning opportunities offered – LEC Camp for our ELL students and Saturday School for grade 3/4/5 students that performed below proficiency as indicated on the BSA. Discussion of dates and times followed. There were no further questions. |
| Mr. Lee than gave an update on school safety. He reviewed the newer dismissal procedures that some parents ere questioning, specifically limiting access to campus during dismissal. He reviewed gate opening and closing procedures which are in line with district mandates.  |

She informed all that a <b>SAC Nominating Committee</b> would be looking for people and accepting names of people who would like to be on the 2019-2020 SAC Committee. She explained that we needed certain percentages of student/teacher and parent input. Also informed that a link would be coming in an email and available on the school and district websites. Mrs. Camuto then turned the floor over to Mrs. Beckette for a SAF update.  |

She indicated that much of the recent meetings focused on school safety and security in response to the MSD tragedy.
