## Stephen Foster Elementary School Advisory Council (SAC) Meeting Oct. 15, 2018

Call to order: The meeting was called to order by Mr. Allagood at 2:25 pm. Mr. Allagood reiterated that the job of SAC is to look at the schools data, support the school by getting involved and review upcoming events. The more we are involved, the more student achievement is enhanced. Mr. Allagood discussed BrainPop as a great resource for students. For fifth graders, there are 154 science lessons, also available in Spanish.
I. Approve minutes from Sept. 17, 2018 meeting: Minutes were approved by Ms. Futscher and seconded by Ms. Clingan-Venable.
II. Principal's Report: The principal's report was presented by the Assistant Principal, Mr. Martin. He discussed that we are getting ready to close first quarter, which ends officially on Thursday, October 18. Wednesday night is our ESOL Parent night in the cafeteria from 6-8:00 pm. We will have computers available to sign up for the $\$ 500$ grants for tutoring. We will try to fill out as many applications as possible.

## III. School Improvement Plan

We need a $62 \%$ to be an A school. We are currently at a " C " but showed improvement last year. Our school motto is "Strive for 65". Our school numbers for 2016-2018 are as follows: For 3rd grade FSA ELA 42\% (2016) to 40\% (2017) 37\% (2018).
For 3rd grade FSA Math Achievement decreased from 54\% (2016) to 48\% (2017) 53\% (2018). For 4th grade, FSA ELA Achievement 42\% (2016) to 38\% (2017) 37\% (2018). ELA Learning Gains $52 \%$ (2016) to 39\% (2017) 36\% (2018). ELA Low 25 Gains 36\% (2016) to 35\% (2017) 33\% (2018). For 4th grade, FSA Math Achievement 48\% (2016) to 49\% (2017) 45\% (2018). Math Learning Gains 49\% (2016) to 48\% (2017) 40\% (2018). Math Low 25 Gains 17\% (2016) to 35\% (2017)15\% (2018).

For 5th grade, FSA ELA Achievement 41\% (2016) to 46\% (2017) 47\% (2018). ELA Learning Gains 54\% (2016) to 61\% (2017) 66\% (2018). ELA Low 25 Gains 45\% (2016) to 55\% (2017) 48\% (2018). For 5th Grade, FSA Math Achievement 45\% (2016) to 52\% (2017) 55\% (2018). Math Learning Gains 55\% (2016) to 63\% (2017) 61\% (2018). Math Low 25 Gains 50\% (2016) to 41\% (2017) 42\% (2018). 5th Grade Science $43 \%$ (2016) to $40 \%$ (2017) 47\% (2018).

SAC By Laws reviewed and adopted.
IV. Title 1: Title 1 events were covered by Ms. Leider. Our ESOL Parent Night will be held Wednesday, October 17 from 6:00-8:00 pm. If a student received a 1 or 2 on the FSA in either $3^{\text {rd }}$ or $4^{\text {th }}$ grade or if they were retained in $3^{\text {rd }}$ grade (current $4^{\text {th }}$ and $5^{\text {th }}$ graders), the state of Florida is providing a $\$ 500$ grant for tutoring. At the ESOL night we are going to set up computers to help parents fill out the forms. We will be confirming how reimbursement will occur. You establish an account for your student, and once a quarter the money will be distributed. It is possible that
the money must be paid up front, but that will be confirmed. This is a great opportunity for our kids. The turnaround is quick for approval. The grants are on a first-come, first-served basis. On the sign-up website, there are also other scholarship opportunities available, such as speech and language therapy.

Our school is a Title 1 School. This classification is based on the number of students on "Free and Reduced" lunch. We are working on parental involvement. We just had our intermediate showcase - sponsored by Title 1.
