Every grade level Team Leader now has a radio.

Issues discussed include how an intruder looks. It doesn't necessarily have a "type" but someone like a student or someone with access to the campus.

Anyone has the right to call a Code Red.

FSA Camps are well underway for 3-5. Waiting for funds to begin Primary grades when we return from the Break with ELL funds.

Discussed gaps in learning and plan to take a deep look at data to figure out how the gaps are happening for students who are not ESE or ELL.

Challenges happen with transiency of the school population.
