Safety Update

We would like to make the following safety recommendations to be followed by students, parents, and or staff who are collecting money for parking at our school district sites:

- 1. Adult supervision is required during the entire time.
- 2. Do not stand in the street to collect money or direct traffic.
- 3. Post a sign at the entrance to the parking lot advising the Parking Fee and the amount.
- 4. The area where the students, parents, and or staff, are collecting the money needs to be far enough away from the entrance area into the parking lot, to allow vehicles to be able to get off the road before having to pay the parking fee.
- 5. Anyone who is collecting the money or directing vehicles on the school district site need to be wearing reflective safety vests, in order to be visible to the driver.
- 6. Anyone who is collecting the money or directing vehicles on the school district site need to have a working and reliable flashlight, in order to be visible to the driver.
- 7. The area where the collection of the money for parking is performed, should be marked with orange traffic cones with reflective markings, (minimum 27 inches in height) in order to form a traffic lane and provide an area where the students, parents, and or staff can stand behind.
- 8. Make sure that water is available to those working the parking detail.
- 9. If the parking event is held during the day that shade is provided, either by pop up type of tent or large umbrella.
- 10. Check with the School District's Police Department for the proper handling and storage of the money that is collected.

ORGANIZED SCHOOL GROUPS SHALL NOT SPONSOR OR ENGAGE IN ANY FORM OF GAMES OF CHANCE.

RULES

Student Solicitations and Fund-Raising

1. Door-to-Door

A. Elementary and Middle School

Door-to-door fund-raising by students shall be prohibited in activities sponsored by the school or by a school-related organization, in which students would be selling items or soliciting contributions, pledges or orders.

B. High School

The sale of commercial items on a door-to-door basis shall be limited to one (1) school-wide project per year. Any deviation from this must have prior approval from the Superintendent or his/her designee.

2. Student Clubs and Organizations

Student groups desiring to engage in fund-raising activities, make solicitations for advertising, or engage in other projects must have prior approval from the principal.

3. Instructional Time

These activities shall not be conducted during the students' scheduled instructional time. Requests for deviations from this rule shall be submitted to the appropriate Area Superintendent for approval.

4. "Panhandling" Activities

Students who are representing the Broward County school system in any manner shall be prohibited from participating in "panhandling" activities.
