#### CAT I -ESOL Endorsement

Completed application forms **must** be sent to the Certification Department at K.C. Wright Bldg, for processing. Do not send to Tallahassee.

#### CAT II, III

After completing your training requirements, you will be required to complete Broward County Public Schools Verification of ESOL Training Form. This form must be filled out and submitted at the workshop final session. This for will be issued to participants at the final session by your facilitator. The ESOL Training Department will submit these forms to the Certification Department once you receive your inservice points on your inservice records. You will be issued a Broward County ESOL Training Certificate. Processing time may take up to 8 weeks
