New Option for Florida Teachers with **Reading Endorsement:**

The 2007 Reverse Crosswalk (Reading to ESOL) awards teachers with the Reading Endorsement 120 points/hours towards the ESOL Endorsement. In addition, reading teachers would be required to take 2 additional courses and complete a practicum or demonstration of mastery in successfully teaching reading to an English language learner (ELL). It is important to note that only those reading teachers assigned to teach Intensive Reading or Developmental Language Arts to students classified as English language learners are required to obtain the FSOL Endorsement.

The following describes the Department's newest option:

Timelines

In accordance to the timelines for completion of the ESOL Endorsement as established by State Board of Education Rule, teachers have up to six years in which to complete the ESOL Endorsement. The chart below outlines the timeline for a teacher assigned to teach an ELL during the 2005-06 school year.

CERTIFICATION





K-12 ESOL CERTIFICATION (subject area coverage)

- Bachelor's degree or higher in teaching English for Speakers of Other Languages; and a passing score on the K-12 ESOL Subject Area Test.
- Teachers with a professional certificate: Passing score on the K-12 ESOL Subject Area test. Teachers electing this option are required to obtain an additional 120 points/hours in ESOL within three years of receipt of K-12 ESOL certification.

ESOL ENDORSEMENT

(300 hours/points or 15 semester hours in college credit)
Teachers with valid Florida teaching certificate: ESOL
Endorsement may be earned through either district inservice
points/hours, or college credit, or a combination of both. The
options for obtaining the ESOL Endorsement are described in
each district's Add-On Endorsement Plan. This plan is submitted
to the Florida Department of Education for approval every 5
years. Inservice points or college credit may be earned either
via traditional, face-to-face courses or via on-line courses.

The following describes the options that may be incorporated into an Add-on ESOL Endorsement Plan:

Options for ESOL Add-on Endorsement Using Inservice Points/Hours

Option 1:

300 inservice points/hours in the following five courses/areas: Applied Linguistics; Methods of Teaching ESOL; Testing & Evaluation of ESOL; ESOL Curriculum & Materials Development, and Cross-Cultural Communication & Understanding.

• Option 2:

300 inservice points/hours in FDOE developed model ESOL Add-on Endorsement Plan: Empowering ESOL Teachers and Teaching English and Cultural Harmony (TEACH).

• Option 3:

300 inservice points/hours in any courses/areas which lead to demonstration of mastery of the 25 ESOL Performance Standards and 75 ESOL Competencies.



Options for ESOL Add-on Endorsement Using College Coursework/Credit Hours

• Option 4:

Fifteen (15) semester hours of college credit in the following five courses/areas: Applied Linguistics; Methods of Teaching ESOL; Testing & Evaluation of ESOL; ESOL Curriculum & Materials Development; and Cross-Cultural Communication & Understanding.

Option 5:

Fifteen (15) semester hours in any courses/areas which lead to demonstration of mastery of the 25 ESOL Performance Standards and 75 ESOL Competencies.

Option 6:

Graduates from universities or colleges with approved programs who earn a degree in a specific field/area in education and at the same time complete the competencies necessary for ESOL Endorsement.



Options for ESOL Add-on Endorsement Using a Combination of Inservice Points/ Hours and College Coursework/Credit

Hours (Only available through a District's approved add-on ESOL Endorsement Plan)

• Option 7:

A combination of inservice points/hours and college credit in the following five courses/areas: Applied Linguistics; Methods of Teaching ESOL; Testing & Evaluation of ESOL; ESOL Curriculum & Materials Development; and Cross-Cultural Communication & Understanding.

Option 8:

A combination of inservice points/hours and college credit based on the FDOE developed model ESOL Addon Endorsement Plan: Empowering ESOL Teachers and Teaching English and Cultural Harmony (TEACH).

Option 9:

A combination of inservice points/hours and college credit in any courses/areas which lead to demonstration of mastery of the 25 ESOL Performance Standards and 75 ESOL Competencies.

Option 10:

Any combination of inservice points/hours and college credit which incorporates Options 1, 2, 4, 5, 7 or 8 $\underline{\text{and}}$ Options 3, or 5 or 9, as described above.
