The Adolescent Health Problems (R) course provides students with opportunities for investigation and self-assessment of selected adolescent health problems. This course should incorporate individual, small group, and large group study.

The content should include, but is not limited to, the following:

- Communication, interpersonal and coping skills
- Responsible decision-making
- Personal relationships
- · Family problems, such as separation and divorce
- · Death and dying
- · Risk-taking and self-defeating behaviors
- Positive emotional development, including the prevention of depression and suicide, violence, gangs, and bullying
- Personal hygiene and appearance
- Disease prevention and control, including HIV/AIDS and other STIs
- Human growth and development through adulthood including human sexuality, abstinence from sexual activity, and pregnancy prevention
- Parenting skills and care-giving, including child abuse and neglect
- Health-related community resources
- Tobacco, alcohol, and other drug use and abuse
