

ELEMENTARY PMRN

WHAT'S NEW FOR 2009-2010?

- 🍏 All K-12 Principals must register their schools in the State's Progress Monitoring and Reporting Network, or PMRN, Florida's Web-based data management system for the reporting of student gains in reading.
- 🍏 Registration is required for the PMRN Coach's Log. All Reading Coaches at all schools must log their coaching activities in the PMRN biweekly, using the PMRN Coach's Log.
- 🍏 All schools will use the FAIR to progress monitor kindergarten students during the three assessment periods in SY09-10. The online electronic scoring tool will upload student data directly to the PMRN.
- 🍏 Only Correct II, Intervene, and 2008-09 implementation pilot schools will use the FAIR as the progress-monitoring tool for all students in K-3 and all Level 1, 2, and 3 students in grades 4-5. The online electronic scoring tool will upload K-2 student data directly to the PMRN. The Web-based Assessment Module will be used to assess grades 3-5 students online and automatically upload student data into the PMRN.
- 🍏 All schools not designated as Intervene, Correct II, or 08-09 pilots will continue to progress monitor all FCAT Level 1 or 2 students and/or students scoring below the 40th percentile on SAT-10 in Virtual Counselor.

WHAT YOU NEED TO DO?

- 🍏 Register the school on the PMRN website at http://www.fcrr.org/pmrn/pmrn_v3_registration_sy0910.htm
 - Click on the link for SY0910 PMRN Registration. Click the link to Register.
 - If the school does not appear in the drop-down menu in Section 2 of the Registration Form, the principal must call or email the PMRN Help Desk at helpdesk@fcrr.org or (850) 644-0931.
 - Complete Sections 1, 2, 3, and 5. Complete Section 4A for Kindergarten. Select "Yes" for "Students Added by Surveys 2 & 3," and select "Vocabulary Required for All Students."
 - If there will be 3+ students enrolled in the school, complete Section 4B, selecting third grade and selecting "Third Grade includes 3+ only."
 - For Correct II and Intervene schools, select first through fifth grades in sections 4A and 4B. In first through fifth grades, select "Yes" for "Students Added by Surveys 2 & 3." Select "Vocabulary Required for All Students" for first and second grades.
 - Click Submit. An email confirmation will be sent to the principal.
 - On the first instructional day, log into the PMRN and identify the Reading Coach as the Coach's Log User and School Level 2 User (SL2).

WHAT WILL HAPPEN IF YOU DON'T?

- 🍏 Schools will not have students rostered for the FAIR, and will not be able to access the mandated assessments.
- 🍏 The Reading Coach will not be able to access the mandatory Coach's Log in the PMRN.
- 🍏 District and Area Office staff will review and monitor data in Virtual Counselor AND the PMRN. Schools not in compliance will be supported with an intervention plan.

- 🍏 All Elementary Principals, Area Offices, District Leadership, School Leadership Teams

HOW WILL YOU COMMUNICATE FOLLOW-UP?

- 🍏 All stakeholders will be informed through periodic updates.
- 🍏 Additional information will be shared with administration and reading coaches for distribution to staff.
