

FIVE STAR SCHOOL AWARD NOMINATION FORM 2017-2018

Accountability legislation and school improvement initiatives are built upon the active involvement of parents, guardians, business people and other community members, whose contributions significantly help to improve our schools. The legislative intent is to return the responsibility for education to those closest to the students—schools, teachers and families. The Five Star School Award was established to recognize that community involvement is fundamental to student success.

This symbol of achievement is presented each year to those schools that have shown evidence of exemplary community involvement. Eligible schools can apply for and receive the award annually, but a new application must be completed and reviewed each year regardless of the school's previous award status.

In order to qualify for this award, a school must meet 100 percent of the criteria in the categories of Business Partnerships, Family Involvement, Volunteers, Student Community Service and School Advisory Councils. The school must also create a portfolio of documents that provides evidence of compliance with each of the criterion in the nomination form. This portfolio must be sent with the nomination form to the District School Volunteer Coordinator.

Certificates for schools winning the 2017-18 Five Star School Award will be issued during the 2018-19 school year, pending release of school grades.

As stated in the attached document, our parent group, the HSA (Harbordale School Association) supports us tremendously. Each year they agree to pay the \$6,000 plus Accelerated Reader bill. It is a computer program that helps teachers manage and monitor children's independent reading practice. The student chooses a book at his/her own level and reads it at his own pace. When finished, they take a short quiz on the computer that offers points for level and quiz percentage. Harbordale has developed a goal program that consistently encourages independent reading that is tracked through AR. Due to mostly this program, our school is reading centered. As you walk through campus you will see kids reading and walking, reading at recess, reading at lunch, begging for more independent reading time, excited about books, authors, new releases, etc.

The HSA also provides monies for rewards such as NEW books, prizes, treats, and entertainment at celebrations. We are currently planning a party for 100 students who have over 100 AR points funded by the HSA. They also purchase our Sunshine State Young Reader books annually, sponsor author visits that promote reading and writing, and buy the technology needed to access the AR program.

The HSA is not just made up of Harbordale parents, but active community members and businesses that want to see our students succeed and achieve. Without them we wouldn't be the high achieving school we ar

H. Community Involvement Best Practice

The examples of school programs and community partnerships below all positively impact student attendance, behavior, and achievement.

Harbordale works closely with many community organizations regularly to enhance the school day and year. Some examples are the local Kiwanis Club sponsoring our monthly Terrific Kid program that highlights students with exemplary attendance, behavior, and academics, as well as providing summer reading materials for our kindergarten students.

The Fort Lauderdale Garden Club partners annually with our fifth grade classes to study botany. The students are escorted to Birch State Park to learn about local flora and fauna, and then the members make several visits to our campus to teach and discuss other aspects of their craft that culminates with a plant and flower show of student work. It includes plants grown by the students with their assistance, plant journals, and posters. Top scorers are invited to a sleep away camp for two weeks during the summer to continue their education in this area free of cost to the students.

Our local Fort Lauderdale Barnes and Noble is our partner in education as well. Mr. Robert Horton, community manager, attends all SAC meetings, brings information on store events, promotions, and giveaways, as well as coordinating a Family Night at the store each fall. Families have the opportunity to participate in a variety of literacy activities and support our school with books. It is a favorite each year.

Some other community members that assist our school are Franklin Templeton Investments that visit us each year to bring books for all our kindergarten students, reads them aloud, and conducts an activity too. The Fort Lauderdale Rotary Club visits each December to present our third grade students with a dictionary as a holiday gift. They are also presented a lesson on dictionary skills. Fourth and fifth graders can earn a scholarship to the local Yacht Club's sailing camp through an essay contest. A favorite amongst the students. We love our community. We often have Burger Fi, PDQ, Outback

Steakhouse and Smoothie King bring by treats and certificates for students as well.

Last, but not least, Harbordale would NOT be the same without our HSA (Harbordale School Association). They are the heart and soul of our school. The association is made up of parents, grandparents, and volunteers. Their only purpose is to support our staff and students. They supplement our budget to enhance curriculum, beautify the campus, and support teachers in the classroom. Because of their fundraising efforts, we have iPads for kindergarten through second grade students, a primary and intermediate playground (yes, all our playground equipment was privately funded totaling \$100,000), grants funded for classroom projects and supplies, a stocked literacy resource area, in-house and off-campus field trips, and much more!

The summer of 2017, the HSA took on one of their biggest projects yet. The media center makeover. A group of HSA volunteers and community members at large completely remodeled our media center. From painting, to shelves, new furniture, decorations, and more the transformation is amazing. The space was very outdated and uninviting. It is now bright and vibrant. Along with the money donated from the HSA each year for new books, the new décor has increased interest in the media center, therefore increasing checkout, which in turn increased reading, which will hopefully result in increased student achievement and interest in school/reading.

Each one of our community partnered programs improves academic work and student achievement by providing real-life experiences, exposure to new things like technology and hands-on labs, and offering incentives to those students that are exceling in the classroom. Examples are the purchase of Accelerated Reader each year, and the many rewards for reaching reading goals, receiving public recognition, a certificate, pencil, bumper sticker, and badge when chosen as a Terrific Kid. Students are required to show good behavior and regular attendance in order to participate in all the abovementioned programs. Rewards are earned, not given at Harbordale. We offer a wide-range community programs, for those students who do the work of a student. This directly correlates to a track record of low behavior infractions and truancy rates.

In conclusion, Harbordale is a Five Star School because without our community, we would not be a success.
