VI. Department Updates

- a) Social Studies: 6th grade world history began the chapter on Greece. This chapter focuses on a lot of government therefore we are doing our best to incorporate world history, civics and ELA. 7th grade just took their final CFA this week on laws, the court system, international organizations, foreign and domestic policies. After break civics teachers will be reviewing and getting students ready to take their EOC. 8th grade is studying the Age of Reform before the Civil War. This includes abolitionism, transportation revolution, urban revolution, and the different groups living in American at the time. 8th grade social studies teachers are enforcing ELA standards in the social studies room as we approach the FSA.
- b) Science: We are getting ready to take the last CFA before going on Spring Break
- c) Math: iReady for Math and Ready. Students always have homework. If they do not, it important they are completing lessons on iReady. Students should be completing at least two lessons a week. iReady helps them fill in the gaps. For math, tenmarks, algebra nation and math nation. FSA testing is May 7th and 8th. The week we get back from Spring Break we will start crunch-time. This will give us an opportunity to reteach and review the standards.
