Kyle Machado made a motion to approve the P.R.I.D.E Remediation. Mr. Michel Gerard second the motion, which was carried by all.

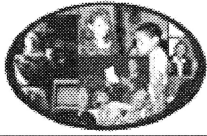

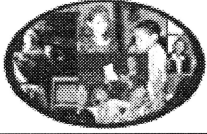
