SAC By Laws Proposal/Approval 2018/2019

SAC By-laws are a set of rules and procedures used to determine how our meetings will be facilitated. They define the relationships, duties and responsibilities of the members of the School Advisory Council. Primary Objectives: Help to identify the need and recommend programs of action through community wide commitment, foster a positive learning environment which sets high expectations and meets the diversity of the students. The SAC should be a resource to the school and the principal.

Function of SAC

- ❖ Facilitate the development of the School Improvement Plan (SIP)
- ❖ Monitor progress and implementation of the SIP
- Make modifications as needed
- Evaluate effectiveness
- Provide assistance in preparation of the school's annual budget
- * Recommend alignment of instructional staffing and instructional materials
- Primary objective is to help identify needs, recommend programs of action through a community wide commitment
- ❖ The majority of the SAC team should not be employed by Broward County School Board

- SAC officers are elected by their peers for one term. Officers should be elected annually at the September meeting and installed at the first meeting
- ❖ All meetings are open to the public by Florida Sunshine law.
- ❖ Attendance records will be kept. Minutes will be recorded and voted upon at the next meeting

<u>School Improvement Plan Update</u>

2017-2018 SIP Closeout completed

The following PLC Smart Goals were established for the 2017/2018 school year:

Increase student attendance by 4% from 65.3% to 69%

Increase the percentage of half credits issued from 24% to 27%

Decrease student behavior by 10% (67-60 incidents).

Increase the percentage of students completing their graduation requirements from 22% to 30%.

<u>Data Results:</u> Student attendance decreased by a slight percentage, a reduction in student discipline in the area of disobedience and insubordination which means student referrals decreased, our graduation rate increased by 16%, and the STEM department gave out 298 half credits and the Literacy department awarded 129 half credits and 44 students that met the Algebra One EOC testing requirements by taking the PERT assessment and getting 97% or higher.
