## **School Advisory Council Minutes**

## Stirling Elementary School

## September 17, 2018

- I. Roll Call
  - a. The meeting was called to order at 2:29 PM by Mr. Fletcher, SAC Member.
- II. Approval of Minutes from May 2018 meeting.
  - a. A motion to approve the minutes was initiated by Mr. Fletcher and Mrs. Frasier seconded the motion.
- III. SAC/SAF Membership Voting
  - a. Mrs. Louis nominated Ms. Valliere as the SAC chair for the 2018-2019 school year. The SAC body unanimously voted for Ms. Valliere as the SAC chair.
  - b. SAC Chair, Ms. Valliere, initiated the voting of the present business partners, parents, and teachers in the SAC body.
- IV. Ms. Valliere, SAC Chair, presented and reviewed the SAC Bylaws to the SAC Body via projector.
  - a. The SAC body voted unanimously to approve the SAC Bylaws.
- V. Ms. Valliere, SAC Chair, presented the purpose and responsibilities of SAC to the SAC Body via projector.
- VI. Mrs. Arnaez, school principal, presented information about the ASSIST Self-Assessment for 2018-19 as to how it is constructed and by whom. It will be presented at the meeting in October.
  - a. Mrs. Arnaez shared how teachers complete self-assessments in order to develop teaching skills and continue improvement.
- VII. Mrs. Arnaez, school principal, detailed the use of the accountability funds and where the funds come from.
  - a. The funds will be voted upon in an upcoming meeting.
- VIII. Mrs. Arnaez, school principal, stated we will close out the SIP plan for the 2017-18 school year, as we looked at it via projector.
  - a. Mrs. Arnaez detailed the process to constructing the SIP Plan for the 2018-2019 school year.
  - b. Parent, business partner, and teacher input was requested while the template was projected via projector for all to view.
  - c. The SAC Body stated they accepted the current plan for the 2018-2019 school year.
- IX. Meeting Dates for 2018-2019 school year were shared.

- X. Mrs. Arnaez, school principal, opened the floor for school related announcements.
  - a. Mrs. Louis presented the calendar for the 2019-2020 school starting date for voting.
