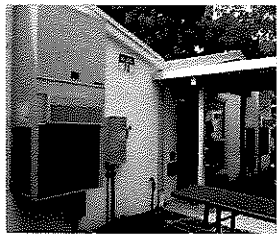

3 Project is complete once all items or enhancements are delivered and installed.  **Improvements Complete**






