Call to Order:

A meeting of Pembroke Pines Elementary School Advisory Council was held in the Media Center on 01/28/19. Co-Chair Dr. Clarke called the meeting to order at 2:20pm. Ms. Uribasterra will record minutes for this meeting.

3. SAC Chair report
 - a. Florida School Recognition Program – A+ FUNDS Update – All funds were approved and they were processed.
 - b. Mid-Year Benchmarks and Reflection – Three data points and we use the BAS scores for our projections. We predicted 62% of students to make a 3 or higher in the reading FSA, and we are close to 50%. There is a gap in our learning. We are offering Camp Pirate after school and offering the pull-out to reach the goal.
4. Title 1 – Ms. Donate
 - a. Title 1 Annual Survey Update – The percentage of parents that answered the survey was shared with the group. The results of the survey by specific questions was also shared at this meeting. The results showed that parents agreed and highly agreed that they feel part of the school and they are informed about school progress. The results also showed that parents feel that they need more information about scores and how to track their child's progress. Also, parents felt that they need more information about the FSA and standard/school-based assessments. We sent 200 paper survey and parent links. Only 37 parents responded to the survey. All present were informed that the 2018-19 Annual Evaluation results have been uploaded to the School's website and were given the instructions on how to locate the survey results that were shared at today's meeting.

We shared that as a result of the survey, we will ask teachers to share the exact results of standardized and school-based assessments with all parents either via phone or in-person conferences as soon as possible. We also shared that the Administrators, Curriculum Coach and Team Leaders are working closely on the results to bring in appropriate training for staff and parents that will address student skills deficits.

The training will be added to the 2019-2020 Parent and Family Engagement Plan. Discussion was held about the results and those present gave ideas on activities that could be added to the plan. The Parent Compact is good and will not be revised for next year.

5. Administrative – Ms. Bell/ Ms. Rodriguez
 - a. Curriculum/Instruction – K-2 teachers are in the process of BAS to adjust the student's learning.
 - b. BSA & BAS Overview – I-Ready is set up to put the students in path that will address their weaknesses. Our current predictions are 49.4% Reading, 43.1% Math, and 25.4% Science are out prediction of level 3 or higher. The teachers will group the students according to their weakness.
 - c. Pirate Camp – It has started, and they were group according to the students subgroups not making progress. Those students were invited first, then we open to other students whom are not making progress.
 - d. Bingo Night – It was a great night.
 - e. Camera Update – We are going to be adding a few more cameras. A team will be coming to see where the school will install new cameras.
 - f. February 14 Plan – Commemoration for MSD of service and love. The county has provided a list of items to do to commemorate this day. Our psychologist will be here that day for our student per Ms. Bell request. In additional, we will have 2 guidance counselors, 2 social workers and possibly have therapy dog(s). The district has requested no workshops and training for that day.
