Call to Order:

A meeting of <u>Pembroke Pines Elementary</u> School Advisory Council was held in the <u>Media Center</u> on <u>04/15/19</u>. Co-Chair <u>Dr. Clarke</u> called the meeting to order at <u>5:32pm</u>. <u>Dr. Clarke</u> recorded minutes for this meeting in Ms. Uribasterra's absence.

Minutes:

<u>Dr. Soufrine</u> motions to approve the minutes of <u>03/18/19</u>, with no corrections. Seconded by Ms. Rojas. Motion outcome: Motion carried unanimously.

 - a. 2019 Stakeholder Survey AdvancED eProve Surveys

The Stakeholder Survey window has been extended to the end of May. At the time of this meeting, the mid point results had indicated that we met District projections for number of surveys completed for both student surveys and staff surveys. As of 03/15/2019, for student surveys, we required 113 surveys, and had 202 completed. For staff surveys, there were 44 required and 44 completed. Of the 57 required parent surveys, 53 had been completed. Ms. Bell was able to update this information. We have met the parent survey requirement with 61 surveys already completed. Ms. Rojas commented that some of the questions were problematic because it was unclear how activities at Pembroke Pines Elementary aligned to the question(s). Members present unanimously agreed that surveys should be discussed with parents at events so that they understand how activities support the school vision and District guidelines.

4. Title 1 - Ms. Donate

a. Finalize and Adopt 2019-2020 School-level Parent and Family Engagement Plan In Ms. Donate's absence, Dr. Clarke reviewed the material and explained key areas of the 2019-2020 School-level Parent and Family Engagement Plan. Sections were revised based on the discussion with stakeholders present. All present agreed unanimously to adopt the document once the changes/revisions noted on the live document were made.

- b. The 2019-2020 School wide Positive Behavior Plan was briefly discussed. The plan will be presented to faculty and staff for further modifications based on their recommendations. After changes have been made, the plan will be voted for adoption.
- c. Development and Review of 2019-2020 School Parent Compact.
 The members present reviewed the 2018-2019 School Parent Compact, and used it to develop the 2019-2020 School Parent Compact. No revisions were made, and the compact was adopted with unanimous support.

d. Title I Parent Activities

The Title I Parental Activities Budget was discussed. Money to be allocated towards Parent trainings and Family Nights. An account will be created at Publix for the purchase of refreshments for these parent and family events.

5. Administrative - Ms. Bell/ Ms. Rodriguez

a. SMART Bond Update

Purchase order has been issued for the Playground component. Adjustments with engineering are being finalized. It is anticipated that work will commence during the summer. The Roof work is slated to begin in the summer. A Pre-bidding Conference is scheduled for April 23 on our campus. The Media Center remodel is also due to begin during the summer. It is hoped that all will be finalized at the beginning of summer so that the bulk of the work can be completed before students return in August.

b. Curriculum/Instruction

Students are currently immersed in FSA preparation, while steadily addressing standards mastery. There was excellent attendance during the FSA 3rd Grade ELA, as well as 4th and 5th Grade Writing assessments with less than 5 make-ups, and 100% participation. We are also preparing students for End of Year alternative promotion criteria assessments, Primary End of Year Assessments, and final sections of the FSA in the remaining content areas.
