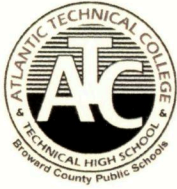

A joint meeting of the Atlantic Technical College & Technical High School Advisory Council and School Advisory Forum was held in Room 122 of Atlantic Technical College on April 23, 2019. Chair Jay Ghanem called the meeting to order at 8:12 AM. Hallema Collier will record minutes for this meeting.

### Minutes:

Mari Lee motions to approve the minutes of January 29, 2019, with no corrections. Erica Fagan seconded. Motion was unanimously approved.

1. Recognition of ATC's Student Government Association
  - a. Mr. Crawford introduced the SGA members present and sponsor, Kathy Kelly. ATC's SGA was the only high school in Broward County to be recognized at the State Convention winning 5 first places out of 10 categories.
2. SAF Update
  - a. Erica Fagan shared there were no new updates.
3. Student Comments
  - a. AJ Futo, high school student, shared education events (Aquatic Ecosystem, Amendments, Senior Exhibition), community service (Above the Influence, Coconut Creek Teen Political Forum) and school spirit activities (SGA Awards, ATC Hosted the BCASC Meeting, Spring Dance).
  - b. Jaanai Scott elaborated on ATC's participation in the inaugural Teen Political Forum at Monarch High School. Mayor Welch gave kudos to our student representatives.
  - c. Jessica English, Pre-College, discussed project-based learning activity, *Money Matters*, scholarships to CTE programs, and a panel discussion with alumni.
4. Assistant Directors' Updates
  - a. John Felser reported on ATC's success at Florida's Skills USA State Competition, two students traveled to New York to compete in the Greater New York Auto Dealers Association Competition, and our Career Placement program has been out making community/business visits.
  - b. Tonya Hefley reported on ATC's success at HOSA (Health Occupations Student Association) and the 211 Seminar. In Business & IT, ATC's JA team made it to finals, NAF AOIT has earned Distinguished again, BPA was heading to California for the national competition. Academic Studies is focusing on college and career. ESOL completed the Book Spine Poetry project.
  - c. Vicky LaPorte reported 100% of ATC juniors have met their FSA-ELA graduation requirement and 100% attended on SAT day. Seniors out did themselves at the annual Senior Exhibition in March. Over 23 boxes of school supplies and baby products were collected as part of the District-wide Day of Service. Students are using virtual reality headsets in Ms. Lederer's class. A new safety group has started, Prevention Cadets. ATC High School has been nominated to apply for the prestigious Blue Ribbon award.
  - d. Andre Newton (Arthur Ashe, Jr campus) reported on PN graduates Pinning Ceremony, 2019 Health & Wellness Fair will be 7/13, provided an update on the Bond construction projects, and have 30 graduates from the Land that Job initiative.

**Topic: HS & Adult Students Compete at SkillsUSA States Conf. in Pensacola**  
**Highlights**

- Twenty-two ATC Adult and HS students attended the SkillsUSA State Competition, competing in 18 events.
- Of the 22 students competing, 16 were awarded a Gold, Silver or Bronze medal.
- Six HS Students won Gold competing in four separate contests.
- These HS students will travel to Louisville, KY on June 24th-28th to compete in their event at SkillsUSA Nationals!

**Topic: Two Auto Students Attend National GNYADA Competition**  
**Highlights**

- Two of ATC's HS Automotive seniors, who won their Regional Automotive Competition, are currently at the National Automotive Technology Competition in NY City, starting today through Thursday.
- This is the most prestigious of all auto contests held specifically for high school automotive service students, offering up to \$100K in scholarships, equipment and tools to the winning team.
- All travel and lodging costs for the 2 students and their teacher to attend this annual competition are being paid for by the South Florida Auto Dealers Association (SFADA).

**Topic: Career Placement Students Visit Two Local Businesses**  
**Highlights**

- The City of Coconut Creek, through the direction of Vice-Mayor Sandra Welch, created a promotional video, highlighting specific businesses who are currently employing Career Placement students. The video will be shown at ATC's Career Placement Advisory on Tuesday, April 30<sup>th</sup>.
- On March 8<sup>th</sup>, eight young women participated in a self-defense class provided by the Coconut Creek Police for students in ACCESS and Career Placement. They will be offering a class for the young men within these programs in the near future.
- As a follow-up to the self-defense class, on April 11<sup>th</sup>, 18 Career Placement students were given a tour of the Coconut Creek Police Department, viewing a K-9 demonstration, as well as learning about the crime scene investigation process.
- On April 3<sup>rd</sup>, 14 Career Placement students were given a tour of Republic Services' main plant and recycling facilities. Transportation was provided for these students through the Center for Independent Living of Broward.

#### Topic: Health Department Highlights

- The Health Occupations Students of America (HOSA) organization held their State Competition in Orlando over Spring Break (March 28 – 31). Six (6) students from ATC Health Science programs have now qualified for Nationals and placed in the following categories:
  - Clinical Nursing – 1st and 2nd place
  - Medical Assisting – 1st place
  - Dental Science – 1st place
  - Pharmacy Science – 2nd place
  - Home Health Aide – 5th place
- The National Competition will take place in Orlando in June.
- The Mental Health Technician program instructor, Ms. Jean Dougherty hosted a Broward “2-1-1” seminar on February 19, 2019. Ms. Jessica Abou, a Community Relations Specialist, facilitated an informational presentation to several of our health science classes and guidance counselors about all of the services available from 2-1-1 Broward. This organization provides 24-hour comprehensive helpline and support services for individuals in our community seeking crisis intervention assistance and/or information and referrals to health and human services in Broward County. Students or individuals need only to dial 2-1-1 to access these services.
- On March 12, 2019, high school seniors from 8 Health Science programs participated in the Senior Career Fair and Expo held in the patio area of ATC. The students, who completed a technical program while enrolled in high school, did an excellent job of showcasing their individual programs to a large group of undergraduate students, visitors and staff.

#### Topic: Business Management & Administration and Information Technology Department Highlights

- **JUNIOR ACHIEVEMENT:** Saturday, April 13, 2019, the student members of Pets Emergency Travel Solutions attended the Spark Tank Finale at JA World at Broward College campus. They participated in several events, Trade Booth display, company presentation, Annual Report and Commercial. The students had a great time promoting their product and learning about the entrepreneurial process. Next is the liquidation of the company and the Annual Meeting where students will receive profit sharing for their hard work.



- **BPA:** Students are gearing up to attend the National Leadership Conference in Anaheim, CA on May 1-5, 2019. There are 29 students attending and competing in various events such as Payroll Accounting, Network Design, Administrative Support, and Microsoft Applications. BPA members are also collecting gently used sneakers for the Broward County Shoe Drive that will take place this summer to help provide shoes for children in need. BPA continues to fund raise with an upcoming car wash on April 27th at the Mobil Gas Station on State Road 7 in North Lauderdale and Krispy Kreme donut sales on Wednesday, April 17.
- **NAF:** Our ATC NAF Academy of Information Technology interns are ready to work. The professional training our students receive here at ATC makes them exceptionally prepared to use their skills in the workplace. Over 17 of our 50 NAF AoIT rising seniors have already secured summer internship positions across Broward County at companies like Emerson Electric, McDonalds, Publix, Broward School's Information and Technology Department and even here at ATC's IT Department. And that's not all, we continue to send resumes to other interested partners for those students still searching for an opportunity. One to mention is our very own Mayor, Sandra Welch, at the City of Coconut Creek. This is an exciting time and great experience for both our students and our community businesses.

**Topic: Pre-College Academic Studies and ESOL Department Highlights**

**Academic Studies:**

- Academic Studies schedule has changed to accommodate 4 subjects (rather than 3). We will pilot two tracks: 1) Career Track where we will focus on: 21<sup>st</sup> Century Employability Skills including collaborative problem solving, strong communication, and technology skills. Students prepare for CCR aligned assessments. and 2) College & Life Ready Track that will focus on: 21<sup>st</sup> Century Employability Skills including collaborative problem solving, strong communication, and technology skills. Positive psychology curriculum integrated into subjects to improve self-awareness and wellness. Students build ability to manage stressors of life and to improve sense of fulfillment, self-efficacy, and purpose.
- We are gearing up for graduation ceremony with over 100 graduates and counting!
- Academic Studies will be working with Pre-College ESOL next month -weaving Mental Wellness activities and projects into our curriculum.

**ESOL:**

- The Advanced ESOL level class had a wonderful field trip to the Broward College Library. Students signed-up for library cards and purchased a lot of books. Advanced level students also participated in ATC Senior Career Fair and Expo where they spent hours touring, asking questions and learning about CTE training opportunities.
- In the Bridge ELCATE class, they worked in the Learning Commons on a project called "Book Spine Poetry". The students arrange book titles to create poems!

- 100% of juniors participated in SAT school days with some improvement over their PSAT scores--more work still to be done

**Topic: Activities**

**Highlights**

- **Senior Exhibition**
  - All seniors had the opportunity to showcase their technical program at this annual event. This was particularly helpful for the sophomores who were in the final phase of selecting their technical program
- **Day of Service Collection**
  - Students and staff from throughout ATC collected school supplies and baby products which were donated to Food for the Poor as part of the district-wide Day of Service and Love. Over 23 packing boxes, as well as cases of diapers and wipes were donated.
- **Virtual Reality Headsets**
  - In our Advanced Placement Human Geography class, Ms. Lederer utilized VR headsets and the *New York Times* VR app to follow three different children in South Sudan, Lebanon, and Ukraine. This technology allowed the students to follow the children's stories, feeling like they were there. The students said this activity helped them better understand the impacts of war and persecution.
- **Prevention Cadets/Safety Patrol**
  - This new ATC group will be the conduit between students, security staff including SROs, and administration. Fourth period classroom representatives will meet monthly for information and discussion, which will be shared with their classmates.

### **Topic: Teacher & Student Successes**

- **Student Government Association Awards**

- Our SGA attended the Florida Association of Student Council's State Convention, March 1-3<sup>rd</sup>. Over 100 schools were in attendance from all over the state. In addition to attending leadership workshops and participating in team-building activities, the ATC students submitted project books for judging. Out of the ten award categories, the ATC SGA won first place in five categories; State Project, Membership Motivation, School Service, Citizenship Development, and Fund Raising. In addition, they were awarded a silver medal for the overall Medallion Book. As the only school in Broward County to take home first place project awards, all the students, as well as Ms. Kathleen Kelly, the SGA Sponsor should be very proud of their accomplishment!

- **Putting Classroom Learning to Work**

- While on the plane heading to Philadelphia on the Spirit of America Youth Leadership Program, junior Charles McNeill used what he has already learned as a Patient Care Technician student to assist with an on-board medical emergency. He acted with such professionalism that the flight attendants found it very hard to believe he was still in high school.
- ATC has been nominated as a National Blue Ribbon School. There are only 13 schools in Florida that have received this honor and we are diligently working on the application at this time.

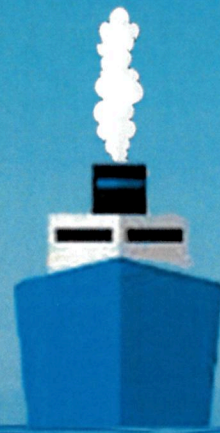

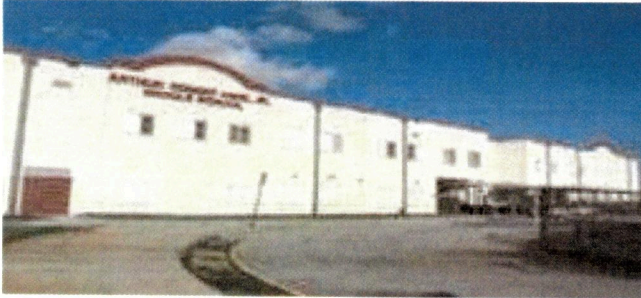

## 2019 Legislative Session- Workforce Education Bills as of 4-16-2019

### **HB 7071 (similar SB 770/ compare HB 7055 and SB 522)**

The bill promotes apprenticeships, enhances talent development, and increases career opportunities for Floridians by:

- Creating the “Strengthening Alignment between Industry and Learning to 60” Initiative and establishing a statewide attainment goal to increase the percentage of working-age adults who hold a high-value postsecondary certificate, degree, or training experience to 60 percent by the year 2030.
- Revising the school grades formula to recognize career certificate clock hour dual enrollment and establishing formal career dual enrollment agreements between high schools and career centers.
- Allowing students with an industry certification to earn two mathematics credits for Algebra I.
- Allowing a computer science credit to substitute for a mathematics or science credit and requiring a biennial review of career education courses for alignment with high school graduation requirements.
- Requiring the Department of Education (DOE) to provide assistance in increasing public awareness of apprenticeship and pre-apprenticeship opportunities.
- Requiring the Commissioner of Education to annually review career and technical education course offerings.
- Establishing a “College and Career Decision Day” to recognize high school seniors for their postsecondary education and career plans.
- Doubling the cap on career and professional education Digital Tool certificates.
- Establishing a middle grades career planning course requirement.
- Revising requirements relating to adjunct teaching certificates.
- Reconstituting the Higher Education Coordinating Council as the Florida Talent Development Council, revising its membership, and requiring the council to develop a strategic plan.
- Creating the Florida Apprenticeship Grant Program to provide competitive grants to expand and enhance apprenticeship and pre-apprenticeship programs.
- Requiring the Department of Business and Professional Regulation, in consultation with the DOE, to submit a report by December 1, 2019, regarding apprenticeship programs that could substitute for the educational training otherwise required for licensure.
- Requiring the statewide articulation agreement to provide for a reverse transfer agreement.
- Requiring career centers and Florida College System (FCS) institutions with overlapping service areas to execute regional career pathways agreements.
- Requiring each school district and FCS institution receiving state workforce education funds to maintain adequate and accurate records and revising the calculation methodology for determining state funding for workforce education programs.

The fiscal impact of the bill is indeterminate. See Fiscal Analysis and Economic Impact Statement, infra. Except as otherwise provided, the bill takes effect on July 1, 2019

## 2019 Legislative Session- Workforce Education Bills as of 4-16-2019

### **HB 7055 (Identical/Similar CS/CS/SB 770)**

To help meet growing workforce demand and provide students flexibility and options to pursue advanced career pathways, the bill:

- revises the school grades formula to recognize career certificate clock hour dual enrollment and establishes formal career dual enrollment agreements between high schools and career centers;
- allows students with an industry certification to earn two mathematics credits for Algebra I;
- allows a computer science credit to substitute for a mathematics or science credit and requires a biennial review of career education courses for alignment with high school graduation requirements;
- requires the Department of Education to provide assistance in increasing public awareness of apprenticeship and pre-apprenticeship opportunities;
- requires the elimination of industry certifications that are not aligned to industry needs;
- establishes a "College and Career Decision Day" to recognize high school seniors for their postsecondary education and career plans;
- doubles the cap on career and professional education digital tool certificates the State Board of Education may identify for weighted FTE funding; and
- reestablishes a middle grades career planning course requirement.

The bill may have a fiscal impact with respect to career dual enrollment agreements. See Fiscal Analysis & Economic Impact Statement, infra.

### **SB 522 (Similar H7071/ Compare S 522 and HB7055)**

SB 522 establishes a new reporting requirement and funding source to expand apprenticeship and pre-apprenticeship opportunities. Specifically, the bill:

- Requires the Department of Education (DOE) to report specified information to the Legislature and the State Apprentice Advisory Council regarding apprenticeship and pre-apprenticeship training in Florida.
- Requires the DOE to provide information on its website explaining how a Florida College System institution or a school district may assume the responsibilities of a local education agency for the purposes of administering an apprenticeship program.
- Creates the Florida Apprenticeship Grant (FLAG) Program, which provides eligibility for grant awards to registered apprenticeship program sponsors who do not require assistance from a career educational institution.
- Assigns to the DOE the responsibility for the administration and supervision of related and supplemental education and training of apprentices whose apprenticeship programs have received a FLAG Program award.

The provisions within the bill are subject to an annual appropriation.

## 2019 Legislative Session- Workforce Education Bills as of 4-16-2019

### CS/CS/SB 770 (Similar HB 7071/ Compare HB 7055 and SB 522)

CS/CS/SB 770 promotes career education and readiness opportunities for students in public schools. The bill creates an alternative pathway, namely the career and technical education (CTE) graduation pathway option, for students to earn a standard high school diploma, and specifies related requirements. Additionally, the bill provides responsibilities for district school boards and the Department of Education (DOE) regarding career education opportunities, specifies options for students to substitute computer science credit for certain credits required for high school graduation, and revises requirements related to CAPE Digital Tool Certificates and adjunct educator certification.

Specifically, the bill:

- Requires students to successfully complete at least 18 credits to receive a standard high school diploma under the CTE graduation pathway option, and exempts a charter school that exclusively offers the CTE pathway option from application requirements related to district school boards but specifies that such charter schools must comply with the application requirements relating to the DOE.
- Modifies the 24-credit pathway for earning a standard high school diploma by revising computer science credit substitution for mathematics or science credits, and creates a mechanism for the review of the sufficiency of career education course standards to meet the Algebra I credit requirement.
- Revises the acceleration mechanism component for the school grade calculation for high schools by specifying that dual enrollment courses include career clock-hour dual enrollment courses.
  - Increases from 15 to 30, the limit on the number of CAPE Digital Tool Certificates that must be identified annually.
- Restores middle grades career education and planning course requirements which were eliminated in 2017, with some modifications.
- Requires district school boards to declare a “College and Career Decision Day” to recognize high school seniors and encourage them to prepare for college and pursue advanced career pathways.
  - Requires the DOE to provide assistance to specified entities when notifying students, parents, and members of the community about apprenticeship and pre-apprenticeship opportunities.
  - Authorizes school districts to issue an adjunct teaching certificate for a full-time teaching position, but specifies that such certificates are valid for a period of three years and are not renewable. The bill also specifies reporting requirements for school districts.
- Creates the “Strengthening Alignment between Industry and Learning to 60” Initiative and establishing a statewide attainment goal to increase the percentage of working-age adults who hold a high-value postsecondary certificate, degree, or training experience to 60 percent by the year 2030.
- Creates the Florida Apprenticeship Grant Program to provide competitive grants to expand and enhance apprenticeship and pre-apprenticeship programs.
- Requires the Department of Business and Professional Regulation, in consultation with the DOE, to submit a report by December 31, 2019, regarding apprenticeship programs that may be substituted for the educational and experience training otherwise required for licensure

**Effective Date:** Except as otherwise expressly provided in this act and except for this section, which shall take effect upon this act becoming a law, this act shall take effect July 1, 2019

## 2019 Legislative Session- Workforce Education Bills as of 4-16-2019

### PCS/CS/SB 1308

PCS/CS/SB 1308 provides for greater access to meaningful credentials that prepare students for additional postsecondary education or a career. Specifically, the bill:

- Requires the Commissioner of Education (commissioner) to conduct an annual review of career and technical education offerings in the K-12 education system, career centers, and the Florida College System (FCS) to determine their alignments with employer demand, postsecondary degree or certificate programs, and industry certifications. As a result of the review, the commissioner must:
  - Phase out programs not aligned to the needs of employers or do not provide those persons who complete programs with middle- or higher-wage jobs.
  - Encourage school districts and FCS institutions to offer new programs that are in demand by employers.
  - Provide an annual report to the Governor and the Legislature summarizing findings and recommendations.
- Expands access to associate in arts (AA) degrees by requiring:
  - The statewide articulation agreement to provide for a reverse transfer agreement to award AA degrees to students who transferred to a state university from an FCS institution before earning the AA degree, but who have since completed requirements for the degree.
  - State universities or FCS institutions to award an AA degree to students who request the degree, or specified students who fail to enroll in a fall or spring semester. The entity that will award the degree is specified based on the number of credits completed at each institution.
- Provides financial assistance for students to complete a degree by:
  - Authorizing a state university or FCS institution to waive tuition and fees for a student who was enrolled between five and 10 years ago, and who successfully completed all but the equivalent of 10 percent of the required coursework for an associate or bachelor's degree.
  - Creating the "Last Mile Scholarship" program for the 2019-2020 academic year. Subject to legislative appropriation, the scholarship awards the cost of in-state tuition and fees to Florida residents who are in good standing, have earned credit at a state university or FCS institution within eight years of application, and are within 12 credit hours of completing a first associate or baccalaureate degree. The bill does not have an impact on state revenues.

The bill may result in a loss of revenue for postsecondary institutions who grant the tuition and fee waivers authorized by the bill. The funding for the "Last Mile Scholarship" is contingent upon legislative appropriation. In addition, institutions may incur costs as they track students about meeting the requirements of AA degree. The Department of Education may incur costs related to the annual review and report of career and technical education offerings. However, the department can absorb these costs within its current appropriation.

## 2019 Legislative Session- Workforce Education Bills as of 4-16-2019

### **SB 1366**

SB 1366 promotes options for education in computer science by:

- Providing that a student may substitute one computer science credit for one science credit, excluding Biology I, in order to satisfy the credit requirements to earn a standard high school diploma;
- Including high-quality professional development for teachers to provide instruction in computer science courses to the existing training that a school district or consortium of school districts may apply to the Department of Education for funding to deliver, subject to legislative appropriation; and
- Increasing the number of potential certificates available to elementary and middle school students by doubling the limit on CAPE Digital Tool certificates that may be included on the Industry Certification Funding List.

The bill does not have an impact on state revenues or expenditures. However, increasing the number of CAPE Digital Tool certificates may allow some school districts to generate additional bonus funding through the Florida Education Finance Program (FEFP).
