- IV. School Improvement Plan 2018 2019 Discussion- Monitor Parent Input
  - Unified Dress Code Policy / Ballot / Voting

    - Change Offense Send home a copy of the school uniform policy and call parents = Combine 2<sup>nd</sup> and 3<sup>rd</sup> offenses
  - Note- when weather changes, uniform policy is still in effect, and children should wear appropriate clothing.
  - Results = Deadline March 15<sup>th</sup> 66 & 2/3 is required for the win.
