SIP Update:

- Behavior Plan:
 - o Committee comes up with a plan that will be used school wide
 - In Cafeteria, Hallways, and playground.
 - Sometimes students need reminders of the plan.
 - Use Data from Referrals to identify recurring problems and how to help/deal with the behaviors. No major infractions such as gang or violence.
 - 98% of students have 0 or 1 referral
 - 1% has 1-5 Referrals
 - 1 student has more than 5
 - 12 referrals this year in 3rd grade and those 12 are split between 2 students.
 - o CHAMPS: Conversation, Help, Action, Movement, Participation, Success
 - District wide behavior plan. Refresher course taken this year.
 - Multiple referrals have more severe consequences and also depending on infraction.
 - Discipline Matrix was updated last year.
 - Deanna O'Connor asked if there were any trends and if data should be assessed by SAC?
 - No Apparent trends.
 - Zen room is being used to allow for calming time. Items requested and a donor page/fundraise with list of items is online.

Principal's Report:

- Buzzer and Card Reader at front door has been installed. Buzzer on secondary door is installed.
- Stop the Bleed kits-3 in school. Walk with CSPD tomorrow to assess where to put more.
- Thursday night (11/29) Coral Glades Zone Meeting at Coral Glades High School from 6-7:30 about academics.
- Washington DC trip for 5th graders will be next week.

• Parents do not go. There are rules and regulations to follow. Only staff goes on the trip with the exception of a medically necessary student.

Other business:

- MSD Commission met to discuss "Hard Corners" They should be taped off to easily see the safe no sight corners. Administration hasn't received directives to do that.
- Threat Assessment team is administration and police. All are retrained or will be. All documents are digital and checklists to see how credible the threat is.
- Honor Roll Assembly- Mary Beth Gebbia asked why we don't do one. Geraine answered we only do a breakfast for the students and don't want to lose more teaching time.
