**i. Meeting called to order**

- The meeting was called to order at 2:33 p.m.

**ii. Approval of January 9, 2019 Minutes**

- Minutes from January 9th, 2019 were approved by Mrs. Benson.

**iii. School Improvement Plan/Title I Addendum**

- Mr. Brown presented the proposed 2019-2020 Title I Addendum to the committee.
- The committee reviewed the Title I Addendum. Mrs. LaPaglia suggested that suggestions from the January 9 SAC meeting be included within the document for the 2019-2020 school year.
- Mr. Brown stated to the committee that the SIP component of the plan cannot be completed at this time due to fact that test scores have not been released and any potential areas of improvement cannot yet be identified.
