3. Principal's Update

- School Choice Enhancement Funds update FOB system was taken off the list of items due to district issues. The fence and the gate are still planned to happen as well as the accordion wall. Three items on the list are done and approved; office lobby, murals, and sign. We have two pending items on the list to see if we have the funds to cover, which is technology and Primary Playground. Ms. Sasse will continue to give updates as it goes along.
- Discussion with HW policy The topic was brought up to the leadership team. We have a great resource with IReady and plan to implement it more for HW. K-2 will be moving forward with just providing IReady HW next school year. Parents discussed they are

good with the use of the just the computer program. Teachers will provide the extra HW if needed for certain students as discussed with parents during conferences.
