

School Advisory Council (SAC) MINUTES
September 24, 2018

1. Welcome: Nina Cohen welcomed new and returning SAC members. She reviewed the sign in sheets.
2. SAC Overview/Bylaws: Ms. Cohen reviewed SAC policies and by-laws. The make-up of the committee, the attendance responsibilities of members, School Board Policy 1403/1403 A, quorums, accountability money and training. Ms. Pinzon motioned to accept the by-laws and Ms. Sester seconded.
3. SAC Nominations: Ms. McCullough made a motion to have Ms. Cohen as the SAC Chair for the 2018-2019 school year and Mr. Noble seconded. Ms. McCullough motioned to have Debra Rosenzweig as the Recording Secretary and Ms. Powell seconded.
4. School Improvement Plan: Ms. Cohen reviewed sections of the SIP. She discussed the plan, best practices and reviewed data on the gains our school made last school year. Components of the School-Wide Positive Behavior Plan were reviewed at this time as well and will be discussed in detail at the next meeting. A parent will be needed to represent our school at SIP meetings for the Zone which includes Monarch HS, Lyons Creek MS, and Tradewinds Elementary.
5. Principal's Sharing: Mr. Henning explained to the SAC members that Title 1 money is used for parent training and staff training More information on expenditures will follow. He shared that the first construction meeting is just a few weeks away. He commended teachers for a job well done in getting our school to a grade of "B". He explained the numbers in regard to budget, we had

to surplus a teacher but that teacher, Mr. Liebig, has been employed by another school. Safety remains a concern, and buzzers are needed for front office doors. Mr. Henning requested the SAC vote to release some of the money allocated for benches and other items from the Bond money to the installation of buzzers. This will be voted on at the next meeting of SAC.

6. Other Business/Open Forum: Ms. McCullough asked when teachers will receive the "A+ Funds". Mr. Henning/Ms. Cohen said proposals were not due until early 2019 and more information would follow.
7. Adjourned SAC at 7:41 am
8. SAF Meeting: Ms. Cohen gave an overview of SAF and asked for a volunteer to chair the SAF. Volunteers interested should contact Ms. Cohen after the meeting. SAF Adjourned at 7:45 a.m.
