

# Hawkes Bluff Elementary School Advisory February 25, 2019 Minutes

## Welcome

- Mrs. Wicker called the meeting to order at 1:22p.m.

## Approval of Minutes

## Peace Pole Dedication

- 5<sup>th</sup> grade students sang a song
- Poems written and read by students

## Monitoring of SIP Plan

- Schoolwide Positive Behavior Plan: We would like to keep the same 3 general rules. Teachers review these rules after long breaks. They should be going over them again after Spring Break
- Mid-year Reflection: We look at data (iReady, BAS, FSA, etc.). We implement supplemental reading groups. We started students on iReady on an earlier start date. Teachers monitor students while taking the diagnostic test. Students are encouraged using incentives. We are asking parents to get the students on iReady for 45 minutes per week in math and reading.
- Barriers: We have had a decrease in tardies due to the new school procedures (closed campus). Students have mastered signing on to SSO. Teachers can place students in quadrants using the iReady data. This allows them to see what each child needs to do to raise academic achievement. Mrs. Cunningham explained stretch growth. You will need to ask the teacher for a parent report. The teachers adjust the lessons based on individual students' needs.
- Strategies implemented to fidelity: Kindergarten and first grade teachers are implementing Wilson Foundations. Grades two through five are using phonics for reading, quick reads, and intermediate rewards.
- Benchmarks for success: Continue iReady and supplemental reading groups. Teachers will continue through data chats and PLC's to analyze data and students' needs.
- We are monitoring students to ensure they are completing iReady with accuracy. They need to complete their lessons with 70% accuracy.

**Principal Updates:**

- Safe Place: Teachers have identified areas in their rooms. They could be changed, but as of now we are complying with the policy.
- Anybody can call a Code Red
- A third directive is threat assessments: Any time a child says anything in the form of a threat, we need to report it. This will follow the child all through school. Every threat is entered into the database. It doesn't matter if they are ESE or not. The consequences might be different, but the threat assessment will go in the system. We have been working to explain this to the students.
- Fortnite: Many kids are talking about it and it is inappropriate for school. They cannot wear Fortnite attire.
- BSA scores compare students in the district. The median is at 50%
