**Old Business:**

1. FSA Camp continues for ELA, Math, and Science for the next two weeks. Writing camp is now over due to the students completing the FSA Writing test earlier this month.
2. FSA ELA 3<sup>rd</sup> Grade and FSA Writing 4<sup>th</sup> and 5<sup>th</sup> grade testing completed on April 2-3.
3. Advanc-Ed Stakeholder Survey: The parent survey is available this evening on the laptop computers. Please complete a survey if you have not done so.

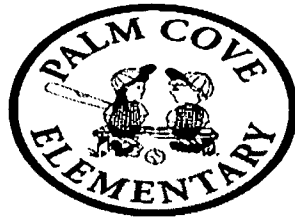
**New Business:**

1. Fifth Grade End of Year Activities are being planned and Coach Hernandez and the Fifth Grade team will be contacting parents to volunteer.
2. School Choice Enhancement Ballot: The draft for the SMART Bond School Choice Ballot was reviewed by the committee. They reviewed the option 1 and 2 choices. Coach Alvarez explained to the committee that the final ballot would be coming home with the students to vote starting tomorrow and ending on 4/19/19. The staff would also have a chance to vote as well. The floor was opened up to any questions or comments. No questions were asked. Herbert Palmer made a motion to accept the School Choice Enhancement Ballot as seen. Markicha Alcide seconded the motion. All were in favor and the motion passed.

**Reports:**

1. **Principal Report:** Mrs. Davida Johnson, the school principal, gave an update on school events and welcomed everyone. She reviewed the FSA testing schedule with the parents.
2. **Title One:** Kim Charpentier gave an update on the Title One. Our binder is 75% complete.
  - a. Parents were given a copy of the 2018-19 SIP plan with the Title 1 Addendum and invited to provide input in the development of the 2019-2020 SIP plan with the Title 1 Addendum. They did not have any suggestions for next year and were happy with the plan as it currently stands.
  - b. Parents were provided a copy of the Review of the 2018-2019 Parent and Family Engagement Plan (PFEP) and a copy of the 2019-2020 PFEP for next school year. The Review and new plan were reviewed by the parents and committee. A discussion was started by one of the parents about how much their children enjoyed the family nights and they wanted that to continue next year. The parents also commented on how they liked having the Open House and Meet and Greet in one day and not on separate days as in years past. A motion was made by Jennifer Alfred to accept the Review of the PFEP for 2018-2019 and accept the new PFEP for 2019-2020. Jill Villar seconded the motion, and all were in favor and the motion passed.
  - c. 2019-2020 Parental Involvement Allocation and parent involvement activities were discussed and reviewed. Allocations for last school year were used towards Family nights for writing, Literacy/Dr. Seuss, Math, and Science. Next year the parents would like to use the funds for the same events and feel that they benefit the school and students. A majority of the parents wanted it to stay the same and feel it should not change. Allocations will remain the same for next year.
