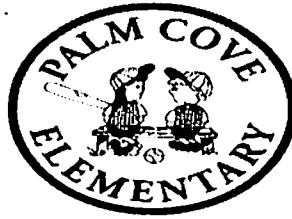

SAC Minutes- March 19,2019.

Call to Order:

A meeting of the Palm Cove Elementary School Advisory Council was held in the Cafeteria on January 24, 2019. Chair Kimberly Charpentier called the meeting to order at 6:00 PM. Jennifer Alfred will record minutes for this meeting.

Minutes:

The minutes from the November meeting were reviewed by the committee. A motion was made to accept the minutes as is by Jennifer Alfred. Second by Herbert Palmer. All were in favor. Motion passed.

Old Business:

1. Please join our new Palm Cove PTA. Contact Coach Bieber if you have any questions. He is here tonight to address concerns/questions.
2. We will be having a parent meeting for the fifth-grade end of year activities. Flyers will be sent home to all fifth-grade students this week. Please look out for them.
3. The Behavior Team is formulating the new Behavior plan for next school year as part of the SIP plan. No updates currently.
4. The Before and After School Child Care Safety Check and Review has been conducted. Copies are being distributed to committee members and parents who are interested. Palm Cove had no violations and passed. Thank you to ASP for doing a great job with our after-care program.

New Business:

1. Parents were reminded that the FSA Writing 4th and 5th grade will take place on April 1st and 2nd as well as the FSA 3rd Grade ELA Assessment.
2. FSA Camp is in full swing at Palm Cove. Students were targeted based on data collected. Camps are Reading, Math, Science, and Writing weekly. We will discontinue the Writing Camp and 3rd grade ELA Camp after the week of the FSA tests. All other camps will continue.

Reports:

1. **Principal Report:** Mrs. Davida Johnson, the school principal, gave an update on school events and welcomed everyone. She reviewed our instructional plans this year and goals for the FSA and moving our school up to the letter grade of a B. She urged the importance of any students who are enrolled in our camps to please attend.
2. **Title 1:** Kim Charpentier gave an update on the Title One plan. Our e-binder is in compliance with the state at this time.

Title 1 Survey: The results of the survey were copied and shared with parents. Parents were given the opportunity to provide input and ask questions. She reviewed the questions and noted that most of the answers on the survey had most of the answers as "Agree". Nigel Bennett was the Pre-K parent representative and felt that the survey should ask more questions in relation to the program. No other parents had any feedback. Coach Charpentier shared that they could access the results by contacting her at the school to obtain additional copies of the results.

School Parent Compact Review of 2018-19: Coach Charpentier passed out a blank copy of this school years compact for review. Norman Wilson wanted to know if all the parents had a good success rate of return. Coach Charpentier explained that a checklist is made prior to Open House for each classroom so that any missing compacts can be obtained at that time. Maria Lozano, our IMT, also explained that the compact is signed at registration by all new parents. No other questions or comments on the compact were noted.

School Parent Compact 2019-2020: Coach Charpentier passed out copies of the new compact for next school year for review. Parents were able to give input for the document and did not have any feedback as they like the layout and format. Ms. Alcide commented that it was user friendly and easy to read. She

also commented that parents know what to look for in the packet of papers at the beginning of the year. All were in favor of accepting the new compact for the 2019-2020 school year.
