New Business: Voting: A+ Proposals

1. School Recognition program (A+ funds) options and process flow chart discussed
2. School staff will vote on Thursday 10/18/18 at 12:30 in the Media center
3. Jessika Pacheco motions to add option 1 on the ballot. Motion seconded by Sherdean Rhule-Rheume. Roll call vote for SAC Committee Membership. (15 yes, 1 no) Proposal of option 1 approved and passed.
4. Natalie Russo motions to add option 3 on the ballot. Motion seconded by Georgia Elliott. Roll call vote for SAC Committee Membership. (6 yes, 10 no) Proposal of option 3 did not pass.
5. Kathi Curtis motions to add option 2 on the ballot. Motion seconded by Anne Miller. Roll call vote for SAC Committee Membership. (14 yes, 2 no) Proposal of option 2 approved and passed.
6. Kimberly McCarthy motions to add specific wording on the ballot that states instructional and non-instructional employee staff must have worked a minimum of 51% or 91 or more days in the majority of the school year at Eagle Ridge in order to be eligible for a share of the A+ funds on the ballot. Motion seconded by Kathi Curtis. Roll call vote for SAC Committee Membership. (15 yes, 0 no) Proposal approved and passed.
