Call to Order: A meeting of the **Silver Shores Elementary School Advisory Council** was held in the principal's office on **Wednesday, November 14, 2018**. Dawn Lopez called the meeting to order at **6:07 pm**. Dawn Lopez will record minutes for this meeting.

Minutes Approval – Minutes from last meeting were unanimously approved.

SAC Update given by Dawn Lopez who let everyone know that the 2nd quarter SIP meeting will be in December. She also discussed cancelling the December SAC meeting, since only 8 meetings are required and everyone is busy around the holidays. This was unanimously approved.

Principal's Report – Given by Dr. Leff at 6:10. He discussed the improvements that are being made to the school from a custodial aspect. He clarified what a PMP is. He discussed the Science Road Show that will be at the school 11/15/18 in partnership with the Everglades HS Science Honor Society. He spoke about a new Math fluency program the school has purchased, Reflex Math.

Title I – No update

Community Update – Dr. Leff spoke about attending the Silver Shores Community Fall Festival where he read some Halloween books to students.

Old Business – Dr. Leff informed us that the last of the SMART Bond Money was finally spent on new modular furniture for the Media Center. Waiting on a few music items that are on backorder. Other improvements to the roof and HVAC also being completed.

New Business – None

Next Steps/Miscellaneous – School Choice window is opening December 1st. Dr. Leff spoke about finding out that the reason we became Title 1 was because that any families that received money after Hurricane Irma were automatically placed on the free/reduced lunch list. Because of that, we are not sure if we will be Title 1 again next year.

- Mr. Williams is concerned about traffic in the mornings. There are more police in the mornings, but people are making illegal left-hand turns out of the school. Additionally, parents are not just dropping off their children from the carline, but stopping to get out of their cars instead.
- Mrs. Lamptey inquired whether or not the school has been contacted or updated on the construction going on. Dr. Leff said that he hasn't. She works for the city of Miramar and said she would look into it, as she thought that the school should be getting updates.
