- III. Principal's Report: Given by Dr. Leff
 - Instead of Science Fair we will have a Science Road Show (Museum of Discovery and Science) May 20, 2019 6:30-8:00.
 - b. We are in the last stretch of the year. ELA is up and Science is up 30%. 1st and 2nd grader are getting ready for the End of year Primary test. 60% of the students are predicted to be proficient on the FSA based on the benchmark test.
 - c. Title 1 has been a great benefit to the school. We have been able to buy supplement material.

IV. Title I

- a. VIII. New Business

- a. Review 2019-20 Schoolwide Positive Behavior Plan (Ms. Monroe) Ms. Jackie agreed to serve on the SPBP team. The staff voted 53 people voted 51 yes and 2 no. Professional development for the staff and any other things needed. 56 referrals most were unruly behavior and play. School-wide Expectations were discussed. The only thing that is new is the teacher rules will be added. We changed our Positive behavior plan. We implemented a behavior dance this year. However next year the students will get beads based on the teacher input on a monthly basis. At the end of each quarter the kids will get recognition.
- b. Every year we allocate money from our School Accountability and School Recognition funds to pay teachers who teach our FSA camps to help prepare our students for the FSA and help our school achieve maximum proficiency and learning gains. This has been added to our SIP. Some money was rolled over from last year since we did not get School Recognition funds this year. However, we need to conduct a vote to allocate \$8,880 from our School Accountability and School Recognition funds to fund our FSA camp. Online vote conducted on May 1, 2019. Results: Unanimously approved with 11 yes and 0 no votes received.
