Principal's Report (Mr. Peters):

Safety

Deputy Rachel Radulic is assigned to the campus full-time. Staff and students must now wear ID's at all times. Due to a generous donation from a parent, there are numerous safety improvements being made throughout Gator Run. A swipe card system has been added to the door exiting the front office into the main hallway. Visitors need to be cleared and buzzed through the door to gain access. Through the SMART bond, Gator Run Elementary received \$100,000 to make school improvements. It was decided to not build an outdoor classroom. Instead additional door swipes are being added to the front of the 800 building and the back door of the main building. Approved visitors will be given swipe cards in order to gain entry to those locations. Speakers were also purchased for the outside art patio and the portables. Arrival and dismissal procedures have also been changed. Parents will no longer be allowed to walk their students onto campus. If coming by car, parents will need to come through the carpool line and stay in their car to drop of students. Parking in the parking lot and walking students to the door will no longer be permitted. During dismissal, the walking gate off of Park Road will now be locked for safety. Students will be exiting campus using the sidewalk leading to Savanna Drive. Parents will be allowed to meet their students at the end of the sidewalk. Severe weather dismissal is also being reviewed. Many options are being looked at to keep students in buildings. Code red drills will be practiced monthly, along with fire drills. After hours, gates will be either locked or monitored to ensure the safety of the students in Aftercare.

FSA Scores

Overall, Gator Run Elementary scored 4th out of all elementary schools in Broward County. A stronger focus will be placed on lower quartile students making learning gains.
