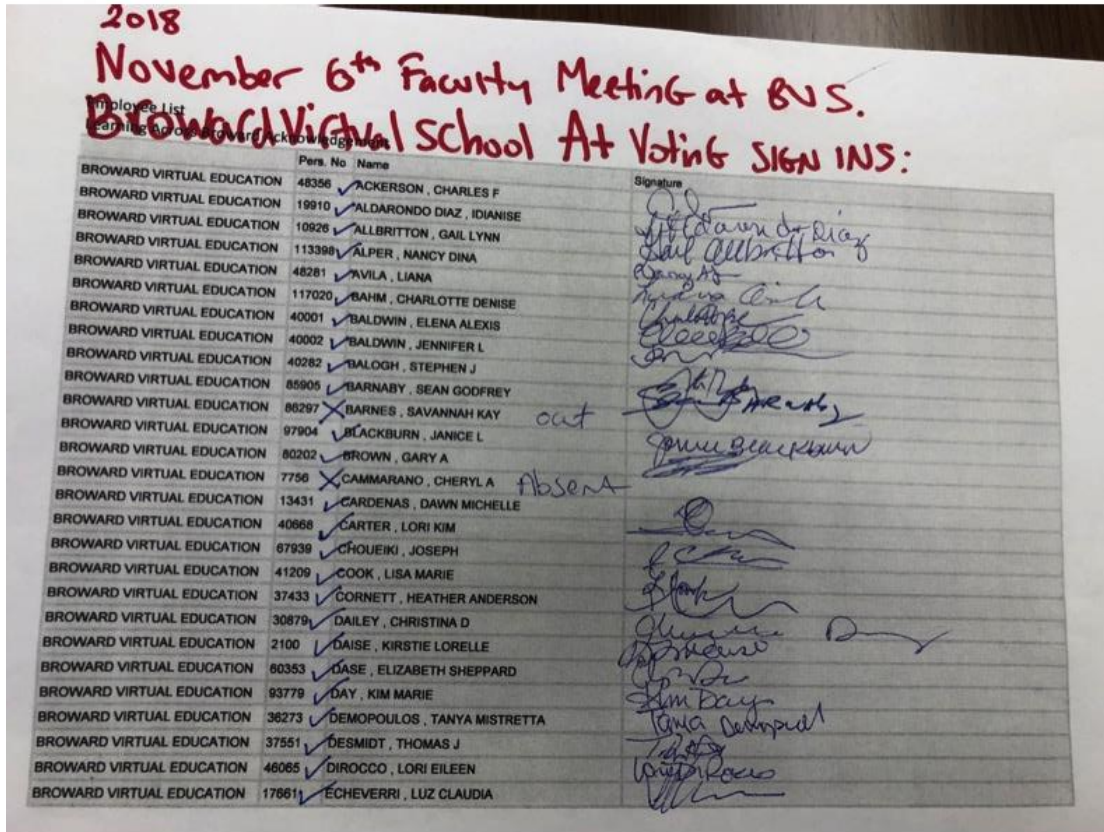

This means we had well over 51% majority voting in Favor of Proposal One.

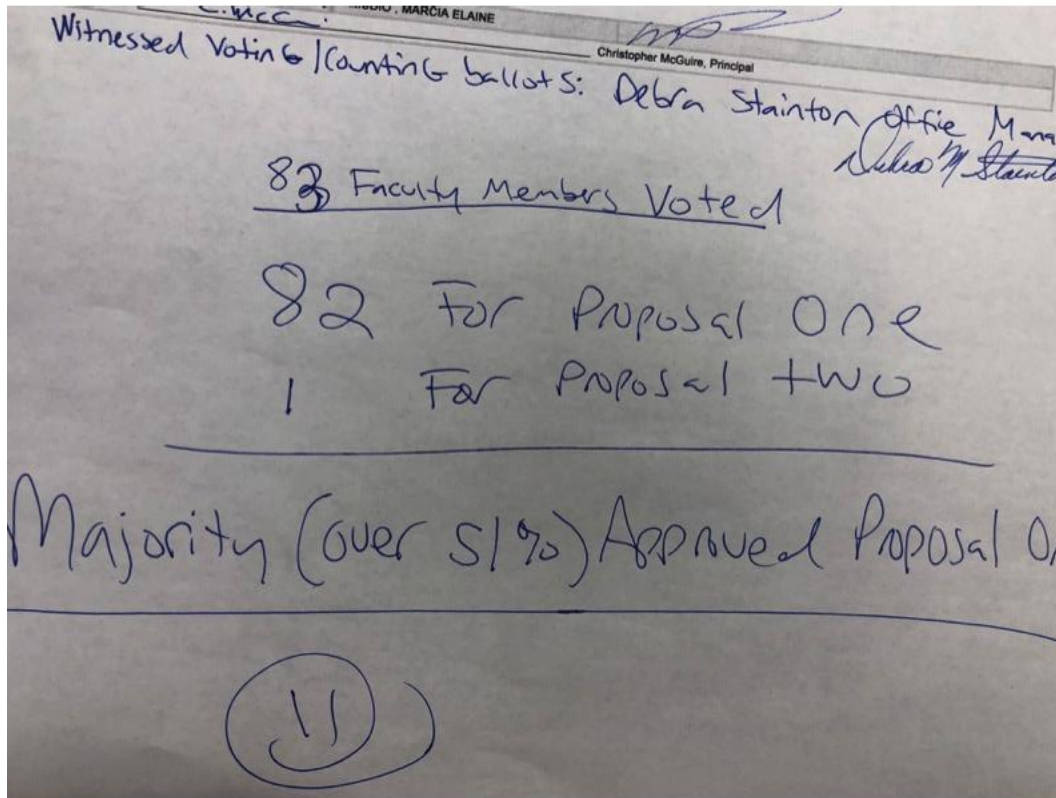
