School Improvement Plan (SIP):

School-Wide Positive Behavior Plan

Ms. Boggan reviewed the School-Wide Positive Behavior Plan where data is collected from BASIS. The Top 5 Behavior incidents are: unruly/disruptive behavior, disruption on campus minor, disruptive unruly play, disobedience/insubordination, and bullying. The locations of these behaviors are: hallway, cafeteria, and playground.

As a result, school-wide expectations were created reduce misbehaviors. The flow chart demonstrates the effective discipline procedures. Staff managed misbehaviors and office managed Misbehaviors shows the matrix of procedures. Teachers also will review CHAMPS to remind students of school-wide expectations.
