SAC Bylaws

Ms. de Varona reviewed the SAC roles and responsibilities and who serves on SAC. SAC is a school-based group intended to represent the school community, and students in efforts to support the school's continuous improvement. SAC is responsible for the final decision-making and implementation of the School Improvement Plan (SIP). SAC is composed of: Principal, teachers, BTU Steward, Education Support Employees, Parents, and Business and Community Citizens.

Article II: Purpose:

-To facilitate the development of SIP

-To monitor the implementation of the SIP

-To evaluate the effectiveness of the SIP

-To make recommendations to support the SIP

-To provide assistance in the preparation of the school's annual budget

Article III: Membership:

-A voting member must be present to vote

-SAC Member will be removed after two unexcused absences

-Term: Serve One Year

-Announcement of Election: must be made 1 week in advance

Article V: Officers:

-Chair and Vice Chair

-Officers are elected annually, installation of new officers is held at the first meeting

Article V: Duties of the Officers

-Chair: preside at all meetings, represent SAC at district meetings, sign SIP and Budget -Vice-Chair: Represent the Chair, substitute in the absence of Chair

-Secretary: responsible for all correspondences and notices of meetings, record minutes, maintain record of attendance

Article VI: Meetings: -All meetings are open to the public. -Quorum is the minimum number of members who must be present -All scheduled meetings will be announced three days in advance -Meetings will follow the approved agenda All meetings will follow Roberts Rules of Order Bylaws must be reviewed and approved annually Amendments must be approved by the majority of SAC members

The floor was open for questions and concerns:

Questions: Why must the by-laws be reviewed and approved annually if there are no revisions?

Ms. deVarona responded by stating that new members must be aware of the by-laws. Maria Dodd made a motion to accept the SAC bylaws. Carrie Forsyth seconded the motion. All were in favor, none opposed.

SMART Bond

Ms. Thomas reviewed the schools previous intentions for the SMART Bond money. **The purchases included:**

Murals, Benches in the front of the school, PA System and speakers for car loop, Upgrade to the cafeteria sound system, PE equipment for each class, grade level books for the literacy book room, New stage curtains, podium, and upgrade to the TV production room.
