SUBJECT: **2008-09 NCLB CHOICE ASSIGNMENTS**

Enrollment counts, as of the 20<sup>th</sup> day of the 2008-09 school year, were conducted for students who changed schools of enrollment, due to the No Child Left Behind (NCLB) option. A data file of all active District students provided on the 20<sup>th</sup> day by Education Technology Services (ETS) staff was compared to a database of students who were enrolled in previous years as Choice students, as well as a file containing all students who were offered NCLB Choice for the present school year.

According to the 20<sup>th</sup> day active student file, there was a cumulative total of 3,615 students with an Assignment Code of "73," which denotes NCLB Choice. The number reflects all students still enrolled in a Choice school from 2004-05 through 2008-09. **Of the 3,615 students, 1,923 Choice students remained enrolled from previous years, and 1,692 students were *new* Choice students enrolled this fall. As reported in the table below, the number of students selecting NCLB Choice in 2008-09 ( $N = 1,692$ ) is lower than the 2007-08 number of 2,363 students. This represents a decrease of 440 students selecting NCLB Choice this year, compared to last year.**

In previous years, the Educational Programs Department mailed a notification to parents or guardians of students scheduled to attend any Title I school that was required to offer NCLB Choice. The notice provided information regarding NCLB Choice options and a choice of *two* schools to which a student could transfer. A new system for selection of receiving schools was implemented for the current school year. This year, instead of selecting only two schools to serve as receiving locations for each sending school, the District identified several schools that were able to receive students. The process successfully allowed the District to assign students to several schools and control possible negative impact of meeting class size reduction. For Title I charter schools that were required to provide Choice, the receiving schools were based on the student's home address. As an example, if the home address was in the South area, the family received a notification letter and form with available schools in the South area, even if the child attended a North Central area charter school. The modification allowed the District to provide transportation based on the student's home address.

Two attachments provide supplementary data regarding NCLB Choice enrollments. Attachment A presents current school year NCLB enrollment data for sending schools. In Attachment B, for the incoming sixth grade students, the sending school is the identified home boundary middle school the sixth grader would have attended, rather than the elementary school they came from as fifth graders. To maintain the anonymity and privacy of students, frequency data were not displayed when the number for a sending or receiving school was fewer than 10 students, which is in accordance with policy guidance from the Florida Department of Education.

According to the data, Ramblewood Middle received the largest number of new NCLB Choice students at the middle school level ( $n=156$ ), and Riverside Elementary received the largest number of new NCLB Choice students at the elementary school level ( $n=35$ ). The Title I schools that lost the greatest number of new NCLB Choice students were Margate Middle at the middle school level ( $n=177$ ), and Royal Palm Elementary at the elementary school level ( $n=33$ ).
