

FULL-TIME INSTRUCTIONAL PERSONNEL ASSIGNED TO TEACH IN THE ADULT AND COMMUNITY EDUCATION PROGRAM

INSTRUCTIONAL PERSONNEL WHO ARE EMPLOYED TO TEACH FULL TIME IN THE ADULT EDUCATION PROGRAM SHOULD BE EMPLOYED AS SCHOOL BOARD OF BROWARD COUNTY CERTIFICATED INSTRUCTIONAL PERSONNEL IN COMPLIANCE WITH FLORIDA STATUTE 232.1725 (1) (B) AND SHALL BE GOVERNED BY THE CRITERIA SPECIFIED BELOW.

RULES

1. Instructional personnel who are employed to teach full-time in the adult education program shall hold a valid full-time Educator's Certificate issued by the State Department of Education in any academic coverage identified on the ADULT CERTIFICATION COVERAGES list and shall be governed by the same School Board policies as other full-time instructional personnel.
2. All Educator's Certificates are to be renewed every five (5) years pursuant to State Board Rules.
3. Condition of Employment

To be and to remain eligible to teach in Adult General Education (AGE) all instructors must complete a minimum of ten (10) inservice points specifically related to adult education (process & methodology) during each five year certificate validity period. College credit courses in adult education may satisfy this ten (10) point requirement.

4. Certification Coverage

I. Adult Basic Education:

- a. Certification for teaching basic skills, are listed on the School Board of Broward County ADULT CERTIFICATION COVERAGES list.
- b. Beginning July 1, 1991, to teach English for Speakers of Other Languages (ESOL), certification subjects are listed on the School Board of Broward County ADULT CERTIFICATION COVERAGES list-ESOL endorsement must be achieved within three [3] years.
The District requirement for ESOL endorsement requires successful completion of either three (3) semester hours of college credit in ESOL or sixty (60) hours of inservice credit in ESOL.

II. Adult Disabled:

Certification coverages shall be those specified by the Course Code Directory in an area of exceptional student education. This provision applies to all teachers hired after June 30, 1995.

III. Adult Secondary Education

- a. Teachers of adult high school (credit earning) courses shall be certified according to the specific program area listed in the Course Code Directory.
- b. Any academic certification coverage is appropriate to teach General Education Promotion (GEP) or General Education Development (GED) courses. Refer to the School Board of Broward County ADULT CERTIFICATION COVERAGES list. When concurrently enrolled students are involved refer to 4-(III) (a) above.
