SUBJECT: RELEASE OF 2011 FLORIDA COMPREHENSIVE ASSESSMENT TEST

(FCAT) WRITING ASSESSMENT RESULTS

Results from the 2011 Florida Comprehensive Assessment Test (FCAT) Writing Assessment were released today by the Florida Department of Education (FDOE). The FCAT Writing Assessment is administered annually to students in grades four, eight, and ten. The assessment consists of an essay written by the student with scores reported on a scale ranging from 1 to 6. While a score of 3 is considered proficient for Adequate Yearly Progress (AYP), a 4 is used for proficiency in Florida's school grading system. This is an increase from 3.5 in prior years. Beginning in 2010, FDOE changed from two prompts and two scorers per grade to a single prompt and scorer due to budget constraints, meaning that half-point scores (1.5, 2.5, etc...) are no longer possible.

The essay prompt directs students in fourth grade to write either in Expository or Narrative style while the eighth and tenth grade students are directed to write either in Expository or Persuasive style. Results are reported by grade level as mean scores for Expository and Narrative/Persuasive style. Moving to a single prompt for each grade means that only Expository or Narrative/Persuasive scores are available for each grade in any given year.

The mean score for Writing among Broward students was 4.2 for Grade 4, 4.3 for Grade 8, and 4.1 for Grade 10. These scores exceeded the state averages. A majority of students in the fourth (97%), eighth (97%), and tenth grades (95%) scored at or above the AYP proficient level of 3 or higher. In terms of School Grade, 86% of grade 4, 86% of grade 8, and 80% of grade 10 students were proficient (a score of level of 4 or higher).

The data summarized in this memorandum encompass all students who were tested this year, including exceptional education students (ESE) and limited English proficient (LEP) students regardless of amount of time in the District. Therefore, these data include students who will not be included for school grade or AYP computations. Table 1 presents the results from the 2011 FCAT Writing Assessment along with the results from the prior four school years.

Broward students outperformed the statewide averages in each grade level. This year's grade 4 average score was 4.2 in Broward compared to 4.0 statewide, 4.3 for grade 8 compared to 4.2 statewide, and 4.1 for grade 10 compared to 4.0 statewide. Since the mode of the writing prompt changed from 2010 to 2011 in grades 4 and 10, the results are not comparable for those grades; however, grade 8 performance remained stable on the expository style prompt from 2010 to 2011. Table 2 displays the percent of students at each grade level who earned a score of 3 or higher, and 4 or higher from 2007 to 2011.

Since 2007, the percentage students scoring 3 or higher in Writing has remained stable or increased slightly to be at or above 95% in 2011. More importantly, the percentage of students writing at a higher level (4 or higher) has increased by 5 or more percentage points in each grade.

- Fourth grade registered an 11 percentage point increase in students scoring at 4 and above from 75% in 2007 to 86% in 2011.
- Eighth grade registered an increase of 5 percentage points in students scoring at or above 4 (81% in 2007 to 86% in 2011).
- Tenth grade registered an 11 percentage point increase in students scoring at or above 4 (69% in 2007 to 80% in 2011).

Table 3 provides the percentage of students scoring 3 and above as well as 4 and above for the state and five largest districts. For each grade, the proportion of students scoring 3 and above was similar in each of the five largest districts and the state. In grade 4, the percentage of students scoring 4 or above in Broward (86%) equaled or exceeded the state and three of the four other large districts (Hillsborough had 90%). In grade 8, the percentage of students scoring 4 or above in Broward (86%) equaled or exceeded the state and the four other large districts. In grade 10, the percentage of students scoring 4 or above in Broward (80%) equaled or exceeded the state and three of the four other large districts (Palm Beach had 82%).
