- 2.5 **Price Adjustments:** Prices offered shall remain firm through the first five years of the contract. A request for price adjustment may be submitted 30 days prior to the first renewal anniversary date of the contract. If a price increase is approved after the first renewal anniversary date, then that price must remain firm for the remaining renewal periods of the contract. ➤ **QUESTION #1:**

Our company can provide a very cost efficient GPS Tracking solution for buses that would save thousands of dollars vs. a solution that includes student tracking. Do we have to provide student tracking?

ANSWER TO QUESTION #1:

It is the intent of Broward Schools to find the best "Turn-Key" GPS solution which will also provide Broward Schools with a long term positive return on investment. It is the responsibility of the Proposer to communicate with any other vendor with which they desire to integrate their system to meet all requirements of the RFP. If a Proposer is unable to provide a student tracking solution, it should be clearly identifiable in their proposal and will be evaluated accordingly.

➤ **QUESTION #2:**

Can we take exception to the requirement to agree to "complete and unconditional acceptance of the contents of Pages 1 through 25 inclusive of this Request for Proposals, and all appendices and the contents of any Addenda released hereto; Proposer agrees to be bound to any and all specifications, terms and conditions contained in the Request for Proposals, and any released Addenda"?

ANSWER TO QUESTION #2:

No. Any Proposer who fails to execute the Required Response Form will be considered non-responsive and not evaluated.

➤ **QUESTION #3:**

What if some items are contradictory (as in the manner of student identification), or currently impossible to meet (such as to change cellular carriers without affecting the hardware) – how do we handle this?

ANSWER TO QUESTION #3:

It is the intent of Broward Schools to evaluate various student tracking solutions. To the extent items are contradictory, it is not intended. In regards to the cellular issue, please see response to Question 15 below.

➤ **QUESTION #4:**

Is Attachment G considered a part of the agreement, or is any agreement restricted simply to pages 1 through 25 and anything specifically identified as an appendix or addendum?

ANSWER TO QUESTION #4:

Attachment G is System Requirements. The system requirements, provided on Attachment G, are general requirements needed for the GPS tracking system and student tracking and will differ per manufacturer. If you are referring to Attachment F, Sample Agreement, this is to provide the Proposer a sample of an agreement that will be used for the recommended Proposer and for award. The finalized agreement will include all pages of the RFP, addendums and attachments.

➤ **QUESTION #5:**

For the on-site consultant service, can we quote a weekly or monthly rate instead of an annual rate? Or is it the intent to have a vendor employee on-site for the duration of the contract or some other period (and if the latter, what is the period)?

ANSWER TO QUESTION #5:

It is the responsibility of the Proposer to provide Broward Schools with an annual cost associated in providing an "on-site" consultant. Weekly/monthly costs may be included in the subtotals of Section 4.4.4.7.

➤ **QUESTION #6:**

Can you tell us why it is important to SBBC that a vendor has references that aren't school districts?

ANSWER TO QUESTION #6:

The references are for comparison purposes in order to have fleet size that is comparable to our District's bus fleet.

➤ **QUESTION #7:**

Can you further describe what is meant by the following, specifically, what is a zone and what is it reference to on page 7 of 25: "4.4.1.18 Zones - Describe all inclusion and any excluding zones."

ANSWER TO QUESTION #7:

Inclusion/exclusion zones refer to boundary areas that relate to Geo-fencing.

➤ **QUESTION #8:**

Can you describe why the solution should be in compliance with the new "Shared Learning Collaborative" standards (Page 7 of 25) when those standards appear to be concerned with classroom instruction?

ANSWER TO QUESTION #8:

Proposers do not need to certify compliance with any Shared Learning Collaborative standards at this time. However, the use of open standards for file formats, data sharing, application integration, or connectivity will all be viewed as beneficial and should be highlighted in RFP responses.

➤ **QUESTION #9:**

Starting on Page 10 of 25 in the Cost of Goods & Services section, there is a reference to a "phased-timeline for a purchased investment." Can you describe what is meant by this as opposed to simple unit pricing?

ANSWER TO QUESTION #9:

The intent of a phased-timeline for a purchased investment is to determine whether there is cash flow deferment opportunities associated with a phased implementation of the GPS solution. For example, the primary GPS functionality could be implemented in one fiscal year, while the student tracking system is implemented in the subsequent year with the costs associated with student tracking deferred into the next fiscal year.

➤ QUESTION #10:

The calendar on Page 3 doesn't make any reference to vendor presentations, site visits, or anything other than: the due date for proposal receipt; the evaluation meeting; and the date for award recommendation. Does the SBBC intend to have vendors demonstrate their solution at any time?

ANSWER TO QUESTION #10:

*Yes, presentations will be required. Presentations will be required for the first short listing of Proposers and the recommended Proposer shall provide a presentation/demonstration for the School Board before the contract is awarded. See **Revised** Page 3 of 25 Pages.*

➤ QUESTION #11:

Please define the words "shall" and "should" for use in this process. (See information in Question 12)

ANSWER TO QUESTION #11:

Shall – When used as an auxiliary verb, "shall", according to Webster's Online Dictionary, "denotes a requirement that is mandatory whenever the criterion for conformance with the specification requires that there be no deviation."

Should – On the other hand, "should", according to Webster's Online Dictionary, "denotes a guideline or recommendation whenever non-compliance with the specification is permissible." When used as an auxiliary verb, it expresses "a conditional or contingent act or state...or moral obligation."

➤ QUESTION #12:

Is the existing Edulog Routing System capable of accepting GPS data from other vendors to meet the following requirements:

- 16.1.6 Integration with bus stop management functions. The system should allow the import of the GPS data into the routing system in order to enhance or correct data contained in the routing system.
- 16.1.7 The system should allow the user to easily evaluate the location of any bus stop as computed by the routing system in relation to the actual location reported by the GPS system. At the user's decision, the planned data could be automatically corrected.
- 16.1.8 The system should allow the user to easily compare time at any bus stop to the time computed by the routing system. The user can then decide on any editing possible to realign the planned times to the actual GPS times, and the system could perform these corrections with minimum user data entry.

ANSWER TO QUESTION #12:

It is the intent of Broward Schools to make electronic comparisons between planned bus routes to actual GPS captured bus routes and make managerial decisions based upon the outcomes. It is also the intent of Broward Schools to find a GPS solution that has the flexibility to integrate with various school transportation routing systems. The Edulog Routing System is currently in use in the Broward Schools Transportation Department without a built-in GPS component. It is the responsibility of the Proposer to communicate with Education Logistics or any other transportation routing system vendor with which they desire to integrate their system.

➤ QUESTION #13:

Assuming the answer to Question 12 is "Yes", how will the transfer process of GPS data to Edulog Routing be documented for other vendors and when? If the answer to Question 12 is "No", are you aware that the RFP becomes a sole source purchase?

ANSWER TO QUESTION #13:

It is not the intent of Broward Schools to make this RFP a sole source purchase. It is the responsibility of the Proposer to communicate with Education Logistics or any other transportation routing system vendor with which they desire to integrate their system. It is expected that the awarded vendor will work collaboratively with Broward Schools solution providers to integrate their GPS solution without intervention by Broward Schools.

➤ QUESTION #14:

Are you interested in GPS vendors with Routing Systems offering them as part of their proposal?

ANSWER TO QUESTION #14:

It is the intent of Broward Schools to find the best short-term cost effective GPS solution which will also provide Broward Schools with a long term positive return on investment.

➤ QUESTION #15:

It appears from the following requirements that GSM cell service is preferred for this project but others such as CDMA as acceptable. Is this correct?

4. **Data Collection** – Data collected should be downloaded via cellular Global for Mobile Communications (GSM)/4G Long term Evolution (LTE) communications
7. **GPS Device** - GPS device shall capture data in four dimensions – latitude, longitude, time and odometer. Device shall have a separate IP address for data security. Device should monitor low battery. Data collected from device should be downloaded via cellular GSM/ 4G Long Term Evolution (LTE) Communication. Device must include at least a five year warranty – all parts and labor.
15. **Student Tracking System:** SBBC will integrate the GPS School Bus Tracking System with a Student Identification System to record students boarding and leaving buses. Proposer must be able to provide a developed student identification system which is seamlessly integrated into the GPS system. The system should meet the following requirements:
 - 15.1 System to include a GPS-GSM that can be integrated with a Radio Frequency Communication Device (RFID) web-based solution for student tracking;

ANSWER TO QUESTION #15:

Broward Schools is interested in maximizing the return on its investment for a GPS-based tracking system. Broward Schools believes this will be accomplished by selecting a solution that has a long lifespan. In regards to the cellular connectivity aspect of the overall solution, Broward Schools will accept Code Division Multiple Access (CDMA) technology on a par with the stated Global System Mobile (GSM) technology. However, in either case (CDMA or GSM) the proposed solution must be based on technology that retains its described functionality as the carrier migrates from either CDMA or GSM to their Long Term Evolution (LTE) architecture. This requirement is based less on concerns about bandwidth than on assuring that the solution will continue to work on the carrier's LTE platform.

➤ QUESTION #16:

The following requirement for Biometric scanning appears to be desired but not required. Is this correct? Biometrics is not the only card less Student Tracking functionality available for student Log On/OFF. Is it acceptable to offer different card less functionality?

15. **Student Tracking System:** SBBC will integrate the GPS School Bus Tracking System with a Student Identification System to record students boarding and leaving buses. Proposer must be able to provide a developed student identification system which is seamlessly integrated into the GPS system. The system should meet the following requirements:

- 15.1 System to include a GPS-GSM that can be integrated with a Radio Frequency Communication Device (RFID) web-based solution for student tracking;
- 15.5 Student tracking has the capability to include Biometric scanning. This is beneficial when a student forgets his/her ID badge.

ANSWER TO QUESTION #16:

It is the intent of Broward Schools to evaluate potential card-less student tracking alternatives. It would be acceptable to offer different alternatives.

➤ QUESTION #17:

How will the speed limit updates from the Florida Department of Transportation be made available?

- 16.1.4 GPS (mapping) must be able to be updated with road and speed limit changes as changed by Florida Department of Transportation. Speed limits must be actual and not estimated or averaged per location.

ANSWER TO QUESTION #17:

It is the responsibility of the Proposer to communicate with any other vendor/agency with which they desire to integrate their system to meet all requirements of this RFP.

➤ QUESTION #18:

The following requirement seems to require some type of communication between the dispatch office and the bus concerning alerts. Is it intended to require some type of Mobile Terminal device on each bus for this purpose? Please explain what is required.

- 6.3 Broadcast or targeted alters to buses.

ANSWER TO QUESTION #18:

Yes, but not limited to a standard MTD. However, must be compliant to County, State and Federal Guidelines.

➤ QUESTION #19:

Are Odometer and Mileage (distance traveled) interchangeable? If not, please explain what is required.

7. **GPS Device:** GPS device shall capture data in four dimensions – latitude, longitude, time and odometer. Device shall have a separate IP address for data security. Device should monitor low battery. Data collected from device should be downloaded via cellular GSM/ 4G Long Term Evolution (LTE) Communication. Device must include at least a five year warranty – all parts and labor.

ANSWER TO QUESTION #19:

Yes.

➤ QUESTION #20:

To meet the following requirement concerning integrating with ParentLink will data transfer requirements of ParentLink be made available, if so when?

8. **Automated Call A-Head Notification:** The system should provide an optional feature to support the designated routes. The GPS tracking system should have the capability to automatically notify the students' homes in real-time at a preset time interval prior to the bus arrival. Parent notification service alerts to households notifying status of their child's bus. This function should be done in a fully automated manner where no action is required from the driver or the dispatcher during the operation. The ability to set the parameters of when to make the automated call, and what message to send is set by the dispatcher or system operator, and should be able to be changed in an instant by the dispatcher or system operator without going to the bus. System must be able to integrate with the District's automated Messaging Service (ParentLink).

ANSWER TO QUESTION #20:

Broward Schools asks only that Proposers describe the ability of their systems to export data in real-time pertaining to route status based on individual students. The District recognizes that this requirement brings with it a number of system integration questions that would need to be addressed in order to implement this feature. What is being asked in the RFP is whether the proposed solution has the ability to integrate with separate communications systems via common file formats and standard data sharing protocols and methodologies. If the proposed solution cannot integrate with the District's current automated notification system (Parlant Technologies "ParentLink" system), but has the ability to provide automated alerts in the manner described in the RFP, this should be noted by the Proposer.

➤ QUESTION #21:

"The GPS System must have the capability of changing data carriers without affecting hardware." We are not aware of any solution from a GPS service provider whose hardware is capable of being completely carrier agnostic. Are you aware of this? Can you clarify the requirements?

ANSWER TO QUESTION #21:

See answer to Question 15 above.

- 2.1 The School Board of Broward County, Florida (hereinafter referred to as "SBBC") desires to receive Proposals for a Global Positioning System (GPS) and Student Tracking for Student Transportation & Fleet Services. SBBC is looking for a complete "turn-key" tracking system as described herein that will include system hardware, communication/transmission and reception equipment, software and license fees, radio tower rental fees (if applicable), barcode reading/scanning, training and support for the fleet of school buses currently in operation in the District. There is a possibility that maintenance vehicles may be added to this system for tracking purposes; the system must be able to handle the different schedules of tracking these vehicles. The GPS System must have the capability of changing data carriers without affecting hardware. All hardware, firmware and software shall be designed and provided by the Awardee allowing SBBC to have a single source for all issues related to ongoing support. Warranty shall cover all parts and labor associated with warranty repairs performed on-site. Awardee must have an adequate service and repair facility capable of maintaining the equipment as recommended by the manufacturer.

6.0 SPECIAL CONDITIONS

- 6.9 **PRODUCT SPECIFICATIONS:** It is the intent of these specifications to describe a GPS tracking system and related components in sufficient detail to secure Proposals on comparable equipment. All parts not specifically mention, which are necessary to provide a complete unit, shall be included in the Proposal and conform in strength and quality of material and workmanship to that which is usually provided to the trade in general. The unit shall be new (out of the box) and of current model under standard production by the manufacturer. The scope of these specifications is to also insure the delivery of a complete unit ready for operation. Omission of any essential detail from these specifications does not relieve the Awardee from furnishing a complete unit.
- 6.10 **SBBC INFORMATION SECURITY GUIDELINES:** It is the responsibility of the Awardee to read and adhere to the SBBC Information Security Guidelines when using any device connected to the SBBC's network. Following the conclusion of the contract term, all of SBBC's confidential information must be removed from Awardee's equipment and all access privileges must be revoked. Final payment will be withheld until the Awardee has confirmed, in writing, that all SBBC's confidential information has been purged from any and all electronic technology devices that were used during this contract and were connected to the SBBC's network.
- 6.11 **DELIVERY:** All deliveries shall be F.O.B. destination point. Delivery shall be within the normal working hours of the user, Monday through Friday, excluding state holidays and days during which the school district administration is closed.
- 6.12 **PAYMENT:** Payment will be made by SBBC after the items awarded have been received, inspected, found to comply with award specifications and free of damage or defect and properly invoiced.
- 6.13 **WARRANTY:** Awardee warrants that all goods and services furnished hereunder will conform in all respects to the terms of this RFP including any drawings, specifications or standards incorporated herein, and that they will be free from latent and patent defects in materials, workmanship and title, and will be free from such defects in design. In addition, Awardee warrants that said goods and services are suitable for, and will perform in accordance with, the purposes for which they are purchased, fabricated, manufactured and designed or for such other purposes as are expressly specified in this solicitation. SBBC may return any nonconforming or defective items to the Awardee or require correction or replacement of the item at the time the defect is discovered, all of the Awardee's risk and expense. Acceptance shall not relieve the Awardee of its responsibility.

7.0 GENERAL CONDITIONS

- 7.1 **INDEMNIFICATION:** This General Condition of the RFP is NOT subject to negotiation and any Proposal that fails to accept these conditions will be rejected as "non-responsive".
- 7.1.1 By SBBC: SBBC agrees to be fully responsible for its acts of negligence or its agents' acts of negligence when acting within the scope of their employment and agrees to be liable for any damages resulting from said negligence. Nothing herein is intended to serve as a waiver of sovereign immunity by SBBC. Nothing herein shall be construed as consent by SBBC to be sued by third parties in any matter arising out of any contract. Nothing herein shall be construed as a waiver by SBBC to any rights or limits to liability under Section 768.28, Florida Statutes.
- 7.1.2 By Awardee: Awardee agrees to indemnify, hold harmless and defend SBBC, its agents, servants and employees from any and all claims, judgments, costs and expenses including, but not limited to, reasonable attorney's fees, reasonable investigative and discovery costs, court costs and all other sums which SBBC, its agents, servants and employees may pay or become obligated to pay on account of any, all and every claim or demand, or assertion of liability, or any claim or action founded thereon, arising or alleged to have arisen out of the products, goods or services furnished by the Vendor, its agents, servants or employees; the equipment of the Awardee, its agents, servants or employees while such equipment is on premises owned or controlled by SBBC; or the negligence of Awardee or the negligence of Awardee's agents when acting within the scope of their employment, whether such claims, judgments, costs and expenses be for damages, damage to property including SBBC's property, and injury or death of any person whether employed by the Awardee, SBBC or otherwise.
- 7.2 **IRREVOCABILITY OF PROPOSAL:** A Proposal may not be withdrawn before the expiration of 90 days from the date of Proposal opening.
- 7.3 **EVALUATION COMMITTEES AND PROPOSALS:** SBBC and its Proposal Evaluation Committees evaluate and negotiate all Proposals in accordance with State Statutes 119.071 and 286.0113.
- 7.4 **INFORMATION NOT IN RFP:** No verbal or written information which is obtained other than by information in this document or Addenda to this Request for Proposal shall be binding on SBBC.
- 7.5 **PROPOSAL PUBLIC RECORD:** Proposer acknowledges that all information contained within their Proposal is part of the public domain as defined by the State of Florida Sunshine and Public Record Laws.
- 7.6 **NONCONFORMANCE TO CONTRACT CONDITIONS:** Services offered must be in compliance with RFP conditions and specifications and any resulting agreement at all times. Services not conforming to RFP conditions, specifications or time frames may be terminated at Awardee(s) expense and acquired on the open market. Any increase in cost may be charged against the Awardee(s). Any violation of these stipulations may also result in:
- 7.6.1 For a period of two years, any RFP submitted by Proposer will not be considered and will not be recommended for award.
- 7.6.2 All departments being advised not to do business with Proposer.
- 7.7 **APPLICABLE LAW:** This RFP and any agreement resulting from it shall be interpreted and construed according to the laws of the State of Florida.
- 7.8 **GOVERNING LAW:** This RFP, and any award(s) resulting from this RFP, shall be interpreted and construed in accordance with the laws of the State of Florida. Any bid protests arising from this RFP shall be subject to Section 120.57(3), Florida Statutes. Any disputes or controversies arising out of a contract awarded under this RFP shall be submitted to the jurisdiction of the state courts of the Seventeenth Judicial Circuit in and for Broward County, Florida.
- 7.9 **LEGAL REQUIREMENTS:** Federal, state, county and local laws, ordinances, rules and regulations that in any manner affect the goods or services covered herein apply. Lack of knowledge by the Proposer will in no way be a cause for relief from responsibility.
- 7.10 **ADVERTISING:** In submitting an RFP, Proposer agrees not to use the results therefrom as a part of any commercial advertising without prior written approval of SBBC.

7.0 GENERAL CONDITIONS (Continued)

- 7.11 **PAYMENT:** A purchase order will be released after award by SBBC for any services to be performed as a result of the RFP. Payment will be provided after services are in compliance with all the conditions of this RFP.
- 7.12 **EXPENDITURE:** No guarantee is given or implied as to the total dollar value or work as a result of this RFP. SBBC is not obligated to place any order for services performed as a result of this award. Order placement will be based upon the needs and in the best interest of SBBC.
- 7.13 **CONFLICT OF INTEREST:** The award of this RFP is subject to the provisions of Chapter 112, Florida Statutes, as currently enacted or as amended from time to time. All Proposers must disclose with their Proposal the name of any officer, director or agent who is also an employee of SBBC.
- 7.14 **PATENTS AND ROYALTIES:** The Proposer, without exception, shall indemnify and save harmless SBBC and its employees from liability of any nature or kind, including cost and expenses for any copyrighted, patented, or unpatented invention, process, or article manufactured or used in the performance of the contract, including its use by SBBC. If the Proposer uses any design, device, or materials covered by letters, patent, or copyright, it is mutually understood and agreed without exception that the RFP prices shall include all royalties or cost arising from the use of such design, device or materials in any way involved in the work.
- 7.15 **DISPUTES:** In the event of a conflict between the documents, the order of priority of the documents shall be as follows:
- Any agreement resulting from the award of this RFP (if applicable); then
 - Addenda released for this RFP, with the latest Addendum taking precedence; then
 - the RFP; then
 - Awardee's Proposal.
- In case of any other doubt or difference of opinion, the decision of SBBC shall be final and binding on both parties.
- 7.16 **OSHA:** The Proposer warrants that the product supplied to SBBC shall conform in all respects to the standards set forth in the Occupational Safety and Health Act of 1970, as amended, and the failure to comply with this condition will be considered as a breach of contract.
- 7.17 **ANTI-DISCRIMINATION:** SBBC prohibits any policy or procedure which results in discrimination on the basis of age, color, disability, gender identity, gender expression, national origin, marital status, race, religion, sex or sexual orientation. Individuals who wish to file a discrimination and/or harassment complaint may call the Executive Director, Benefits & EEO Compliance at 754-321-2150 or Teletype Machine TTY 754-321-2158.
- 7.18 **LIABILITY, INSURANCE, LICENSES AND PERMITS:** The Proposer agrees to The Indemnification Provision stated herein and will assume the full duty, obligation and expense of obtaining all necessary licenses, permits and insurance. Where Awardee(s) is required to enter or go onto SBBC property to deliver materials or perform work or services, the Awardee(s) shall be liable for any damages or loss to SBBC occasioned by negligence of the Awardee(s) (or agent) or any person the Awardee(s) has designated in the completion of the contract.
- 7.19 **BILLING INSTRUCTIONS AND PAYMENT:** Invoices, unless otherwise indicated, must show purchase order numbers and shall be submitted in duplicate to the Accounts Payable Department of SBBC, 1643 N. Harrison Parkway, Building H, Sunrise, Florida 33323. Payment will be made a minimum of 30 days after delivery, authorized inspection and acceptance. When vendors are directed to send invoices to a school, the school will make direct payments to the vendor.
- 7.20 **PUBLIC ENTITY CRIMES:** Section 287.133(2)(a), Florida Statutes, as currently enacted or as amended from time to time, states that a person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a Proposal on a contract to provide any goods or services to a public entity, may not submit a Proposal on a contract with a public entity for the construction or repair of a public building or public work, may not submit a Proposal on leases of real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017 for CATEGORY TWO [currently \$25,000] for a period of 36 months from the date of being placed on the convicted vendor list.

- 7.21 **CERTIFICATION REGARDING DEBARMENT, SUSPENSION, INELIGIBILITY OR VOLUNTARY EXCLUSION - Lower Tier Covered Transactions:** Executive Order 12549, as currently enacted or as amended from time to time, provides that, to the extent permitted by law, Executive departments and agencies shall participate in a government-wide system for non-procurement debarment and suspension. A person who is debarred or suspended shall be excluded from Federal financial and non-financial assistance and benefits under Federal programs and activities. Except as provided in § 85.200, Debarment or Suspension, § 85.201, Treatment of Title IV HEA participation, and §85.215, Exception provision, debarment or suspension of a participant in a program by one agency shall have government-wide effect. A lower tier covered transaction is, in part, any transaction between a participant [SBBC] and a person other than a procurement contract for goods or services, regardless of type, under a primary covered transaction; and any procurement contract for goods or services between a participant and a person, regardless of type, expected to equal or exceed the Federal procurement small purchase threshold fixed at 10 U.S.C. 2304(g) and 41 U.S.C. 253(g) (currently \$100,000) under a primary covered transaction; or any procurement contract for goods or services between a participant and a person under a covered transaction, regardless of amount, under which that person will have a critical influence on or substantive control over that covered transaction. A participant may rely upon the certification of a prospective participant in a lower tier covered transaction that it and its principals are not debarred, suspended, proposed for debarment under 48 CFR part 9, subpart 9.4, ineligible, or voluntarily excluded from the covered transaction, unless it knows that the certification is erroneous. Each participant shall require participants in lower tier covered transactions to include the certification for it and its principals in any Proposal submitted in connection with such lower tier covered transactions.

CERTIFICATION

- 7.21.1 The prospective lower tier participant certifies, by submission of this Proposal, that neither it nor its principals is presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in this transaction by any Federal department or agency.
- 7.21.2 Where the prospective lower tier participant is unable to certify to any of the statements in this certification, such prospective participant shall attach an explanation to this Proposal.

- 7.22 **MINORITY/WOMEN BUSINESS ENTERPRISE (M/WBE) PARTICIPATION:** SBBC has a Supplier Diversity & Outreach Program whose intent is to have a diverse group of Minorities and Women Business enterprises (M/WBE) participating on SBBC contract awards. SBBC encourages each Proposer to make every reasonable effort to include M/WBE participation on any contract award under this RFP. An M/WBE is defined by SBBC as any legal entity, other than a joint venture, which is organized to engage in commercial transactions and which is at least 51% owned and controlled by minority or women. If the Proposer is a Certified M/WBE by SBBC or by the State of Florida, Office of Supplier Diversity, Department of Management, **Proposer should indicate its certification number in its Proposal.**

To receive evaluation points for M/WBE participation, the Proposal shall identify the specific certified M/WBE which will be utilized. PROTESTING OF RFP CONDITIONS/SPECIFICATIONS: Any person desiring to protest the conditions/specifications in this RFP, or any Addenda subsequently released thereto, shall file a notice of intent to protest, in writing, within 72 hours after electronic release of the competitive solicitation or Addendum and shall file a formal written protest within ten calendar days after the date the notice of protest was filed. Saturdays, Sundays, state holidays or days during which the school district administration is closed shall be excluded in the computation of the 72 hours. If the tenth calendar day falls on a Saturday, Sunday, state holiday or day during which the school district administration is closed, the formal written protest must be received on or before 5:00 p.m. ET of the next calendar day that is not a Saturday, Sunday, state holiday or day during which the school district administration is closed. Section 120.57(3)(b), Florida Statutes, as currently enacted or as amended from time to time, states that **"The formal written protest shall state with particularity the facts and law upon which the protest is based"**.

Failure to file a notice of protest or to file a formal written protest within the time prescribed by Section 120.57(3), Florida Statutes, or a failure to post the bond or other security required by Policy 3320, within the time allowed for filing a bond, shall constitute a waiver of proceedings. The failure to post the bond required by SBBC Policy 3320, Part VIII, as currently enacted or as amended from time to time, shall constitute a waiver of proceedings. Notices of protest, formal written protests, and the bonds required by Policy 3320, shall be filed at the office of the Director of Supply Management & Logistics, 7720 West Oakland Park Boulevard, Suite 323, Sunrise, Florida 33351 (fax 754-321-0936). Fax filing will not be acceptable for the filing of bonds.

POSTING OF RFP RECOMMENDATIONS/TABULATIONS: RFP Recommendations and Tabulations will be posted in the Supply Management & Logistics Department and on www.demandstar.com on **FEBRUARY 11, 2013 at 3:00 p.m. ET**, and will remain posted for 72 hours. Any change to the date and time established herein for posting of RFP Recommendations/Tabulations shall be posted in the Supply Management & Logistics Department and/or at www.demandstar.com (under the document section for this RFP). In the event the date and time of the posting of RFP Recommendations/Tabulations is changed, it is the responsibility of each Proposer to ascertain the revised date of the posting of RFP Recommendations/Tabulations. Any person desiring to protest the intended decision shall file a notice of protest, in writing, within 72 hours after the posting of the RFP tabulation and shall file a formal written protest within ten calendar days after the date the notice of protest was filed. Saturdays, Sundays, state holidays and days during which the school district administration is closed shall be excluded in the computation of the 72 hours. If the tenth calendar day falls on a Saturday, Sunday, state holiday or day during which the school district administration is closed, the formal written protest must be received on or before 5:00 p.m. ET of the next calendar day that is not a Saturday or Sunday, state holiday or days during which the school district administration is closed. No submissions made after the Proposal opening amending or supplementing the Proposal shall be considered. Fax filing will not be acceptable for the filing of bonds.

- 7.25 **USE OF OTHER CONTRACTS:** SBBC reserves the right to utilize any other SBBC contract, any State of Florida Contract, any contract awarded by any other city or county governmental agencies, other school boards, other community college/state university system cooperative agreements, or to directly negotiate/purchase per SBBC policy and/or State Board Rule 6A-1.012, as currently enacted or as amended from time to time, in lieu of any offer received or award made as a result of this RFP if it is in its best interest to do so.
- 7.26 **ASSIGNMENT:** Neither any award of this RFP nor any interest in any award of this RFP may be assigned, transferred or encumbered by any party without the prior written consent of the Director, Supply Management & Logistics Department. There shall be no partial assignments of this RFP including, without limitation, the partial assignment of any right to receive payments from SBBC.
- 7.27 **CANCELLATION:** In the event any of the provisions of this RFP are violated by the Awardee, the Superintendent shall give written notice to the Awardee stating the deficiencies and unless deficiencies are corrected within five days, recommendation will be made to SBBC for immediate cancellation.
- 7.28 **REASONABLE ACCOMMODATION:** Individuals with disabilities requesting accommodations under the Americans with Disabilities Act (ADA) may call Equal Educational Opportunities (EEO) at 754-321-2150 or Teletype Machine 754-321-2158.
- 7.29 **CONE OF SILENCE:** Any vendor or lobbyist for a vendor is prohibited from having any communications concerning this solicitation for a competitive procurement with any School Board Member or the Superintendent of Schools, after the Supply Management & Logistics Department releases the solicitation to the general public. This "Cone of Silence" shall go into effect and shall remain in effect from the time of release of the solicitation until the contract is awarded by SBBC. All communications regarding this solicitation shall be directed to the designated Purchasing Agent unless so notified by the Supply Management & Logistics Department. Background Screening: Awardee agrees to comply with all the requirements of Sections 1012.32 and 1012.465, Florida Statutes, and that Awardee and all its personnel who (1) are to be permitted access to school grounds when students are present, (2) will have direct contact with students, or (3) have access or control of school funds will successfully complete the background screening required by the referenced statutes and meet the standards established by the statutes. **Personnel shall include employees, representatives, agents or sub-contractors performing duties under the contract to SBBC and who meet any or all of the three requirements identified above.** This background screening will be conducted by SBBC in advance of Awardee or its personnel providing any services. Awardee will bear the cost of acquiring the background screening required under Section 1012.32, Florida Statutes, and any fee imposed by the Florida Department of Law Enforcement to maintain the fingerprints provided with respect to Awardee and its personnel. The Parties agree that the failure of Awardee to perform any of the duties described in this section shall constitute a material breach of this RFP/BID entitling SBBC to terminate immediately with no further responsibilities or duties to perform under this Agreement. Awardee agrees to indemnify and hold harmless SBBC, its officers and employees of any liability in the form of physical or mental injury, death or property damage resulting in Awardee's failure to comply with the requirements of this section or Sections 1012.32 and 1012.465, Florida Statutes.

SBBC issued identification badges must be worn at all times when on SBBC property and must be worn where they are visible and easily readable.

L-1 Enrollment Services has been contracted to provide all background and fingerprinting services. All questions pertaining to fingerprinting, photo identification and background check services must be directed to the EasyPath Project Coordinator at 754-321-1830 or easypathinfo@L1ID.com. **Each individual, for whom a SBBC photo identification badge is requested, must fill out the forms that are required, provide his/her driver's license and social security card, and must be fingerprinted.** A background check will be conducted for each badge applicant. SBBC reserves the right to require additional information, should it be necessary, and to deny the issuance of a badge to an applicant. Any applicant, that has been denied a badge, is prohibited from entering SBBC property as an employee, sub-contractor or agent of a contract Awardee. There will be two websites used for services: 1) <http://www.L1Enrollment.com> (used for scheduling and registering applicants) and 2) <http://sbcc-easypath.browardschools.com> (used for vendors to check the status of applicants and order replacement badges). The total fee for the SBBC photo identification badge, fingerprinting and a FBI background check can be found at the following website: www.L1Enrollment.com. Payment options can be made by electronic check (e-check), Visa, MasterCard or use of an established escrow account code. **These fees are non-refundable and are subject to change without notice. Badges are issued for a one-year period and must be renewed annually. The renewal date will be one year from date of issuance. Failure to renew the badge, at that time, will result in the vendor being required to re-apply and pay the going rate for badging and fingerprinting.**

- 7.31 **GRATUITIES:** Proposers shall not offer any gratuities, favors, or anything of monetary value to any official, employee, or agent of SBBC; including any School Board Member, Superintendent of Schools and any Evaluation Committee Members, for the purpose of influencing consideration of this Proposal.
- 7.32 **LOBBYIST ACTIVITIES:** In accordance with SBBC Policy 1100B, as currently enacted or as amended from time to time, persons acting as lobbyists must state, at the beginning of their presentation, letter, telephone call, e-mail or facsimile transmission to School Board Members, Superintendent or Members of Senior Management, the group, association, organization or business interest she/he is representing.
- 7.32.1 A lobbyist is defined as a person who, for immediate or subsequent compensation (e.g., monetary profit/personal gain), represents a public or private group, association, organization or business interest and engages in efforts to influence School Board Members on matters within their official jurisdiction.
- 7.32.2 A lobbyist is not considered to be a person representing school allied groups (e.g., PTA, DAC, Band Booster Associations, etc.) nor a public official acting in her/his official capacity.
- 7.32.3 Lobbyists shall annually (July 1) disclose in each instance and for each client prior to any lobbying activities, their identity and activities by completing the lobbyist statement form which can be obtained from official School Board Records, School Board Member's Offices or the Superintendent's Office and will be recorded on SBBC's website, www.browardschools.com.
- 7.32.4 The lobbyist must disclose any direct business association with any current elected or appointed official or employee of SBBC or any immediate family member of such elected or appointed official or employee of SBBC.
- 7.32.5 Senior-level employees (Pay Grade 30 and above) and/or School Board Members are prohibited from lobbying activities for one year after resignation or retirement or expiration of their term of office.
- 7.32.6 The Deputy to the Superintendent shall keep a current list of persons who have submitted the lobbyist statement form.
- 7.33 **PREPARATION COST OF PROPOSAL:** Proposer is solely responsible for any and all costs associated with responding to this RFP. SBBC will not reimburse any Proposer for any costs associated with the preparation and submittal of any Proposal, or for any travel and per diem costs that are incurred by any Proposer.
- 7.34 **WITHDRAWAL OF RFP:** In the best interest of SBBC, SBBC reserves the right to withdraw this RFP at any time prior to the time and date specified for the Proposal opening.
- 7.35 **SEVERABILITY** In case of any one or more of the provisions contained in this RFP shall be for any reason be held to be invalid, illegal, unlawful, unenforceable or void in any respect, the invalidity, illegality, unenforceability or unlawful or void nature of that provision shall not affect any other provision and this shall be considered as if such invalid, unlawful, unenforceable or void provision had never been included herein.
- 7.36 It is the sole responsibility of the **Proposer** to assure it has received the entire Proposal and any and all Addendum.
- 7.37 It is the sole responsibility of the **Proposer** to assure that its Proposal is time stamped in the **SUPPLY MANAGEMENT & LOGISTICS DEPARTMENT on or before 2:00 p.m. ET** on the date due.
- 7.38 No verbal or written information which is obtained other than by information in this document or by Addenda to this RFP shall be binding on SBBC.
- 7.39 No submissions made after the Proposal opening, amending or supplementing the Proposal, shall be considered.

7.40 ACCEPTANCE AND REJECTION OF PROPOSALS:

- 7.40.1 **Acceptance:** All Proposals properly completed and submitted will be evaluated in accordance with Section 5.1. SBBC reserves the right to reject any or all Proposals that contain material deviations from the RFP or that fail to meet all mandatory requirements. SBBC may reject any or all Proposals when it serves the best interest of SBBC.
- 7.40.2 SBBC also reserves the right to waive irregularities or technicalities in any Proposal received if such action is in the best interest of SBBC. However, such a waiver shall in no way modify the RFP requirements or excuse the Proposer from full compliance with the RFP specifications and other contract requirements if the Proposer is awarded the contract.
- 7.40.3 **Rejection:** A Proposal may be rejected if it does not conform to the rules or the requirements contained in this RFP. Examples for rejection include, but are not limited to, the following:
- 7.40.3.1 The Proposal is time-stamped at the Supply Management & Logistics Department after the deadline specified in the RFP.

- 7.42 **TERMINATION:** This RFP may be terminated with or without cause by SBBC during the term hereof upon thirty (30) days written notice to the other parties of its desire to terminate this RFP. In the event of such termination, SBBC shall not be obligated to pay for any services beyond the effective date of termination.
- 7.43 **PRICE REDUCTIONS:** If, from date of Proposal opening, the Awardee either bids the same products and/or services at a lower price than offered to SBBC or reduces the price of the proposed product or service, the lowest of these reduced prices will be extended to SBBC. The price reduction shall be effective as of the date the reduced price was offered to another company.
- 7.44 **DISTRIBUTION:** DemandStar by Onvia, www.demandstar.com, is the official method approved by the Supply Management Department for the distribution of all competitive solicitations including ITBs and RFPs. It is the responsibility of all interested parties to assure they have received all necessary documents, including Addenda and have included all necessary information within their response. SBBC is not responsible for Proposer's failure to obtain complete bidding documents from DemandStar. SBBC reserves the right to reject any Proposal as non-responsive for failure to include all necessary documents or required Addenda. For information regarding the above-referenced solicitation, contact the designated Purchasing Agent as stated herein.
- 7.45 **PURCHASE BY OTHER PUBLIC AGENCIES:** With the consent and agreement of the Awardee(s), purchases may be made under this RFP by other agencies. Such purchases shall be governed by the same terms and conditions as stated herein.
- 7.46 **SBBC INFORMATION SECURITY GUIDELINES:** It is the responsibility of the vendor to read and adhere to the SBBC Information Security Guidelines when using any device connected to the SBBC's network. The confidential information cannot be disclosed unless valid consent is obtained from the District's students or their legal guardians. Both parties agree to protect these records in compliance with FERPA, HIPAA, and the District's policy. To the extent permitted by law, nothing contained herein shall be construed as precluding either party from releasing such information to the other so that each can perform its respective responsibilities.

Vendor agrees that it may create, receive from or on behalf of the District, or have access to, records or record systems that are subject to FERPA and/or HIPAA (collectively, the "Confidential Records"). Vendor represents, warrants, and agrees that it will: (1) hold the Confidential Records in strict confidence and will not use or disclose the Confidential Records except as (a) permitted or required by this Agreement, (b) required by law, or (c) otherwise authorized by the District in writing; (2) safeguard the Confidential Records according to commercially reasonable administrative, physical and technical standards as required by law; and (3) continually monitor its operations and take any and all action necessary to assure that the Confidential Records are safeguarded in accordance with the terms of this Agreement. General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

Purpose of Form

A person who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) to report, for example, income paid to you, real estate transactions, mortgage interest paid, acquisition or abandonment of secured property, cancellation of debt, or contributions you made to an IRA.

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN to the person requesting it (the requester) and, when applicable, to:

1. Certify that the TIN you are giving is correct (or you are waiting for a number to be issued),
2. Certify that you are not subject to backup withholding, or
3. Claim exemption from backup withholding if you are a U.S. exempt payee. If applicable, you are also certifying that as a U.S. person, your allocable share of any partnership income from a U.S. trade or business is not subject to the withholding tax on foreign partners' share of effectively connected income.

Note. If a requester gives you a form other than Form W-9 to request your TIN, you must use the requester's form if it is substantially similar to this Form W-9.

Definition of a U.S. person. For federal tax purposes, you are considered a U.S. person if you are:

- An individual who is a U.S. citizen or U.S. resident alien,
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States,
- An estate (other than a foreign estate), or
- A domestic trust (as defined in Regulations section 301.7701-7).

Special rules for partnerships. Partnerships that conduct a trade or business in the United States are generally required to pay a withholding tax on any foreign partners' share of income from such business. Further, in certain cases where a Form W-9 has not been received, a partnership is required to presume that a partner is a foreign person, and pay the withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership conducting a trade or business in the United States, provide Form W-9 to the partnership to establish your U.S. status and avoid withholding on your share of partnership income.

The person who gives Form W-9 to the partnership for purposes of establishing its U.S. status and avoiding withholding on its allocable share of net income from the partnership conducting a trade or business in the United States is in the following cases:

- The U.S. owner of a disregarded entity and not the entity,
- The U.S. grantor or other owner of a grantor trust and not the trust, and
- The U.S. trust (other than a grantor trust) and not the beneficiaries of the trust.

Foreign person. If you are a foreign person, do not use Form W-9. Instead, use the appropriate Form W-8 (see Publication 515, Withholding of Tax on Nonresident Aliens and Foreign Entities).

Nonresident alien who becomes a resident alien. Generally, only a nonresident alien individual may use the terms of a tax treaty to reduce or eliminate U.S. tax on certain types of income. However, most tax treaties contain a provision known as a "saving clause." Exceptions specified in the saving clause may permit an exemption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

If you are a U.S. resident alien who is relying on an exception contained in the saving clause of a tax treaty to claim an exemption from U.S. tax on certain types of income, you must attach a statement to Form W-9 that specifies the following five items:

1. The treaty country. Generally, this must be the same treaty under which you claimed exemption from tax as a nonresident alien.
2. The treaty article addressing the income.
3. The article number (or location) in the tax treaty that contains the saving clause and its exceptions.
4. The type and amount of income that qualifies for the exemption from tax.
5. Sufficient facts to justify the exemption from tax under the terms of the treaty article.

Example. Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if his or her stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first protocol) and is relying on this exception to claim an exemption from tax on his or her scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity not subject to backup withholding, give the requester the appropriate completed Form W-8.

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS a percentage of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

Payments you receive will be subject to backup withholding if:

1. You do not furnish your TIN to the requester.
2. You do not certify your TIN when required (see the Part II instructions on page 3 for details).
3. The IRS tells the requester that you furnished an incorrect TIN.
4. The IRS tells you that you are subject to backup withholding because you did not report all your interest and dividends on your tax return (for reportable interest and dividends only), or
5. You do not certify to the requester that you are not subject to backup withholding under 4 above (for reportable interest and dividend accounts opened after 1983 only).

Certain payees and payments are exempt from backup withholding. See the instructions below and the separate Instructions for the Requester of Form W-9.

Also see *Special rules for partnerships* on page 1.

Updating Your Information

You must provide updated information to any person to whom you claimed to be an exempt payee if you are no longer an exempt payee and anticipate receiving reportable payments in the future from this person. For example, you may need to provide updated information if you are a C corporation that elects to be an S corporation, or if you no longer are tax exempt. In addition, you must furnish a new Form W-9 if the name or TIN changes for the account, for example, if the grantor of a grantor trust dies.

Penalties

Failure to furnish TIN. If you fail to furnish your correct TIN to a requester, you are subject to a penalty of \$50 for each such failure unless your failure is due to reasonable cause and not to willful neglect.

Civil penalty for false information with respect to withholding. If you make a false statement with no reasonable basis that results in no backup withholding, you are subject to a \$500 penalty.

Criminal penalty for falsifying information. Willfully falsifying certifications or affirmations may subject you to criminal penalties including fines and/or imprisonment.

Misuse of TINs. If the requester discloses or uses TINs in violation of federal law, the requester may be subject to civil and criminal penalties.

Specific Instructions

Name

If you are an individual, you must generally enter the name shown on your income tax return. However, if you have changed your last name, for instance, due to marriage without informing the Social Security Administration of the name change, enter your first name, the last name shown on your social security card, and your new last name.

If the account is in joint names, list first, and then circle, the name of the person or entity whose number you entered in Part I of the form.

Sole proprietor. Enter your individual name as shown on your income tax return on the "Name" line. You may enter your business, trade, or "doing business as (DBA)" name on the "Business name/disregarded entity name" line.

Partnership, C Corporation, or S Corporation. Enter the entity's name on the "Name" line and any business, trade, or "doing business as (DBA)" name on the "Business name/disregarded entity name" line.

Disregarded entity. Enter the owner's name on the "Name" line. The name of the entity entered on the "Name" line should never be a disregarded entity. The name on the "Name" line must be the name shown on the income tax return on which the income will be reported. For example, if a foreign LLC that is treated as a disregarded entity for U.S. federal tax purposes has a domestic owner, the domestic owner's name is required to be provided on the "Name" line. If the direct owner of the entity is also a disregarded entity, enter the first owner that is not disregarded for federal tax purposes. Enter the disregarded entity's name on the "Business name/disregarded entity name" line. If the owner of the disregarded entity is a foreign person, you must complete an appropriate Form W-8.

Note. Check the appropriate box for the federal tax classification of the person whose name is entered on the "Name" line (individual/sole proprietor, Partnership, C Corporation, S Corporation, Trust/estate).

Limited Liability Company (LLC). If the person identified on the "Name" line is an LLC, check the "Limited liability company" box only and enter the appropriate code for the tax classification in the space provided. If you are an LLC that is treated as a partnership for federal tax purposes, enter "P" for partnership. If you are an LLC that has filed a Form 8832 or a Form 2553 to be taxed as a corporation, enter "C" for C corporation or "S" for S corporation. If you are an LLC that is disregarded as an entity separate from its owner under Regulation section 301.7701-5 (except for employment and excise tax), do not check the LLC box unless the owner of the LLC (required to be identified on the "Name" line) is another LLC that is not disregarded for federal tax purposes. If the LLC is disregarded as an entity separate from its owner, enter the appropriate tax classification of the owner identified on the "Name" line.

Other entities. Enter your business name as shown on required federal tax documents on the "Name" line. This name should match the name shown on the charter or other legal document creating the entity. You may enter any business, trade, or DBA name on the "Business name/disregarded entity name" line.

Exempt Payee

If you are exempt from backup withholding, enter your name as described above and check the appropriate box for your status, then check the "Exempt payee" box in the line following the "Business name/disregarded entity name" sign and date the form.

Generally, individuals (including sole proprietors) are not exempt from backup withholding. Corporations are exempt from backup withholding for certain payments, such as interest and dividends.

Note. If you are exempt from backup withholding, you should still complete this form to avoid possible erroneous backup withholding.

The following payees are exempt from backup withholding:

1. An organization exempt from tax under section 501(c)(3), any IRA, or a custodial account under section 403(b)(7) if the account satisfies the requirements of section 401(f)(2).
 2. The United States or any of its agencies or instrumentalities.
 3. A state, the District of Columbia, a possession of the United States, or any of their political subdivisions or instrumentalities.
 4. A foreign government or any of its political subdivisions, agencies, or instrumentalities, or
 5. An international organization or any of its agencies or instrumentalities.
- Other payees that may be exempt from backup withholding include:
6. A corporation.
 7. A foreign central bank of issue.
 8. A dealer in securities or commodities required to register in the United States, the District of Columbia, or a possession of the United States.
 9. A futures commission merchant registered with the Commodity Futures Trading Commission.
 10. A real estate investment trust.
 11. An entity registered at all times during the tax year under the Investment Company Act of 1940.
 12. A common trust fund operated by a bank under section 584(a).
 13. A financial institution.
 14. A middleman known in the investment community as a nominee or custodian, or
 15. A trust exempt from tax under section 664 or described in section 4947.

The following chart shows types of payments that may be exempt from backup withholding. The chart applies to the exempt payees listed above, 1 through 15.

Interest and dividend payments	All exempt payees except for 9

² However, the following payments made to a corporation and reportable on Form 1099-MISC are not exempt from backup withholding: medical and health care payments, attorneys' fees, gross proceeds paid to an attorney, and payments for services paid by a federal executive agency.

Part I. Taxpayer Identification Number (TIN)

Enter your TIN in the appropriate box. If you are a resident alien and you do not have and are not eligible to get an SSN, your TIN is your IRS individual taxpayer identification number (ITIN). Enter it in the social security number box. If you do not have an ITIN, see *How to get a TIN* below.

If you are a sole proprietor and you have an EIN, you may enter either your SSN or EIN. However, the IRS prefers that you use your SSN.

If you are a single-member LLC that is disregarded as an entity separate from its owner (see *Limited Liability Company (LLC)* on page 2), enter the owner's SSN (or EIN, if the owner has one). Do not enter the disregarded entity's EIN. If the LLC is classified as a corporation or partnership, enter the entity's EIN.

Note. See the chart on page 4 for further clarification of name and TIN combinations.

How to get a TIN. If you do not have a TIN, apply for one immediately. To apply for an SSN, get Form SS-5, Application for a Social Security Card, from your local Social Security Administration office or get this form online at www.ssa.gov. You may also get this form by calling 1-800-772-1213. Use Form W-7, Application for IRS Individual Taxpayer Identification Number, to apply for an ITIN, or Form SS-4, Application for Employer Identification Number, to apply for an EIN. You can apply for an EIN online by accessing the IRS website at www.irs.gov/businesses and clicking on Employer Identification Number (EIN) under Starting a Business. You can get Forms W-7 and SS-4 from the IRS by visiting IRS.gov or by calling 1-800-TAX-FORM (1-800-829-3878).

If you are asked to complete Form W-9 but do not have a TIN, write "Applied For" in the space for the TIN, sign and date the form, and give it to the requester. For interest and dividend payments, and certain payments made with respect to readily tradable instruments, generally you will have 60 days to get a TIN and give it to the requester before you are subject to backup withholding on payments. The 60-day rule does not apply to other types of payments. You will be subject to backup withholding on all such payments until you provide your TIN to the requester.

Note. Entering "Applied For" means that you have already applied for a TIN or that you intend to apply for one soon.

Caution: A disregarded domestic entity that has a foreign owner must use the appropriate Form W-8.

Part II. Certification

To establish to the withholding agent that you are a U.S. person, or resident alien, sign Form W-9. You may be requested to sign by the withholding agent even if item 1, below, and items 4 and 5 on page 4 indicate otherwise.

For a joint account, only the person whose TIN is shown in Part I should sign (when required). In the case of a disregarded entity, the person identified on the "Name" line must sign. Exempt payees, see *Exempt Payee* on page 3.

Signature requirements. Complete the certification as indicated in items 1 through 3, below, and items 4 and 5 on page 4.

1. Interest, dividend, and barter exchange accounts opened before 1984 and broker accounts considered active during 1983. You must give your correct TIN, but you do not have to sign the certification.

2. Interest, dividend, broker, and barter exchange accounts opened after 1983 and broker accounts considered inactive during 1983. You must sign the certification or backup withholding will apply. If you are subject to backup withholding and you are merely providing your correct TIN to the requester, you must cross out item 2 in the certification before signing the form.

3. Real estate transactions. You must sign the certification. You may cross out item 2 of the certification.

4. Other payments. You must give your correct TIN, but you do not have to sign the certification unless you have been notified that you have previously given an incorrect TIN. "Other payments" include payments made in the course of the requester's trade or business for rents, royalties, goods (other than bills for merchandise), medical and health care services (including payments to corporations), payments to a nonemployee for services, payments to certain fishing boat crew members and fishermen, and gross proceeds paid to attorneys (including payments to corporations).

5. Mortgage interest paid by you, acquisition or abandonment of secured property, cancellation of debt, qualified tuition program payments (under section 529), IRA, Coverdell ESA, Archer MSA or HSA contributions or distributions, and pension distributions. You must give your correct TIN, but you do not have to sign the certification.

Secure Your Tax Records from Identity Theft

Identity theft occurs when someone uses your personal information such as your name, social security number (SSN), or other identifying information, without your permission, to commit fraud or other crimes. An identity thief may use your SSN to get a job or may file a tax return using your SSN to receive a refund.

To reduce your risk:

- Protect your SSN.
- Ensure your employer is protecting your SSN, and
- Be careful when choosing a tax preparer.

If your tax records are affected by identity theft and you receive a notice from the IRS, respond right away to the name and phone number printed on the IRS notice or letter.

If your tax records are not currently affected by identity theft but you think you are at risk due to a lost or stolen purse or wallet, questionable credit card activity or credit report, contact the IRS Identity Theft Hotline at 1-800-908-4490 or submit Form 14039.

Victims of identity theft who are experiencing economic harm or a system problem, or are seeking help in resolving tax problems that have not been resolved through normal channels, may be eligible for Taxpayer Advocate Service (TAS) assistance. You can reach TAS by calling the TAS toll-free case intake line at 1-877-777-4778 or TTY/TDD 1-800-829-4059.

Protect yourself from suspicious emails or phishing schemes.

Phishing is the creation and use of email and websites designed to mimic legitimate business emails and websites. The most common act is sending an email to a user falsely claiming to be an established legitimate enterprise in an attempt to scam the user into surrendering private information that will be used for identity theft.

The IRS does not initiate contacts with taxpayers via emails. Also, the IRS does not request personal detailed information through email or ask taxpayers for the PIN numbers, passwords, or similar secret access information for their credit card, bank, or other financial accounts.

If you receive an unsolicited email claiming to be from the IRS, forward this message to phishing@irs.gov. You may also report misuse of the IRS name, logo, or other IRS property to the Treasury Inspector General for Tax Administration at 1-800-368-4484. You can forward suspicious emails to the Federal Trade Commission at spam@ftc.gov or contact them at www.ftc.gov/idtheft or 1-877-IDTHEFT (1-877-438-4338).

Visit IRS.gov to learn more about identity theft and how to reduce your risk.

Privacy Act Notice

Section 6109 of the Internal Revenue Code requires you to provide your correct TIN to persons (including federal agencies) who are required to file information returns with the IRS to report interest, dividends, or certain other income paid to you; mortgage interest you paid; the acquisition or abandonment of secured property; the cancellation of debt; or contributions you made to an IRA, Archer MSA, or HSA. The person collecting this form uses the information on the form to file information returns with the IRS, reporting the above information. Routine uses of this information include giving it to the Department of Justice for civil and criminal litigation and to cities, states, the District of Columbia, and U.S. possessions for use in administering their laws. For the purposes of this Agreement, the term "*Insert Name's* Records" shall include, without limitation, accounting records, payroll time sheets, cancelled payroll checks, W-2 forms, written policies and procedures, computer records, disks and software, videos, photographs, executed subcontracts, subcontract files (including proposals of successful and unsuccessful bidders), original estimates, estimating worksheets, correspondence, change order files (including sufficient supporting documentation and documentation covering negotiated settlements), and any other supporting documents that would substantiate, reconcile or refute any charges and/or expenditures related to this Agreement.

(b) Duration of Right to Inspect. For the purpose of such audits, inspections, examinations, evaluations and/or reproductions, SBBC's agent or authorized representative shall have access to *Insert Name's* Records from the effective date of this Agreement, for the duration of the term of this Agreement, and until the later of five (5) years after the termination of this Agreement or five (5) years after the date of final payment by SBBC to *Insert Name* pursuant to this Agreement.

(c) Notice of Inspection. SBBC's agent or its authorized representative shall provide *Insert Name* reasonable advance notice (not to exceed two (2) weeks) of any intended audit, inspection, examination, evaluation and or reproduction.

(d) Audit Site Conditions. SBBC's agent or its authorized representative shall have access to *Insert Name's* facilities and to any and all records related to this Agreement, and shall be provided adequate and appropriate work space in order to exercise the rights permitted under this section.

(e) Failure to Permit Inspection. 3.01 **No Waiver of Sovereign Immunity.** Nothing herein is intended to serve as a waiver of sovereign immunity by any agency or political subdivision to which sovereign immunity may be applicable or of any rights or limits to liability existing under Section 768.28, Florida Statutes. This section shall survive the termination of all performance or obligations under this Agreement and shall be fully binding until such time as any proceeding brought on account of this Agreement is barred by any applicable statute of limitations.

3.02 **No Third Party Beneficiaries.** The parties expressly acknowledge that it is not their intent to create or confer any rights or obligations in or upon any third person or entity under this Agreement. None of the parties intend to directly or substantially benefit a third party by this Agreement. The parties agree that there are no third party beneficiaries to this Agreement and that no third party shall be entitled to assert a claim against any of the parties based upon this Agreement. Nothing herein shall be construed as consent by an agency or political subdivision of the State of Florida to be sued by third parties in any matter arising out of any contract.

3.03 **Independent Contractor.** The parties to this agreement shall at all times be acting in the capacity of independent contractors and not as an officer, employee or agent of one another. Neither party or its respective agents, employees, subcontractors or assignees shall represent to others that it has the authority to bind the other party unless specifically authorized in writing to do so. No right to SBBC retirement, leave benefits or any other benefits of SBBC employees shall exist as a result of the performance of any duties or responsibilities under this Agreement. SBBC shall not be responsible for social security, withholding taxes, contributions to unemployment compensation funds or insurance for the other party or the other party's officers, employees, agents, subcontractors or assignees.

3.04 **Equal Opportunity Provision.** The parties agree that no person shall be subjected to discrimination because of age, race, color, disability, gender identity, gender expression marital status, national origin, religion, sex or sexual orientation in the performance of the parties' respective duties, responsibilities and obligations under this Agreement.

3.05 **Termination.** This Agreement may be canceled with or without cause by SBBC during the term hereof upon thirty (30) days written notice to the other parties of its desire to terminate this Agreement. In the event of such termination, SBBC shall pay the other party for all services rendered through the effective date of termination.

3.06 **Default.** The parties agree that, in the event that either party is in default of its obligations under this Agreement, the non-defaulting party shall provide to the defaulting party (30) days written notice to cure the default. However, in the event said default cannot be cured within said thirty (30) day period and the defaulting party is diligently attempting in good faith to cure same, the time period shall be reasonably extended to allow the defaulting party additional cure time. Upon the occurrence of a default that is not cured during the applicable cure period, this Agreement may be terminated by the non-defaulting party upon thirty (30) days notice. This remedy is not intended to be exclusive of any other remedy, and each and every such remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statute or otherwise. No single or partial exercise by any party of any right, power, or remedy hereunder shall preclude any other or future exercise thereof. Nothing in this section shall be construed to preclude termination for convenience pursuant to Section 3.05.

3.07 **Annual Appropriation.** The performance and obligations of SBBC under this Agreement shall be contingent upon an annual budgetary appropriation by its governing body. If SBBC does not allocate funds for the payment of services or products to be provided under this Agreement, this Agreement may be terminated by SBBC at the end of the period for which funds have been allocated. SBBC shall notify the other party at the earliest possible time before such termination. No penalty shall accrue to SBBC in the event this provision is exercised, and SBBC shall not be obligated or liable for any future payments due or any damages as a result of termination under this section.

3.08 **Excess Funds.** Any party receiving funds paid by SBBC under this Agreement agrees to promptly notify SBBC of any funds erroneously received from SBBC upon the discovery of such erroneous payment or overpayment. Any such excess funds shall be refunded to SBBC with interest calculated from the date of the erroneous payment or overpayment. Interest shall be calculated using the interest rate for judgments under Section 55.03, Florida Statutes, applicable at the time the erroneous payment or overpayment was made by SBBC.

3.09 **Public Records.** Each party shall maintain its own respective records and documents associated with this Agreement in accordance with the records retention requirements applicable to public records. Each party shall be responsible for compliance with any public documents request served upon it pursuant to Section 119.07, Florida Statutes, and any resultant award of attorney's fees for non-compliance with that law.

3.10 **Student Records:** Notwithstanding any provision to the contrary within this Agreement, any party contracting with SBBC under this Agreement shall fully comply with the requirements of Section 1002.22, Florida Statutes, or any other state or federal law or regulation regarding the confidentiality of student information and records. Each such party agrees, for itself, its officers, employees, agents, representatives, contractors or subcontractors, to fully indemnify and hold harmless SBBC and its officers and employees for any violation of this section, including, without limitation, defending SBBC and its officers and employees against any complaint, administrative or judicial proceeding, payment of any penalty imposed upon SBBC, or payment of any and all costs, damages, judgments or losses incurred by or imposed upon SBBC arising out of a breach of this covenant by the party, or an officer, employee, agent, representative, contractor, or sub-contractor of the party to the extent that the party or an officer, employee, agent, representative, contractor, or sub-contractor of the party shall either intentionally or negligently violate the provisions of this section or of Section 1002.22, Florida Statutes. This section shall survive the termination of all performance or obligations under this Agreement and shall be fully binding until such time as any proceeding brought on account of this Agreement is barred by any applicable statute of limitations.

3.11 **Compliance with Laws.** Each party shall comply with all applicable federal and state laws, codes, rules and regulations in performing its duties, responsibilities and obligations pursuant to this Agreement.

3.12 **Place of Performance.** All obligations of SBBC under the terms of this Agreement are reasonably susceptible of being performed in Broward County, Florida and shall be payable and performable in Broward County, Florida.

3.13 **Governing Law and Venue.** This Agreement shall be interpreted and construed in accordance with and governed by the laws of the State of Florida. Any controversies or legal problems arising out of this Agreement and any action involving the enforcement or interpretation of any rights hereunder shall be submitted to the jurisdiction of the State courts of the Seventeenth Judicial Circuit of Broward County, Florida.

3.14 **Entirety of Agreement.** This document incorporates and includes all prior negotiations, correspondence, conversations, agreements and understandings applicable to the matters contained herein and the parties agree that there are no commitments, agreements or understandings concerning the subject matter of this Agreement that are not contained in this document. Accordingly, the parties agree that no deviation from the terms hereof shall be predicated upon any prior representations or agreements, whether oral or written.

3.15 **Binding Effect.** This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.

3.16 **Assignment.** Neither this Agreement or any interest herein may be assigned, transferred or encumbered by any party without the prior written consent of the other party. There shall be no partial assignments of this Agreement including, without limitation, the partial assignment of any right to receive payments from SBBC.

3.17 **Incorporation by Reference.** Exhibits attached hereto and referenced herein shall be deemed to be incorporated into this Agreement by reference.

3.18 **Captions.** The captions, section designations, section numbers, article numbers, titles and headings appearing in this Agreement are inserted only as a matter of convenience, have no substantive meaning, and in no way define, limit, construe or describe the scope or intent of such articles or sections of this Agreement, nor in any way effect this Agreement and shall not be construed to create a conflict with the provisions of this Agreement.

3.19 **Severability.** In the event that any one or more of the sections, paragraphs, sentences, clauses or provisions contained in this Agreement is held by a court of competent jurisdiction to be invalid, illegal, unlawful, unenforceable or void in any respect, such shall not affect the remaining portions of this Agreement and the same shall remain in full force and effect as if such invalid, illegal, unlawful, unenforceable or void sections, paragraphs, sentences, clauses or provisions had never been included herein.

3.20 **Preparation of Agreement.** The parties acknowledge that they have sought and obtained whatever competent advice and counsel as was necessary for them to form a full and complete understanding of all rights and obligations herein and that the preparation of this Agreement has been their joint effort. The language agreed to herein expresses their mutual intent and the resulting document shall not, solely as a matter of judicial construction, be construed more severely against one of the parties than the other.

3.21 **Amendments.** No modification, amendment, or alteration in the terms or conditions contained herein shall be effective unless contained in a written document prepared with the same or similar formality as this Agreement and executed by each party hereto.

3.22 **Waiver.** The parties agree that each requirement, duty and obligation set forth herein is substantial and important to the formation of this Agreement and, therefore, is a material term hereof. Any party's failure to enforce any provision of this Agreement shall not be deemed a waiver of such provision or modification of this Agreement unless the waiver is in writing and signed by the party waiving such provision. A written waiver shall only be effective as to the specific instance for which it is obtained and shall not be deemed a continuing or future waiver.

3.23 **Force Majeure.** Neither party shall be obligated to perform any duty, requirement or obligation under this Agreement if such performance is prevented by fire, hurricane, earthquake, explosion, wars, sabotage, accident, flood, acts of God, strikes, or other labor disputes, riot or civil commotions, or by reason of any other matter or condition beyond the control of either party, and which cannot be overcome by reasonable diligence and without unusual expense ("Force Majeure"). In no event shall a lack of funds on the part of either party be deemed Force Majeure.

3.24 **Survival.** All representations and warranties made herein, indemnification obligations, obligations to reimburse SBBC, obligations to maintain and allow inspection and audit of records and property, obligations to maintain the confidentiality of records, reporting requirements, and obligations to return public funds shall survive the termination of this Agreement.

3.25 **Authority.** Each person signing this Agreement on behalf of either party individually warrants that he or she has full legal power to execute this Agreement on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this Agreement.

ATTACHMENT G

System Requirements

SYSTEM REQUIREMENTS

The system requirements listed below are general requirements needed for the GPS Tracking System and Student Tracking for SBBC, Student Transportation & Fleet Services Department. Manufacturer's system specifications will vary on the type of equipment, software and training provided and are not all encompassing in this requirement.

1. **System Requirements:** The System will need to be scalable in terms of being complementary to new technologies. The proposed system shall obtain GPS information for each school bus using GPS satellites orbiting the earth. The GPS positional accuracy should be rated five (5) meter board or less and provide ten (10) meter accuracy ninety (90%) percent of the time. Information to be transmitted about each vehicle includes latitude, longitude, and speed. The school bus units must also have the capability to transmit the occurrence of a minimum of six (6) different events to be determined by SBBC (i.e., door opening, reverse lights, stop arm, etc.) The System may provide an emergency or panic signal feature and include a student tracking system where each student entering or departing a bus will be recorded and can be displayed spatially in real-time by the Dispatcher using the tracking system as the communication protocol. The District is also looking into a fully integrated system that will incorporate not only GPS School Bus Tracking and Student Identification, but also Computerized Routing (CR). The ability to easily import and export data using the proposed GPS Tracking System is critical.
2. **Training:** Training must occur at SBBC Transportation Department and must be conducted with the most current SBBC Data installed on the proposed software system. Proposer shall provide a tutorial program with electronic and manual documentation to SBBC; the Proposer's telephone support center shall be available for assistance with tutorial programs. Due to reassignment of personnel, training will be required throughout the term of this contract.
3. **Functional Capabilities:** Proposer must be able to demonstrate the capability of their existing system to support the listed features in real-time at SBBC's request. The system must be capable of supporting the following bus tracking functions:
 - 3.1 **Real-time Instant Polling:** At any moment, the system operator or dispatcher operator must be able to select any one or more buses and display the locations of those selected buses on the map. Information associated with the buses, including but not limited to, bus number (ID), speed, driving direction, time and date must be also displayed.
 - 3.2 **Constant Polling:** The system operator or dispatcher must be able to specify any desirable interval of polling frequency and the tracking system should report real-time bus data every ten seconds as a standard with the flexibility to adjust up to 10 minutes. The polling interval should be changeable at any time from the system operator's or dispatcher's computers.
 - 3.3 **Variable Polling Schedule:** The system should allow for different polling schedules to be set for different vehicles. For instance, the buses serving special education routes may be tracked at a different schedule from those serving regular routes, and maintenance vehicles can be tracked at a different schedule than school buses. Operators must be able to make changes in the schedule from the server computer.
 - 3.4 **A visualization of bus location and related information on electronic map:** This will include, but not be limited to:
 - 3.4.1 Bus/Route Number;
 - 3.4.2 Route track and assigned stops;
 - 3.4.3 Assigned load;

SYSTEM REQUIREMENTS3. **Functional Capabilities (Continued):**3.4 **A visualization of bus location and related information on electronic map (Continued):**

- 3.4.4 Current Bus Location. Positions of all vehicles in the fleet; ability to select and view any one vehicle;
- 3.4.5 Substitute Bus Management (regular versus substitute bus assigned to routes)
- 3.4.6 Visual planned route hours and miles data imported from the routing software application against the actual hours and miles data GPS information collected from vehicles.
- 3.4.7 Turn-by-turn directions for each route and also supply stop time, mileage between each stop.
- 3.4.8 Display location information of the nearest vehicle to be a defined address.

4. **Data Collection** – Data collected should be downloaded via cellular Global System for Mobile Communications (GSM)/ 4G Long Term Evolution (LTE) communications.5. **Alerts** – GPS system should provide a platform for customizable and configurable alerts that should have escalating capabilities with alerts, including, but not limited to: activity alert, battery low voltage alert, GPS Zone alert, idle alert, and speed (max speed) alerts.6. **Emergency Alert:** The GPS tracking device must provide live (real-time) alerts. The system must include an emergency alert button which, when pressed will send an alert message to the dispatch center, along with time, date and exact location of bus/vehicle.

- 6.1 Distribution of real-time alerts (i.e., late bus arrival) via email, text message, voice or other. Customized alarms via pop-up windows, including the time the alarm was triggered, the type of alarm, the action taken following the alarm and the description of the event.
- 6.2 Non-voice "Panic Button" for drivers, (i.e., silent duress alarm).
- 6.3 Broadcast or targeted alerts to buses.

7. **GPS Device:** GPS device shall capture data in four dimensions – latitude, longitude, time and odometer. Device shall have a separate IP address for data security. Device should monitor low battery. Data collected from device should be downloaded via cellular GSM/ 4G Long Term Evolution (LTE) Communication. Device must include at least a five year warranty – all parts and labor.8. **Automated Call A-Head Notification:** The system should provide an optional feature to support the designated routes. The GPS tracking system should have the capability to automatically notify the students' homes in real-time at a preset time interval prior to the bus arrival. Parent notification service alerts to households notifying status of their child's bus. This function should be done in a fully automated manner where no action is required from the driver or the dispatcher during the operation. The ability to set the parameters of when to make the automated call, and what message to send is set by the dispatcher or system operator, and should be able to be changed in an instant by the dispatcher or system operator without going to the bus. System must be able to integrate with the District's automated Messaging Service (ParentLink).9. **Arrival Time Buffer Upon Notification (Exception Reporting):** The system should provide an optional feature of arrival time notification. An electronic message should be sent to the District's designated personnel when a bus/vehicle fails to arrive or depart a specific location (i.e., stop or school) beyond a preset buffer period specified by the dispatcher or system operator. For example, if a stop is being monitored due to a parental complaint, the system should be able to send a message to the dispatcher if the bus fails to arrive at the stop in question within +/- 5 minutes of the scheduled time for the stop. Proposer will describe their approach to this process and to provide the scope of the process.

SYSTEM REQUIREMENTS

10. **Report Generating:** The system should provide a specified user-friendly adhoc reporting function stored electronically within the server. This facilitates the creation of reports for management or governmental agencies. The system should also include report generation of standard activity reports (i.e., bus arrival times at schools vs. scheduled arrival times, bus on-time arrival percentage) periodically based upon a specified schedule.
 - 10.1 Historical data tracking relative to asset inspection & management, including:
 - 10.1.1 "Black Box" mechanical data, primarily for maintenance due notification and scheduling purposes;
 - 10.1.2 Odometer readings;
 - 10.1.3 Key asset pre and post trip inspection points/inspection completed notifications, (i.e., time ignition was turned on, the time the safety signals were deployed and tested, time the bus left the parking lot).
11. **Travel History Recording:** The system operator or dispatcher should have the option to save the vehicle tracking history in a file of driving records. Records in this file should contain all the polling points (instant or constant) and events (emergency, railroad crossing if available, door close/open if available, and call-ahead if available).
12. **Travel History Playback:** The system should provide a function to allow the operator to playback the history file of any bus on any date and for any recorded time frame. The bus' travel pattern should be displayed on the map, along with the speed, direction, time, and date. The system operator or dispatcher should be able to view the entire trip as a trail, or point by point with the capability of stopping at any moment and skip locations if desired. System must have the capability to store data history for a minimum of three (3) to six (6) months. The District shall have real-time access to recordings up to six (6) months old and within 24 hours, access to data up to five (5) years old.
13. **Routing Software:** The system must provide the following mapping functions:
 - 13.1 Ability to import any updated map in a designated format or from a third party that captures updates without compromising existing routes;
 - 13.2 Display any number of feature codes at any time;
 - 13.3 Allow for the operator to click on the map to generate the shortest route between any two locations on the map;
 - 13.4 Enter an address and identify its location;
 - 13.5 Play back on the map any bus trip point-by-point for any period of date/time;
 - 13.6 Display the trail on the map of any bus for any period;
 - 13.7 Show any bus trip with both driving history and students boarding on the same map.
14. **System Security:** The system security architecture should allow for the designation of a security administrator.
 - 14.1 There should be provisions for the system to handle security measures including user identifications (ID's) and passwords. Access to these user IDs and passwords must be restricted. All user IDs and passwords should be encrypted while stored and in transit to prevent unauthorized access.
 - 14.2 User should be prevented from seeing functions on menus that the user is not authorized to perform.
15. **Student Tracking System:** SBBC will integrate the GPS School Bus Tracking System with a Student Identification System to record students boarding and leaving buses. Proposer must be able to provide a developed student identification system which is seamlessly integrated into the GPS system. The system should meet the following requirements:
 - 15.1 System to include a GPS-GSM that can be integrated with a Radio Frequency Communication Device (RFID) web-based solution for student tracking;
 - 15.2 RFID Reader should also be equipped with a low-power sleep mode;
 - 15.3 System should provide a time and date stamp for students boarding and leaving the bus;

SYSTEM REQUIREMENTS**15.. Student Tracking System (Continued):**

- 15.4 Student tracking system should have an RFID card read range of 0-2";
- 15.5 Student tracking has the capability to include Biometric scanning. This is beneficial when a student forgets his/her ID badge.
- 15.6 Card reader should provide an audible beep to confirm card reading and be logged and transmitted to a secure database;
- 15.7 Student tracking system should include an option that shows the time and location of card swipes;
- 15.8 Information on student cards must be securely stored and accessible only via username and password;
- 15.9 Alerts for parents should be available via email or text message.
- 15.10 Update the student list for each bus;
- 15.11 Transmit the actual list of students on any specified bus to the dispatch server in real-time;
- 15.12 Keep passenger records accurately;
- 15.13 Student Identification/Tracking Software: The software installed on the server computer must be able to do the following:
 - 15.13.1 The software is either a part of the GPS bus tracking software or should be seamlessly integrated with the system;
 - 15.13.2 The software should display the list of students who board/exit the bus at any bus stop in real-time. As soon as the bus leaves the bus stop, the information is available to the user on the GPS tracking screen as to:
 - 15.13.2.1 Who stepped on the bus and was assigned to the stop;
 - 15.13.2.2 Who stepped on the bus but was not assigned to the bus stop, and
 - 15.13.2.3 Who was assigned to the bus stop but did not show up.
 - 15.13.3 Report the passenger list of any bus for any specified period;
 - 15.13.4 Report rider statistics;
 - 15.13.5 Report the trip of any bus;
- 15.14 The system should allow for the easy data entry associated with an issuance, loss, replacement, temporary suspension, etc. of ID cards.
- 15.15 In the process of issuance of a new student, there should be a minimum data entry required: the student data should already be directly read from the student database; the ID of the student should be scanned or entered electronically without typing.
- 15.16 All information about the student history related to credentials is available for easy query. All student data should be linked to the main student database of the routing system.

16. Integration with Edulog Routing and Scheduling System

- 16.1 GPS system should be capable of meeting the following specifications using integration with Edulog routing and a tracker comparative analysis module:
 - 16.1.1 The system should allow for the comparison of the actual driving data to the planned data available in the routing system.
 - 16.1.2 Real-time display of bus performance (early, late, on-time). The comparisons are based on the use of the data available in the routing management system. Exception situations (as defined by the user, for example, late status) should be automatically brought to the user's attention, both in text table form (listing of bus operational data) and graphic made (color coded icons immediately identifiable regarding the bus' on-time/early/late statuses).
 - 16.1.3 Ability to display actual versus planned route data in text format. Any bus stop could be clearly viewed as on-time, early or late, missed or unscheduled. According to the current status of the bus, all future bus stops should be provided an estimated time of arrival adjusted to the latest real-time GPS data received.

SYSTEM REQUIREMENTS16. **Integration with Edulog Routing and Scheduling System (Continued):**

- 16.1.4 GPS (mapping) must be able to be updated with road and speed limit changes as changed by Florida's Department of Transportation. Speed limits must be actual and not estimated or averaged per location.
- 16.1.5 Ability to display actual versus planned route data on the map. The user should have the ability to display both actual real-time and planned travel paths on the same screen, with user-defined selection of colors and symbols to clearly separate the two.
- 16.1.6 Integration with bus stop management functions. The system should allow the import of the GPS data into the routing system in order to enhance or correct data contained in the routing system.
- 16.1.7 The system should allow the user to easily evaluate the location of any bus stop as computed by the routing system in relation to the actual location reported by the GPS system. At the user's decision, the planned data could be automatically corrected.
- 16.1.8 The system should allow the user to easily compare time at any bus stop to the time computed by the routing system. The user can then decide on any editing possible to realign the planned times to the actual GPS times, and the system could perform these corrections with minimum user data entry.
