The School Board of Broward County, Florida (SBBC) is interested in receiving bids in response to the attached Invitation to Bid (ITB) for Emergency Debris Clean Up and Removal Services. Any information that amends any portion of this ITB, which is received by any method other than an Addendum issued to the ITB, is not binding on SBBC.

In order to assure that your bid is in full compliance with all requirements of the ITB, carefully read all portions of the ITB document, paying particular attention to the following areas:

M/WBE CERTIFICATION/PARTICIPATION - SEE EXHIBIT A

All price corrections shall be initialed by the person signing the bid even when using opaque correction fluid. SBBC reserves the right to not tabulate any illegible entries, pencil bids or price corrections not initialed and to reject any bid containing any of these errors.

Bids are due in Procurement and Warehousing Services on the date and time stated on Page 1 of the ITB. In order to have your bid considered, it must be received on or before the date and time due. Bids received after 2:00 p.m. ET on date due will not be considered.

SECTION 3, GENERAL CONDITIONS

- SEALED BID REQUIREMENTS: The "Bidder Acknowledgement Section" must be completed, signed and returned with the bid. The Bid Summary Sheet pages on which the Bidder actually submits a bid, and any pages, upon which information is required to be inserted, must be completed and submitted with the bid. The School Board of Broward County (SBBC) reserves the right to reject any bid that fails to comply with these submittal requirements.
 - a) <u>BIDDER'S RESPONSIBILITY</u>: It is the responsibility of the Bidder to be certain that all numbered pages of the bid and all attachments thereto are received and all Addendum released are received prior to submitting a bid without regard to how a copy of this ITB was obtained. All bids are subject to the conditions specified herein on the attached bid documents and on any Addenda issued thereto.
 - b) <u>BID SUBMITTED</u>: Completed bid must be submitted in a sealed envelope with bid number and name clearly typed or written on the front of the envelope. Bids must be time stamped in Procurement and Warehousing Services on or before 2:00 p.m. ET on date due for bid to be considered. Bids will be opened at 2:00 p.m. ET on date due. Bids submitted by telegraphic or facsimile transmission will not be accepted.
 - c) EXECUTION OF BID: Bid must contain an original manual signature of an authorized representative in the space provided above. All bids must be completed in ink or typewritten. If a price correction is necessary, draw a single line through the entered figure and enter the corrected figure or use an opaque correction fluid. All price corrections must be initialed by the person signing the bid even when using opaque correction fluid. SBBC reserves the right to reject any bid or bid item completed in pencil or any bid that contains illegible entries or price corrections not initialed.

 BIDDING PREFERENCE LAWS: ALL BIDDERS MUST COMPLETE AND SUBMIT THE LEGAL OPINION OF BIDDER'S PREFERENCE FORM IN ORDER TO BE CONSIDRED FOR AWARD. The State of Florida provides a Bidder's preference for Florida vendors for the purchase of personal property. The local preference is five (5) percent. Bidders outside the State of Florida must have an Attorney, licensed to practice law in the out-of-state jurisdiction, as required by Florida Statute 287.084(2), execute the "Opinion of Out-of-State Bidder's Attorney on Bidding Preferences" form and must submit this form with the submitted bid. Such opinion should permit SBBC's reliance on such attorney's opinion for purposes of complying with Florida Statute 287.084. Florida Bidders must also complete its portion of the form. Failure to submit and execute this form, with the bid, shall result in bid being considered "non-responsive" and bid rejected.
- PRICES QUOTED: Deduct trade discounts and quote firm net prices. Give both unit
 price and extended total. Prices must be stated in units to quantity specified in the
 bidding specification. In case of discrepancy in computing the amount of the bid, the
 Unit Price quoted will govern.

All prices quoted shall be F.O.B. destination and freight prepaid (Bidder pays and bears freight charges). Bidder owns goods in transit and files any claims unless otherwise stated in Special Conditions. Discounts for prompt payment: Award, if made, will be in accordance with terms and conditions stated herein. Each item must be bid separately and no attempt is to be made to tie any item or items in with any other item or items. Cash or quantity discounts offered will not be a consideration in determination of award of bid(s). If a Bidder offers a discount or offers terms less than Net 30, it is understood that a minimum of 30 days will be required for payment, and if a payment discount is offered, the discount time will be computed from the date of satisfactory delivery at place of acceptance and receipt of correct invoice at the office specified.

- a) <u>TAXES</u>: The School Board of Broward County, Florida does not pay Federal Excise and State taxes on direct purchase of tangible personal property. The applicable tax exemption number is shown on the Purchase Order. This exemption does <u>not</u> apply to purchases of tangible personal property made by contractors who use the tangible personal property in the performance of contracts for the improvement of School Board owned real property as defined in Chapter 192 of the Florida Statutes.
- b) MISTAKES: Bidders are expected to examine the specifications, delivery schedules, bid prices and extensions, and all instructions pertaining to supplies and services. Failure to do so will be at Bidder's risk.
- c) <u>CONDITION AND PACKAGING</u>: It is understood and agreed that any item offered or shipped as a result of this bid shall be new (current production model at the time of this bid) unless otherwise specified. All containers shall be suitable for storage or shipment and all prices shall include standard commercial packaging.
- d) <u>UNDERWRITERS' LABORATORIES</u>: Unless otherwise stipulated in the bid, all manufactured items and fabricated assemblies shall be UL listed where such has been established by UL for the item(s) offered and furnished. In lieu of the UL listing, Bidder may substitute a listing by an independent testing laboratory recognized by OSHA under the Nationally Recognized Testing Laboratories (NRTL) Recognition Program.

- e) <u>BIDDER'S CONDITIONS</u>: Bid conditions and specifications shall not be changed, altered or conditioned in any way. The Board specifically reserves the right to reject any conditional bid.
- 3. <u>SAMPLES:</u> Samples of items, when required, must be furnished free of expense within five working days of request unless otherwise stated and, if not destroyed, will, upon request, be returned at the Bidder's expense. Bidders will be responsible for the removal of all samples furnished within 30 days after bid opening. All samples will be disposed of after 30 days. Each individual sample must be labeled with Bidder's name, bid number and item number. Failure of Bidder to either deliver required samples or to clearly identify samples as indicated may be reason for rejection of the bid. Unless otherwise indicated, samples should be delivered to Procurement and Warehousing Services, The School Board of Broward County, Florida, 7720 West Oakland, Park Boulevard, Suite 323, Sunrise, Florida 33351-6704.
- 4. <u>DELIVERY:</u> All deliveries shall be F.O.B. destination point. Unless actual date of delivery is specified (or if specified delivery cannot be met), show number of days required to make delivery after receipt of Purchase Order in space provided. Delivery time may become a basis for making an award (see Special Conditions). Delivery shall be within the normal working hours of the user, Monday through Friday, excluding state holidays and days during which the school district administration is closed.
- 5. <u>INTERPRETATIONS:</u> Any questions concerning conditions and specifications must be submitted in writing and received by Procurement and Warehousing Services no later than ten working days, or as stated in the Special Conditions, prior to the original bid opening date. If necessary, an Addendum will be issued.
- 6. <u>AWARDS:</u> In the best interest of SBBC, the Board reserves the right to: 1) withdraw this bid at any time prior to the time and date specified for the bid opening; 2) to reject any or all bids received when there are sound documented business reasons that serve the best interest of SBBC; 3) to accept any item or group of items unless qualified by Bidder; and 4) to acquire additional quantities at prices quoted on this ITB unless additional quantities are not acceptable, in which case, the bid sheets must be noted "BID IS FOR SPECIFIED QUANTITY ONLY." All awards made as a result of this bid shall conform to applicable Florida Statutes and shall be governed by the laws of the State of Florida, and must have venue established in the 17th Judicial Circuit Court of Broward County, Florida or the United States Court of the Southern District of Florida.
- BID OPENING: Shall be public, on the date and at the time specified on the bid form.
 All bids received after that time shall not be considered.
- ADVERTISING: In submitting a bid, Bidder agrees not to use the results there from as a part of any commercial advertising without prior approval of the School Board.
- 9. <u>INSPECTION, ACCEPTANCE & TITLE:</u> Inspection and acceptance will be at destination unless otherwise provided. Title to/or risk of loss or damage to all items shall be the responsibility of the Awardee until acceptance by the buyer unless loss or damage resulting from negligence by the buyer. If the materials or services supplied to the Board are found to be defective or not conform to specifications, the Board reserves the right to cancel the order upon written notice to the seller and return product at Awardee's expense.
- 10. <u>PAYMENT:</u> Payment will be made by SBBC after the items awarded have been received, inspected, found to comply with award specifications and free of damage or defect and properly invoiced. All payments will be made by ACH (Automated Clearing House) for automatic deposits (credits).
- 11. CONFLICT OF INTEREST AND CONFLICTING EMPLOYMENT OR CONTRACTUAL RELATIONSHIP: Section 112.313 (3) and (7), Florida Statutes, sets forth restrictions on the ability of SBBC employees acting in a private capacity to rent, lease, or sell any realty, goods or services to SBBC. It also places restrictions on SBBC employees concerning outside employment or contractual relationships with any business entity which is doing business with SBBC. Each Bidder is to disclose any employees it has who are also SBBC employees by submitting Attachment 1, Disclosure of Potential Conflict of Interest and Conflicting Employment or Contractual Relationship, with its Bid. Any employees identified by the Bidder when completing Attachment 1 should obtain legal advice as to their obligations and restrictions under Section 112.313 (3) and (7), Florida Statutes.
- 12. <u>INSURANCE</u>: Bidder, by virtue of submitting a bid, shall be in full compliance with paragraph 20: LIABILITY INSURANCE, LICENSES AND PERMITS of the General Conditions. Insurance Requirements are shown in FORMS AND ATTACHMENTS Section of this ITB. Bidder shall take special notice that SBBC shall be named as an additional insured under the General Liability policy including Products Liability.

The insurance policies shall be issued by companies qualified to do business in the State of Florida. The insurance companies must be rated at least A-VI by AM Best or Aa3 by Moody's Investor Service. All policies must remain in effect during the performance of the contract.

- DISPUTES: In case of any doubt or difference of opinion as to the items to be furnished hereunder, the decision of the School Board shall be final and binding on both parties.
- 14. <u>LICENSES, CERTIFICATIONS AND REGISTRATIONS:</u> As of the Bid Opening Date, Bidder must have all Licenses, Certifications and Registrations required when performing the services as described herein, in order for Bid to be considered a responsive and responsible Bid. Licenses, Certifications and Registrations required for this Bid shall be as required by Chapter 489, Florida Statutes, as currently enacted or as amended from time to time; by the State Requirements for Educational Facilities (SREF), latest version; and by Broward County, Florida. Bidder must submit a copy of all its current Licenses, Certifications and Registrations required as described herein, either with its Bid or within five working days of notification.
 - An Awardee who has any License, Certification or Registration either suspended, revoked or expired after the date of the Bid Opening, shall provide notice to the Director of Supply Management & Logistics within five working days of such suspension, revocation or expiration. However, such suspension, revocation or expiration after the date of the Bid Opening shall not relieve the Awardee of its responsibilities under a contract awarded under this bid.
- 15. PATENTS & ROYALTIES: The Awardee, without exception, shall indemnify and save harmless The School Board of Broward County, Florida and its employees from liability of any nature or kind, including cost and expenses for any copyrighted, patented, or unpatented invention, process, or article manufactured or used in the performance of the contract, including its use by The School Board of Broward County, Florida. If the Awardee uses any design, device, or materials covered by letters, patent, or copyright, it is mutually understood and agreed without exception that the bid prices shall include all royalties or cost arising from the use of such design, device or materials in any way involved in the work.
- 16. <u>OSHA:</u> The Awardee warrants that the product supplied to The School Board of Broward County, Florida shall conform in all respects to the standards set forth in the Occupational Safety and Health Act of 1970, as amended, and the failure to comply with this condition will be considered as a breach of contract.
- 17. <u>SPECIAL CONDITIONS:</u> The Superintendent or Designee has the authority to issue Special Conditions and Specifications as required for individual bids. Any and all Special Conditions that may vary from these General Conditions shall have precedence.
- 18. ANTI-DISCRIMINATION: The School Board of Broward County, Florida, prohibits any policy or procedure which results in discrimination on the basis of age, color, disability, gender identity, gender expression, national origin, marital status, race, religion, sex or sexual orientation. Individuals who wish to file a discrimination and/or harassment complaint may call the Executive Director, Benefits & EEO Compliance at 754-321-2150 or Teletype Machine TTY 754-321-2158.
- 19. <u>QUALITY:</u> All materials used for the manufacture or construction of any supplies, materials or equipment covered by this bid shall be new unless otherwise specified. The items bid must be new, the latest model, of the best quality and highest grade workmanship.
- 20. <u>LIABILITY INSURANCE, LICENSES AND PERMITS:</u> Where Awardees are required to enter or go onto School Board property to deliver materials or perform work or services as a result of a bid award, the Awardee agrees to The Hold Harmless Agreement stated herein and will assume the full duty obligation and expense of obtaining all necessary licenses, permits and insurance. The Awardee shall be liable for any damages or loss to the School Board occasioned by negligence of the Awardee (or agent) or any person the Awardee has designated in the completion of the contract as a result of their bid.
- 21. <u>BID BONDS, PERFORMANCE BONDS AND CERTIFICATES OF INSURANCE:</u> Bid bonds, when required, shall be submitted with the bid in the amount specified in Special Conditions. Bid bonds will be returned to non-Awardees. After acceptance of bid, the School Board will notify the Awardee to submit a performance bond and certificate of insurance in the amount specified in Special Conditions. Upon receipt of the performance bond, the bid bond will be returned to the Awardee.
- 22. <u>CANCELLATION:</u> In the event any of the provisions of this bid are violated by the contractor, the Superintendent shall give written notice to the contractor stating the deficiencies and unless deficiencies are corrected within five days, recommendation will be made to the School Board for immediate cancellation.

- 23. <u>BILLING INSTRUCTIONS:</u> Invoices, unless otherwise indicated, must show Purchase Order numbers and shall be submitted in duplicate to The School Board of Broward County, Florida, Accounting and Financial Reporting Department, Attn: Accounts Payable, 600 S.E. 3rd Avenue, 7th Floor, Fort Lauderdale, Florida 33301. Payment will be made a minimum of 30 days after delivery, authorized inspection and acceptance. When vendors are directed to send invoices to a school, the school will make direct payments to the vendor.
- NOTE TO VENDORS DELIVERING TO MATERIALS LOGISTICS CENTRAL (WAREHOUSE): Receiving hours are Monday through Friday (excluding state holidays and days during which the school district administration is closed) 7:00 a.m. to 2:00 p.m. ET.
- 25. <u>SUBSTITUTIONS:</u> The School Board of Broward County, Florida WILL NOT accept substitute shipments of any kind. Awardees are expected to furnish the brand quoted in their bid once awarded by the School Board. Any substitute shipments will be returned at the Awardee's expense.
- 26. <u>FACILITIES:</u> SBBC reserves the right to inspect the Awardee's facilities at any time with prior notice. SBBC may use the information obtained from this in determining whether a Bidder is a responsible Bidder.
- 27. BID ABSTRACTS: Bid tabulations are available at www.demandstar.com.
- 28. ASBESTOS AND FORMALDEHYDE STATEMENT: All building materials, pressed boards, and furniture supplied to SBBC shall be 100% asbestos free. It is desirous that all building materials, pressed boards and furniture supplied to the School Board also be 100% formaldehyde free. Bidder, by virtue of bidding, certifies by signing bid that, if awarded this bid, only building materials, pressed boards, and/or furniture that is 100% asbestos free will be supplied.
- 29. <u>ASSIGNMENT:</u> Neither any award of this bid nor any interest in any award of this bid may be assigned, transferred or encumbered by any party without the prior written consent from the Director, Procurement and Warehousing Services. There shall be no partial assignments of this "Bid/RFP" including, without limitation, the partial assignment of any right to receive payments from SBBC.
- 30. EXTENSION: In addition to any extension options contained herein, SBBC is granted the right to extend any award resulting from this bid for the period of time necessary for SBBC to release, award and implement a replacement bid for the goods, products and/or services provided through this bid. Such extension shall be upon the same prices, terms and conditions as existing at the time of SBBC's exercise of this extension right. The period of any extension under this provision shall not be for a period in excess of six months from (a) the termination date of a contract entered into as a result of this bid or (b) the termination date under any applicable period of extension under a contract entered into as a result of this bid.
- 31. OMISSION FROM THE SPECIFICATIONS: The apparent silence of this specification and any Addendum regarding any details or the omission from the specification of a detailed description concerning any point shall be regarded as meaning that only the best available units shall be provided and the best commercial practices are to prevail, and that only materials and workmanship of first quality are to be used. All interpretations of this specification shall be made upon the basis of this agreement.
- 32. <u>SUBMITTAL OF INVOICES:</u> All Bidders are hereby notified that any invoice submitted as a result of the award of this bid must be in the same format as any Purchase Order released as a result of the award of this bid. <u>Each line of the invoice must reference a corresponding single line shown on the Purchase Order.</u> A single invoice line must not correspond to or commingle the cost shown on multiple Purchase Order lines. An invoice submitted that does not follow the same format and line numbering as shown on the Purchase Order will be deemed to be not correct, and may be returned to the vendor by the Accounts Payable Department for correction. Address for submitting invoices is included on Purchase Order.
- 33. PURCHASE AGREEMENT: This bid and the corresponding Purchase Orders will constitute the complete agreement. Such rights will be exercised with notice to the Awardee to determine compliance with and performance of the terms, conditions and specifications on all matters, rights and duties, and obligations established by this agreement. Documents/records in any form shall be open to the District or State's representative and may include but are not limited to all correspondence, ordering, payment, inspection, and receiving records, contracts or sub-contracts that directly or indirectly pertain to the transactions between the District and the Awardee(s).
- 53. <u>ORIGINAL DOCUMENT FORMAT:</u> Only the terms and conditions of this solicitation as they were released by SBBC, or amended via Addendum, are valid. Any modification to any term or condition by a vendor is not binding unless it is expressly agreed to, in writing, by SBBC.

The confidential information cannot be disclosed unless valid consent is obtained from the students or their legal guardians. Both parties agree to protect these records in compliance with FERPA, HIPAA, and the District's policy. To the extent permitted by law, nothing contained herein shall be construed as precluding either party from releasing such information to the other so that each can perform its respective responsibilities.

Vendor agrees that it may create, receive from or on behalf of the District, or have access to, records or record systems that are subject to FERPA and/or HIPAA (collectively, the "Confidential Records"). Vendor represents, warrants, and agrees that it will: (1) hold the Confidential Records in strict confidence and will not use or disclose the Confidential Records except as (a) permitted or required by this Agreement, (b) required by law, or (c) otherwise authorized by the District in writing; (2) safeguard the Confidential Records according to commercially reasonable administrative, physical and technical standards as required by law; and (3) continually monitor its operations and take any and all action necessary to assure that the Confidential Records are safeguarded in accordance with the terms of this Agreement. At the request of the District, Vendor agrees to provide the District with a written summary of the procedures Vendor uses to safeguard the Confidential Records. A breach of these confidentiality requirements shall constitute grounds for the District to terminate any Agreement with Vendor.

SECTION 4, SPECIAL CONDITIONS

INTRODUCTION AND SCOPE:

- The School Board of Broward County, Florida (hereinafter referred to as "SBBC") desires bids on EMERGENCY DEBRIS CLEAN UP AND REMOVAL SERVICES as specified herein. The purpose of this bid is to establish a pool of vendors who can assist SBBC with debris management and removal after a storm, natural disaster, or similar event. The scope of this contract is hazardous debris removal and disposal due to a natural disaster or emergency situation in accordance with all local, state and federal guidelines. All work will be performed on public property and/or public rights-of-way. The work to be performed consists of hazardous tree removal, hazardous limb removal, hazardous stump removal and the gathering and collection of all vegetative material. Also included is removal of construction and demolition debris from the school grounds and/or right-of-way areas, as well as loading, hauling and disposal to a Florida Department of Environmental Protection (FDEP) and/or local authority, FEMA permitted dumpsite, as directed by SBBC. One hard-copy bid must be sent with the bid and one identical electronic version of the bid, in PDF Format on CD/flash drive, should be submitted in time for bid opening.
- 2. <u>TERM:</u> The award of this bid shall establish a contract for the period beginning from date of award and continuing through November 30, 2018. Bids will not be considered for a shorter period of time. Items will be ordered on an as-needed basis. If only one bid is received, the term of the contract may be reduced to one year.
- 3. <u>AWARD:</u> Bid shall be awarded in its **ENTIRETY** to **ALL** bidders who are responsive and responsible meeting all specifications, terms and conditions. Therefore, it is necessary to bid on every item in the group, in order to have the bid considered for award. Those responsive and responsible bidders who comply with all specifications, terms and conditions of this bid will then be ranked based on pricing offered. The lowest bidder will become the primary awardee. The next lowest bidder will become the first alternate and so on. When services are required, the primary awardee will be called first, then the first alternate, etc.

After award of this bid, any Awardee who violates any specification, term or condition of this bid can be found in default of its contract, have its contract canceled, be subject to the payment of liquidated damages, and be removed from the bid list and not be eligible to do business with SBBC for two years, as described in General Conditions 22 and 55.

Any verbal or written information, which is obtained other than by information in this ITB document or by Addenda, shall not be binding on SBBC.
- 5. <u>CONTRACT RENEWAL:</u> The purpose of this bid is to establish a contract, at firm unit prices, for the purchase of estimated requirements for the items listed. The term of the bid shall be for approximately three (3) year(s), and may, by mutual agreement between SBBC and the Awardee, be renewed for two additional one-year periods and, if needed, 180 days beyond the expiration date of the final renewal period. Procurement and Warehousing Services, will, if considering renewing, request a letter of intent to renew from each Awardee, prior to the end of the current contract period. The Awardee will be notified when the recommendation has been acted upon by the School Board. All prices shall be firm through the period stated in Special Condition 11 Price Adjustments for the term of the contract. The Bidder(s) agrees to this condition by signing its bid.

- 10. <u>ISA CERTIFIED ARBORIST:</u> An International Society of Arboriculture (ISA) Certified Arborist will be needed to supervise the removal of hazardous limbs, trees and any other situations SBBC deems hazardous, as described in Section 6, Bid Specification 6. It is not a requirement of this bid to have an arborist on staff currently; however, the Awardee(s) must be able to provide an ISA-Certified Arborist as necessary to provide for the supervision described above. Indicate whether an arborist is currently on staff in Section 5, Bid Summary, Additional Information.
- PRICE ADJUSTMENTS: Prices offered shall remain firm through the first two years of the contract. - 1. <u>PERFORMANCE</u>: All hazardous tree trimming, removal and debris hauling shall be completed within 45 days of the issuance of a Notice to Proceed to the Awardee(s). If necessary, or as conditions may warrant, the Awardee(s) may submit a written request for an extension. Unless otherwise directed, the Awardee(s) will be required to complete all hazardous trimming, tree removal and associated debris hauling at one site prior to moving to a new site. SBBC representative(s) will monitor Awardee(s)' performance and determine when a site is complete. Stumps remaining on the site must be removed within three (3) days of completion of the tree removal and debris hauling.
- 2. <u>WORKING HOURS</u>: Unless otherwise notified, working hours shall be 7:00 a.m. to 6:00 p.m., seven (7) days a week.
- 3. <u>EQUIPMENT</u>: Awardee(s) will be responsible for providing all equipment necessary to complete the work assigned. All equipment must meet DOT safety standards for operation. Trucks or equipment which is designated for use at SBBC locations shall not be used for any other purpose during the working hours of this contract.

4. <u>AWARDEE(S) REQUIREMENTS</u>:

- A. Awardee(s) shall provide an Operations Manager to serve as the principal liaison between SBBC representative(s) and the Awardee(s)' staff. The assigned Operations Manager must be knowledgeable of the Awardee(s)' operations at all times and have the authority to act in all ways necessary to perform the required tasks. The Operations Manager will participate in daily and/or weekly meetings at the request of SBBC representative(s).
- B. Awardee(s) shall be responsible for control of pedestrian and vehicular traffic in assigned areas at all times. No work shall be done when students, parents, staff members or others are in the immediate area of work. The Awardee(s) shall work closely with the location's administration to ensure the safety of all students, parents and staff.
- C. Awardee(s) shall supervise and direct the work, using professional skilled labor and equipment in good condition and appropriate for all assigned and approved tasks. Safety of the Awardee's personnel and equipment is the responsibility of the Awardee.
- D. All work at any particular site must be completed with a minimum number of passes for hazardous tree, limb and stump removal.
- 5. <u>INSPECTION</u>: SBBC representative(s) shall inspect each site once the Awardee(s) indicates that work is complete at each site. Any work which has been overlooked or is unfinished shall be completed within 24 hours.

6. SPECIFIC JOB REQUIREMENTS:

- A. HAZARDOUS LIMB REMOVAL (HANGERS) The determination of the existence of a hazardous situation is the responsibility of SBBC-assigned representative(s). Awardee(s) shall provide a licensed, certified arborist to supervise the trimming of hanging or partially broken limbs. (See Special Condition 10) Awardee(s) is to remove all broken and hanging limbs still attached to the tree. Broken and hanging limbs are to be cut at the closest main branch junction. All broken and hanging limbs in the tree must be removed from the tree at the same time. Multiple passes to remove limbs will not be allowed.
- B. **RESTANDING**, **LEANING OR FELLED TREES** Utilizing customary industry standards, straighten or re-stand trees and ensure the tree is adequately secured. Once the tree has been reestablished, the removal of material used to secure a tree will be the responsibility of SBBC. The following methods may be used:
 - 1. Wood Stakes: Straight, sound, rough-sawn lumber not less than 2" x 4". Steel pins or rebar are NOT acceptable.
 - 2. Black Webbing Tape: As supplied by Terra International, Inc., Miami, Florida; Florida Landscape Supplies, Miami, Florida, or approved equal. Wire or cable is NOT be acceptable.
 - 3. Deadmen: Straight, sound, rough-sawn lumber not less than 2" x 4".
- C. HAZARDOUS TREE REMOVAL (LEANERS) The determination of the existence of a hazardous situation is the responsibility of SBBC-assigned representative(s). Awardee(s) shall provide a licensed, certified arborist to supervise the removal of partially uprooted or split trees and leaning trees. (See Special Condition 10) Awardee(s) will remove all trees that are uprooted, completely down or excessively destroyed. Tree removal does not include the removal of the stump.
 - 1. Leaning trees (greater than 30 degrees) that have 50 percent or less of the root ball exposed shall be flush cut at ground level.
 - 2. Excessively destroyed trees shall be flush cut at ground level. Trees that have less than 50 percent of the root ball exposed shall be cut flush at the ground level.
 - 3. Excessively destroyed trees are defined as trees with more than 50% of the tree crown destroyed or damaged, or a tree with a split trunk or broken branches that expose the heartwood.

D. HAZARDOUS TREE STUMP REMOVAL – The determination of the existence of a hazardous situation is the responsibility of the SBBC assigned representative(s). All stumps will be removed. SBBC representative(s) will determine the method of removal.

Stumps that are 24 inches or greater in diameter, as measured 24 inches above-ground level and that have 50 percent or more of the root-ball exposed, will be extracted. Stump extraction, whether by mechanical means or by hand, shall completely remove the stump and all associated above ground roots. The depression resulting from the stump extraction shall be filled with sand or topsoil. The resulting depression may be, in appropriate circumstances, graded level by mechanical means or by hand without the addition of new fill.

Stumps that are less than 24 inches in diameter will be either ground or extracted at the discretion of SBBC-assigned representative(s). Mechanical grinding of stumps must remove all stump material to a minimum depth of four inches below grade. All above-ground roots associated with the stump must be removed by mechanical grinding or cutting. The depth of mulch remaining after grinding a stump shall be no more than four inches above grade. Any mulch that would result in a mound greater than four inches above grade must be removed by the Awardee(s). The cost of removal of the mulch shall be inclusive of the stump grinding. Extraction of stumps less than 24 inches in diameter will be completed in the same manner as described above for stumps greater than 24 inches in diameter.

- E. **DEBRIS REMOVAL**: Storm debris shall be hauled to approved disposal sites only. Awardee(s) will be directed by SBBC to use a particular disposal site(s). Debris that may be eligible for local, state or federal reimbursement must be taken to an FDEP and/or local authority permitted dumpsite as directed by SBBC.
 - 1. Awardee(s) must completely remove all storm-generated vegetative debris. Vegetative debris consists of whole trees, tree stumps, tree branches, tree trunks, and other leafy material. Depending on the size of the debris, the collection of vegetative debris may require the use of flat bed trucks, dump trucks and grapple loaders. Awardee(s) is responsible to cut any debris into a size that can be managed by its hauler. Vegetative debris shall be removed from the entire campus or facility. Vegetative debris may or may not be consolidated by others prior to pick up.
 - 2. Awardee(s) must provide complete removal of all storm-generated construction and demolition (C & D) debris. Construction and demolition debris, for the purpose of this bid, is being defined as damaged and scattered components of buildings and structures, to include, but not limited to: lumber and wood, gypsum wallboard, glass, metal, roofing material, tile, carpeting and floor coverings, window coverings, pipe, concrete, asphalt, equipment, furnishings and fixtures. Construction and demolition debris shall be removed from the entire campus or facility. Construction and demolition debris may or may not be consolidated by others prior to pick up.

Awardee(s) shall take care not to mix vegetative and C & D debris. The mixing of debris types does not facilitate effective recycling and waste stream reduction efforts. However, conditions at the site may create situations in which mixed debris types exist and sorting is not feasible. Hauling of mixed debris loads will be allowed for these situations. SBBC representative(s) will determine when this will be permitted.

7. EQUIPMENT/DEBRIS REMOVAL REQUIREMENTS:

- A. Truck Certification Prior to any debris hauling, each truck or trailer to be utilized for hauling debris must be certified by SBBC representative(s). Each truck will be inspected and measured. The maximum capacity will be determined and recorded. Once approved, trucks designated for debris removal shall be equipped with two signs; one attached to each side. The signs shall indicate, in large, legible type, the Awardee(s)' or owner(s)' name, vehicle number and maximum capacity. Trucks or trailers that are altered during the execution of the contract will be re-measured and reapproved.
- B. **Hand Loading** Hand loading of trucks and trailers is prohibited. Awardee(s) must utilize mechanical equipment to load and reasonably compact debris into trucks and trailers.
- C. Tipping Fees Awardee(s) shall not include tipping fees in the unit price for hauling and disposal of debris. All tipping fees will be invoiced directly to SBBC. SBBC shall be responsible to pay only those tipping fees billed directly to SBBC for debris removal from SBBC property.
- D. **Load Tickets** Load tickets will be issued by SBBC-assigned representative(s) prior to departure from the loading site. The load ticket is five part and multi-colored. The ticket will be distributed as follows. The goldenrod copy will be retained by the site representative(s). The white copy will be retained by the tower representative(s) at the dumpsite. The green copy will be retained by SBBC. The yellow copy will be retained by the Awardee(s)' contractor/driver.
- E. **Measurement** Measurement of tree debris will be by the cubic yard. Trucks with less than full capacities will be adjusted down by visual inspection by a dump site representative(s) employed or contracted by SBBC.

In the cases below, the following person must give Form W-9 to the partnership for purposes of establishing its U.S. status and avoiding withholding on its allocable share of net income from the partnership conducting a trade or business in the United States:

- In the case of a disregarded entity with a U.S. owner, the U.S. owner of the disregarded entity and not the entity,
- In the case of a grantor trust with a U.S. grantor or other U.S. owner, generally, the U.S. grantor or other U.S. owner of the grantor trust and not the trust, and
- In the case of a U.S. trust (other than a grantor trust), the U.S. trust (other than a grantor trust) and not the beneficiaries of the trust.

Foreign person. If you are a foreign person or the U.S. branch of a foreign bank that has elected to be treated as a U.S. person, do not use Form W-9. Instead, use the appropriate Form W-8 or Form 8233 (see Publication 515, Withholding of Tax on Nonresident Aliens and Foreign Entitles).

Nonresident alien who becomes a resident alien. Generally, only a nonresident alien individual may use the terms of a tax treatly to reduce or eliminate U.S. tax on certain types of income. However, most tax treatles contain a provision known as a "saving clause." Exceptions specified in the saving clause may permit an examption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

If you are a U.S. resident alien who is relying on an exception contained in the saving clause of a tax treaty to claim an examption from U.S. tax on certain types of income, you must attach a statement to Form W-9 that specifies the following the items:

- The treaty country. Generally, this must be the same treaty under which you claimed exemption from tax as a nonresident alien.
- 2. The treaty article addressing the income.
- The article number (or location) in the tax treaty that contains the saving clause and its exceptions.
- 4. The type and amount of income that qualifies for the exemption from tax.
- Sufficient facts to justify the exemption from tax under the terms of the treaty article.

Example. Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident allon for tax purposes if his or her stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dafed April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first protocol) and is relying on this exception to claim an exemption from tax on his or her scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS a percentage of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

Payments you receive will be subject to backup withholding if:

- 1. You do not furnish your TIN to the requester,
- You do not certify your TIN when required (see the Part II instructions on page 3 for details).
 - 3. The IRS tells the requester that you furnished an incorrect TIN,
- The IRS tells you that you are subject to backup withholding because you did not report all your interest and dividends on your tax return (for reportable interest and dividends only), or
- You do not certify to the requester that you are not subject to backup withholding under 4 above (for reportable interest and dividend accounts opened after 1983 only).

Certain payees and payments are exempt from backup withholding. See Exempt payee code on page 3 and the separate instructions for the Requester of Form W-9 for more information.

What is FATCA reporting? The Foreign Account Tax Compilance Act (FATCA) requires a participating foreign financial institution to report all United States account holders that are specified United States persons. Cartain payees are exampt from FATCA reporting. See Exemption from FATCA reporting code on page 3 and the instructions for the Requester of Form W-9 for more information.

Updating Your Information

You must provide updated information to any person to whom you claimed to be an exempt payee if you are no longer an exempt payee and anticipate receiving reportable payments in the future from this person. For example, you may need to provide updated information if you are a C corporation that elects to be an S corporation, or if you no longer are tax exempt. In addition, you must furnish a new Form W-9 if the name or TIN changes for the account, for example, if the grantor of a grantor trust dies.

Penalties

Failure to furnish TIN. If you fall to furnish your correct TIN to a requester, you are subject to a penalty of \$50 for each such failure unless your failure is due to reasonable cause and not to willful neglect.

Civil penalty for false information with respect to withholding. If you make a false statement with no reasonable basis that results in no backup withholding, you are subject to a \$500 penalty.

Criminal penalty for falsitying information. Willfully falsitying certifications or affirmations may subject you to criminal penalties including thes and/or imprisonment.

Misuse of TINs. If the requester discloses or uses TINs in violation of federal law, the requester may be subject to civil and criminal penalties.

Specific Instructions

Name

If you are an individual, you must generally enter the name shown on your income tax return. Partnership, C Corporation, or S Corporation. Enter the entity's name on the "Name" line and any business, trade, or "doing business as (DBA) name" on the "Business name/disregarded entity name" line.

Disregarded entity. For U.S. federal tax purposes, an entity that is disregarded as an entity separate from its owner is treated as a "disregarded entity." See Regulation section 301.7701-2(c)(2)(ii). Enter the owner's name on the "Name" line. The name of the entity entered on the "Name" line should never be a disregarded entity. The name on the "Name" line must be the name shown on the income tax return on which the income should be reported. For example, if a foreign LLC that is treated as a disregarded entity for U.S. federal tax purposes has a single owner that is a U.S. person, the U.S. owner's name is required to be provided on the "Name" line. If the direct owner of the entity is also a disregarded entity, enter the first owner that is not disregarded for federal tax purposes. Enter the disregarded entity's name on the "Business name/disregarded entity name" line. If the owner of the disregarded entity is a foreign person, the owner must complete an appropriate Form W-8 instead of a Form W-9. This is the case even if the foreign person has a U.S. Till.

Note. Check the appropriate box for the U.S. federal tax classification of the person whose name is entered on the "Name" line (Individual/sole proprietor, Partnership, C Corporation, S Corporation, Trust/estate).

Limited Liability Company (LLC). If the person identified on the "Name" line is an LLC, check the "Limited liability company" box only and enter the appropriate code for the U.S. federal tax classification in the space provided. If you are an LLC that is treated as a partnership for U.S. federal tax purposes, enter "P" for partnership. If you are an LLC that has filed a Form 8832 or a Form 2553 to be taxed as a corporation, enter "C" for C corporation or "S" for S corporation, as appropriate. If you are an LLC that is disregarded as an entity separate from its owner under Regulation section 301.7701-3 (except for employment and excise tax), do not check the LLC box unless the owner of the LLC (required to be identified on the "Name" line) is another LLC that is not disregarded for U.S. federal tax purposes. If the LLC is disregarded as an entity separate from its owner, enter the appropriate tax classification of the owner identified on the "Name" line.

Other entitles. Enter your business name as shown on required U.S. federal tax documents on the "Name" line. This name should match the name shown on the charter or other legal document creating the entity. You may enter any business, trade, or DBA name on the "Business name/disregarded entity name" line.

Exemptions

Exempt payee code. Generally, individuals (including sole proprietors) are not exempt from backup withholding. Corporations are exempt from backup withholding for certain payments, such as interest and dividends. Part I. Taxpayer Identification Number (TIN)

The 60-day rule does not apply to other types of payments. You will be subject to backup withholding on all such payments until you provide your TIN to the requester.

Note. Entering "Applied For" means that you have already applied for a TIN or that you intend to apply for one soon.
