September 20, 2018
Minutes**

- **Welcome**
 - Lori Sparks welcomed parents and staff, began the meeting at 6:11 PM.
- **SAC Composition/SAC By-Laws**
 - Ms. Sparks explained the purpose and procedures of SAC, the specific positions and roles within the SAC Composition, reviewed the school demographics and how the SAC composition needs to mirror the same %'s and reviewed the SAC By-Laws. Ms. Boyd explained how the School Accountability Fund is funded and what types of academic items have been purchased in the past.
- **School Improvement Plan**
 - Ms. Sparks and Ms. Boyd spoke about the School Improvement Plan (SIP), its purpose and how this committee has input on the academics of the plan and the school as a whole. The various plans within the SIP – guidance, attendance, FACE, PBIS... were also discussed. It was explained that the SIP, in its entirety, will be shared at length at the October meeting.

- **Title I**
 - Ms. Sparks explained Ms. Keyunta Tyler, 2nd grade teacher, is the Title I liaison and Ms. Boyd shared what being a Title I school means and what is necessary to properly document being in the Title I program.
- **SAC Dates**
 - Dates and times for future meetings were shared and possibly alternating times throughout the year was also discussed.
