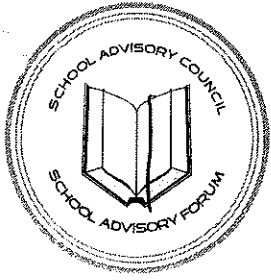

Call to Order:

North Area/ DAC Report

The perimeter fence will be installed soon. A campus monitor will be hired to man the gate along with other security duties.

Start with Hello program from Sandy Hook has begun at Riverglades. Students and staff are reaching out to students who may need a friend.
