Principal's Report

Delivered by Dr. Sweeting-Miller in Mr. Neer's absence.

Testing: FSA and EOC retakes have been administered. After spring break 9th and 10th grade students will be taking the writing portion of the FSA. Five Super Testing days will take place May 2nd, 3rd, 6th, 7th, and 8th. Further information about these days will be forthcoming.

Report from North Area Advisory

Michelle Martinez reviewed information covered in the last North Area Advisory meeting.

Three ID replacements will be given to students before a \$5 charge will be incurred.

A summary of the type of medical staff employed by the school district and funding sources was given. Currently 222 health professionals are employed by the school district.

A list was given of municipalities that provide funding for School Resource Officers so taxpayers can address concerns with cities directly.

Mr. Runcie was present to address questions regarding safety and other concerns.

Every Student Succeeds Act (ESSA) State Plan

- Federal Percent of Points Index – new index analyzes individual subgroup proficiency. Index of 40 or less is not acceptable. 41 and above is good but a school may still need to address not performing subgroups. Monarch has an index level of 53 and the Students with Disabilities is the group that will need to be addressed in our future School Improvement Plan. Various assessment level results were reviewed along with instructions on how to access school reports.
